The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, in violation of Section 565.050, RSMo, committed the class A felony of assault in the first degree, punishable upon conviction under Section 558.011, RSMo, in that on or about June 24, 2014, in the County of Jackson, State of Missouri, the defendant shot at _____ and such conduct was a substantial step toward the commission of the crime of attempting to cause serious physical injury to _____ and was done for the purpose of committing such assault, and in the course thereof inflicted serious physical injury on / _____.

Count II. Armed criminal action (3101099.0)


The Grand Jurors of the County of Jackson, State of Missouri, charge that the defendant, in violation of Section 571.015, RSMo, committed the felony of armed criminal action, punishable upon conviction under Section 571.015.1, RSMo, in that on or about June 24, 2014, in the county of Jackson, State of Missouri, the defendant committed the felony of assault in the first degree charged in Count I, all allegations of which are incorporated herein by reference, and the defendant committed the foregoing felony of assault in the first degree by, with and through, the knowing use, assistance and aid of a deadly weapon.

Wherefore this Indictment supersedes any complaint previously filed in the Associate Circuit Court.


