To This Honorable Court  
The State of Kansas  
Counsels:

I stand before this Court as an educated person with a full and complete understanding of the various paragraphs of the Plea Agreement including the charges, penalties, and waiver of legal rights which would be afforded me had this matter continued to trial. I further understand this Honorable Court has the right and obligation to accept, reject, modify, or amend this Plea Agreement as it relates to either matters of Law or in the interest of Justice. Additionally, I have received full explanation from my counsel regarding the consequences of accepting this Agreement.

Your Honor, it is my free will and voice to enter a plea of guilty to the offenses charged in this Plea Agreement without receipt of promise or coercion from any party associated with or connected to this matter. Although I freely enter the plea of guilty to the matters set forth in this Agreement, it is done so because my education and life experiences have produced an understanding that the Rule of Law and Justice, at times, are in conflict. Regardless of the infamous words “and justice for all”, those words can and do appear as merely a dream in the daily struggles for those trying to receive it.


The standards held to or required of the lay-person to avoid unintentional [key word] pitfalls of the “letter of the law” are equal to those standards placed upon a learned and admitted practitioner of the law. Even then, there is reasonable question as to either the intent or interpretation of the law, thereby guaranteeing that our adversarial system of law will continue, and the Dream of Justice will remain as such.

To avoid any possibility of confusion, I restate the entry of my guilty plea to the charges as described in the Plea Agreement. I have an understanding today that the "letter of law" was violated; and I take full responsibility and, therefore, acceptance of the penalties related to my actions. I certainly have a more enhanced understanding of the judicial process and even a greater understanding that the violation of the "letter of law" is not dependent upon one's intent.

Please understand, my unwitting violations of the Statutes was not due to failing to exercise common sense, or out of some desire to challenge the law. It turns out I simply made a mistake. I remain steadfast in knowing there was no intent, desire, or conspiracy to circumvent the "One Man-One Vote" integrity of our system of free elections and political representation.

Again, thank you to this Honorable Court for your considerations and the opportunity to address you in this matter.
