

**EASTERN NEW MEXICO UNIVERSITY**  
**Board of Regents Special Telephonic Meeting**  
**March 20, 2017 - 8:00 a.m.**

**CALL TO ORDER**

Regent President Dan Patterson called the meeting to order at 8:00 a.m. and declared a quorum. Regent Jane Christensen was present; Regents Dan Patterson, Terry Othick, and Kekoa VonSchriltz attended by telephone. [There are only four members of the Board due to a vacancy.]

**APPROVE THE AGENDA**

*Regent Othick moved to approve the agenda as presented. Regent Christensen seconded the motion. Vote: 4-0-0. Motion approved.*

**EXECUTIVE SESSION**

**Dr. Jeff Elwell**, dean of the College of Arts and Sciences, and professor of Theatre and Speech at the University of Tennessee Chattanooga

**Dr. John Fritch**, dean and interim dean of the College of Humanities, Arts and Sciences, professor and graduate faculty member at the University of Northern Iowa

**Dr. Neal R. Weaver**, vice president for University Advancement and Innovation at Nicholls State University

**Dr. Sandra Woodley**, higher education senior strategist/senior fellow at Kentucky State University

*Regent Christensen seconded the motion. Vote: 4-0-0. Motion approved.*

Regent Othick thanked those who served on the subcommittee and Dr. Patrice Caldwell as the liaison for this committee. Dr. Patterson also thanked Regents Othick and Christensen who served on the subcommittee and Dr. Caldwell.
