TYPE A BRIEF DESCRIPTION OF PROGRAM (Format, participants, content, etc.): In-depth interview with Gary Cox and Bill Marshall of Portales, NM, about the New Mexico Christian Children's Home and the programs and services provided for children in need around the country and for single parents. The residential program at the children's home offers children from troubled family environments a chance to live in cottages with house parents in rural eastern New Mexico, attend public schools in the region and take part in a variety of community programs such as raising animals through 4-H and sports activities. The program's goal is to help children have hope and realize their potential in life. The single parent program provides safe, secure apartments and support for single parents where they can raise their children while pursuing an education at nearby colleges and universities and/or job training so they can be empowered on a path to greater independence.

Hospice Foundation Benefit event at the Flying J Ranch to raise money and awareness for people living in rural areas of Lincoln County in southeastern New Mexico, about services and resources available for end-of-life care, such as hospice care, home health care and other medical needs. Provided educational information about the Ruidoso Hospice Foundation's year-round services, such as financial assistance for utilities and phone service for patients in their homes and travel costs for relatives to visit the patient receiving hospice care. Discussion about the challenges and unique needs for hospice/home health care patients living in rural areas of the KENW-FM listening region in New Mexico.

TYPE A BRIEF DESCRIPTION OF PROGRAM (Format, participants, content, etc.): In-depth interview with Oscar Solis, operations director for the New Mexico Law Enforcement Torch Run for New Mexico Special Olympics, a regional community service initiative that empowers the local law enforcement community to give back to area residents and raise awareness of the athletic abilities of people with certain developmental and physical disabilities through Special Olympics. Provided educational information about the N.M. Law Enforcement Torch Run that involves law enforcement officers and their families throughout the region and the state in running and cycling with the Special Olympics torch, the "Flame of Hope," over 1,600 total miles throughout New Mexico as "guardians of the flame" to keep the joy of sport alive for people with disabilities and prepare for lighting the official Special Olympics cauldron during the opening ceremonies at the New Mexico Special Olympics Summer Games.

The event features CMN children and families singing the National Anthem before the baseball game, a 4-year-old CMN child throwing out the first pitch of the game and other awareness and fund-raising activities during the game. Provided educational information about the free services and resources offered to children who have experienced the death of a family member to meet their needs, assist them with grief counseling and peer support groups to reduce feelings of isolation and help the family adjust and cope to changes brought about by the death and grief.

TYPE A BRIEF DESCRIPTION OF PROGRAM (Format, participants, content, etc.): In-depth interview with Yvette Lucero, a recruiter with the New Mexico Children, Youth and Families Department for Region 4 in eastern and southeastern New Mexico, about the increasing need for single and married people to train to become licensed foster and adoptive parents in the region. Provided educational information about the 4-6 month process to meet the requirements to become licensed foster and adoptive parents, such as the required 32-hours of free CYFD training, home study, background check, and information about creating and maintaining a good environment for children and keeping their best interests at the forefront. Discussion about the severe shortage of licensed foster and adoptive parents in rural New Mexico, where the need for safe, emergency foster care for children who are being rescued from abusive and violent situations is increasingly high. Information about the continuing resources and services provided to foster and adoptive parents through CYFD, such as medical care, funding for clothing and basic needs, counseling and support for children, parents, guardians and families.
