		Your typed or clearly printed and signed <u>NOTARIZED</u> request, or a statement made under penalty of perjury pursuant to 28 U.S.C. § 1746, providing your full name or any subsequent name changes, date and place of birth, current mailing address, current daytime telephone, current e-mail address if available and a clear copy of your valid government issued photo identification i.e. driver's license, non-driver's license, passport.
		A NOTARIZED consent from the file subject authorizing release to you, along with a copy of the subject's photo identification.
		Submit the FULL name, date and place of birth of the file subject and the dates that he/she may have applied for a United States passport.
-		If the subject is under 100 years old, we require either a <u>NOTARIZED</u> consent from the subject authorizing the release of information from his/her passport record to you, OR convincing evidence of the death in the form of a newspaper obituary or death certificate.
-		Please submit evidence of legal, court ordered guardianship of the subject.
_		Certified copies of passport records require submission of a \$50.00* fee per subject. For each additional copy the fee is \$50.00 per subject.
_		Apostilled copies of passport records require submission of an \$8.00* fee per subject. For each additional copy, the fee is \$8.00 per subject.
_		J.S. passport records do not include evidence of travel such as entrance/exit stamps, visas residence permits, etc., since this information is entered into the U.S. passport book after it is issued. If you are seeking travel information, we suggest that you contact U.S. Customs and Border Patrol at 1-877-227-5511.
