KNAU partnered with NPR station KJZZ in Phoenix for a new science desk with all four of the state's public radio stations participating. As a result, KNAU was able to bring on one new science reporter imbedded in Flagstaff. She has been outstanding and continues to improve exponentially. KNAU was honored with an Edward R. Murrow award for best sports reporting, continuing our unbroken streak of winning at least one Murrow every year for 20+ years. KNAU brought on former national Morning Edition producer Cindy Carpien to work with new reporters on collecting sound, writing around it and mixing sound for NPR quality pieces. KNAU broadened our newscast division leading to at least half a dozen reporters on the air with spot news, many times reporting for the national network. KNAU's news team has increased our social medial presence tenfold. The KNAU news team participated in many community activities including speaking engagements, guest lectures at public schools and at Northern Arizona University, and walking the catwalk as models for Goodwill Industries annual fashion show.

News team appearances have led to story leads, a stronger social medial following, and increased contributions to the station.

KNAU is in a unique location geographically, bordering the country's largest Indian tribe – the Navajo Nation – as well as one of the most remote and private tribes, the Hopi. Our news coverage regularly includes tribal issues, including sacred land and artifacts, environmental, cultural and political topics. KNAU's tribal news coverage is often featured in NPR's national newscast. In the last year, KNAU reporters have covered issues relating to immigration, disabilities, health, education and many other topics that affect minority or diverse populations of listeners.

CPB funding is critical to KNAU operations. CPB funding, along with institutional support from Northern Arizona University, provides the bulk of KNAU's operating revenue. The station is able to leverage those funds with membership campaigns and program underwriting to more than triple the investments from CPB and NAU. CPB funding allows KNAU to operate on a level consistent with stations in major markets. We hire professional journalists, announcers, producers and development staff. Without CPB funding, KNAU would not be able to operate as a primary source of news and information for tens of thousands of listeners and the station would be unable to purchase quality public radio programs that connect our audience to the world.
