KTTZ-FM and our associated digital signals are the only public radio outlets in our region of Texas. To meet the diverse needs of our community we have offered long-form new and information programming from NPR, APM, PRI, the BBC, and independent producers as program choices. Simultaneously, we have offered classical music on a full-time basis. We have offered locally produced programs that highlight the educational and research activities of our licensee, Texas Tech University and the Texas Tech University Health Sciences Center. All this programming is meant to bring the highest possible program content to the listeners of KTTZ-FM. Platforms include terrestrial radio, HD Radio, podcasting, and internet streaming.

We initiated a new locally produced program titled The Front Row to highlight and promote art events in our region. This interview program with art organizations in our area helps drive traffic to their events and expand the cultural life of our community. We partnered with the Lubbock Symphony Orchestra to record their concerts and broadcast them on the radio. We continue to partner with Movies 16 to promote the Metropolitan Opera in HD. In San Angelo, we partner with the local newspaper to provide local news coverage to that region of the country.

All the events we did in collaboration with other arts organizations were well attended and were a benefit to both the radio on the organization. All organizations had promotional materials and staff available at all events. This success has allowed us to secure funding for The Front Row, a program devoted to arts coverage in our community. The increase in revenue from paid PSAs also indicates that other arts organizations are anxious to partner with us for promotion and traffic.

We operate the public radio entity in San Angelo, TX, KNCH-FM. As this station's demographic has a high Hispanic quotient, we provide bilingual programming such as Latino USA and Radio Bilingue to this area. We are also addressing the needs of the migrant community there by including targeted messages informing them of educational opportunities offered by our licensee, Texas Tech University and Angelo State University.

CPB funding made it possible to reach out to the community with high-quality long-form programming available no where else on the radio. CPB funding made it possible to acquire national programs such as Morning Edition and All Things Considered, Wait, Wait, Don't Tell Me, A Prairie Home Companion, and others and provide them to the community. Utilizing our digital channels and internet streams, we also used CPB funding to offer continuous classical music and the BBC World Service to the same listeners. Without CPB funding, much of this programming would not be possible and we would be far less relevant to the community. As we have partnered with so many art organizations this past year, the ancillary ramifications of our CPB funding have become obvious: our art and cultural community is thriving in large part due to the success of KTTZ-FM and it's associations in the community.
