Presentation from PJ Watters

- Our Spokane Public Radio Fund for the Future Endowment is in place with the Inland Northwest Community Foundation. We have \$13,022 in it to date.
- PJ Watters presentation! How the fund is handled and how to help it grow.
- The Planned giving tri-fold in the works and it was suggested to add Verne's picture to it.
- We have begun an effort to turn Capital Campaign automatic payments into Endowment Gifts that are ongoing. Treasurer Emeritus Dave Walker is helping in this effort.

Old Business:

• **Budget:**

- The annual audit has begun. We hope to have the auditors present it at the January meeting.
- Our formal request of the Washington State legislature to "untie" the restrictions on the remainder of our capital construction grant from the state of Washington, while we have nothing official, seems unlikely to succeed at this point. We have it rolled forward, however, for the next year and a half, until June 30, 2019.
- Generally speaking, we continue to improve and strengthen, though we are not as financially robust as we'd like to be. Membership has shown particular improvements, and we need to staff up as resources allow.
- Fund Drive is from October 19-26th. Our theme is simple: you depend on us—we depend on you. Our goal is \$225,000.

- **Programming:**
 - We are still pursuing some documentation about intellectual property in the handbook.
 - Concept programs in development:
 - *Turning Points*
 - *On Creativity*
 - *Celtic Christmas* special is in discussion with Carlos Alden.
 - We are looking at featuring Dan Maher for his 35 years of Inland Folk at the Fall Folk Festival, November 11th at Spokane Falls Community College.
 - *On Point* with Tom Ashbrook was a hit. Beau Soleil was a fine event.
 - Looking at the coverage we receive from N3. Is it worth the increase we agreed to pay? We are receiving less coverage for our region.
- **CAB:** The CAB had no further comments on our programming. They were pleased to hear of the progress on major giving and the endowment. They have also been apprised of cost challenges and increases, and the steps taken to alleviate our costs.
- **STAFF:**
 - Janean Jorgensen is leaving us. Her last day is October 13th. She has taken a job with Gonzaga School of Engineering as a Web Specialist. The search for a new part-time marketing coordinator is underway. We thank her for her great service during times of great transition. We are pressing the search, and hope to hire soon.
 - Doug Nadvornick has moved from part-time to full time last month. SPR is in a time of transition, but reports on improvements to our news content continue to be very positive.

Current major projects:

- Phones- We have implemented two new phone numbers. One for testimonials, the other for listener comments. We have only “advertised” the testimonials line in anticipation of the upcoming pledge drive.
- Satellite Stations & Translators-The main antenna has been restored at Twisp for KTWP. Bob Sanderson and I were able to install the antenna on a new tower in late September.

KOMQ in Omak is up but being fed via the Shaw satellite system, as is KTWP in Twisp. Shaw no longer has any paying customers using this service. It’s probably only a matter of time before they bump us off. When that happens, I will need to relay the KPBX signal from Goat Mountain (Brewster). That will require that KPBW be converted to an HD broadcast station. That will cost upwards of \$30k.

The work described in the Construction Permit for properly locating KPBG in Oroville has been completed and a license application has been filed with the FCC.

- Engineering Conference- I would be happy to present to the SPR board, the presentation that I gave to the Association of Public Radio Engineers Conference this past April, if desired. It described the construction and move to the Firehouse.
- General Plans- I visited the Kellogg site today and got it back on the air. I would still like to reach the Sandpoint Baldy and Brewster sites before winter closes them off.
