Greg Matis is Senior Counsel with Intermountain Healthcare. His primary assignment is SelectHealth, where he also serves on the executive team and has operational responsibility for contracts, compliance, appeals and healthcare reform. Before joining Intermountain, Greg also served as in-house counsel to several other organizations, including First Health, the country's largest third-party administrator. He frequently speaks and writes on healthcare-related topics.

Jason Stevenson is the Education and Communications Director for the Utah Health Policy Project since November 2012, managing the organization's public outreach, social media, and communications strategies, and engaging key advocates on healthcare reform.
