15 INITIAL INCIDENT DESCRIPTION / NARRATIVE:

{On the date and time listed, Ofc Radford was told of the following. The listed victims were sitting a table during lunch, on Friday the 27th of September, when one of the suspects walked up to them and asked if they had been claimed for froshing yet.

After school, they were met by the suspects and they were escorted them to a van and they got in. They were driven to a private residence, where they were asked trivia questions about Garfield HS. They were told that if they did not get the answers correct, they would either be paddled, had to drink a shot of hard liquor or get hot sauce squirted in their mouthes. They answered the questions correctly, then another game was about to begin.

This was interrupted, when one of the suspects stated, "it is about to begin." At that point, they were told to get into the van to the Arboretum where there was a group of about 100 kids present. There were kegs of what appeared to be beer there as well.

One of the victims reported that they had been paddled and forced to drink shots of hard liquor until one of the was very intoxicated. A couple of

them were paddled several times. The suspect named ██████ stopped the paddling, because he stated that they had been paddled enough.

Ofc Radford, Principal Howard and officers from 2nd watch responded to a report of under aged drinkers at that location. None of the victims or suspects were located at that time.

Once they arrived, the students ran in various directions, refusing to stop when ordered to do so. There was evidence of drinking and froshing left at the scene. At that time, the victims had not come forward.
