

### Introduction

County services <u>are not</u> <u>possible</u> without the sacrifices taxpayers make to ensure the well-being of our community.

### **2017 Ballot Initiative**

#### 1/2-percent General Revenue Sales Tax

Voters will be presented with a half-percent County sales tax on the **Nov. 7 ballot**.

#### What it means at the register

For every **\$100 spent** on goods within Greene County, taxpayers will pay an **extra 50 cents** (with the exception of domestic utilities).

#### **Tax Oversight**

The County Commission will create a tax oversight board to review revenues and expenditures, as well as make recommendations on lowering the General Revenue Property Tax levy based on performance to plan.

# The County provides services that benefit all citizens, including those who reside in municipalities.

#### Tax collection allows us to:

- Maintain the criminal justice system, which includes law enforcement, courts, prosecution and medical examiner services
- Manage elections for all political subdivisions within Greene County
- Assess valuation of personal property such as vehicles and homes

What is the Need?

## The City-County Planning Task Force identified three main threats to sustainability of the County's core services:

#### Overburdened Criminal Justice System

The jail's growing population combined with exceeding expenses to operate it creates an unsustainable financial burden to the County.

## Imminent Environmental Compliance Mandates

The region's recent loss of stormwater funding combined with increasing environmental regulatory standards and costs will soon make it difficult to comply with federal and state regulations.

## County Financial Stability To Maintain Services

Due to budget constraints, general County support services have shrunk, and we face deteriorating facilities and needed equipment replacement.



### REDUCE LONG-TERM COSTS OF JAIL OPERATIONS

In addition to on-campus jail operations, we spend more than \$2 million per year to house inmates in other county jail facilities. That cost is expected to increase by more than \$740,000 per year. The ballot initiative addresses this issue the following ways:

### SUPPORT PUBLIC SAFETY & CRIMINAL JUSTICE

Adequate facilities and programs are needed to keep the public safe and the criminal justice system operating with optimal efficiently. A new tax would offer the flexibility to accomplish a variety of solutions.

## MAINTAIN QUALITY SERVICES

The last time voters approved a County General Revenue Sales Tax was in 1984. The service demand upon County offices has long **outgrown that revenue stream**, resulting in both episodic and permanent reduction in services. Increased general revenue sales tax revenue would allow us to increase and maintain services our citizens say they want.

## The County's current tax rate is 1.25%, one of the lowest amongst neighboring counties.

If approved, a new tax would increase Greene County's rate to 1.75%, bringing us to the level of nearby Christian and Stone counties.

## Greene County's existing General Revenue Sales Tax is split with the Road & Bridge Fund.

We maintain 1,284 miles of road, 217 bridges and 655 culverts. We also provide \$1.7 million to pave roads in the City of Springfield and more than \$200,000 in other municipalities.

## 70% of the remaining General Revenue funds law enforcement, courts and corrections.

Approx. 62.5% of the ¼-cent Law Enforcement Sales <u>Tax I is distributed to area municipalities.</u> The County's share of this tax is <u>not sufficient to fund</u> the criminal justice system as promised to voters.

## The County expects more than \$3 million in budget cuts in 2018.

These cuts are partly due to:

- anticipated general election costs
- increased jail expenses
- increased pension costs
- and the complete use of the remaining park tax funds



The County has won numerous transparency awards from Harvard University, Missouri Association of Counties and National Association of Counties.



Moody upgraded the County's bond rating, citing our open-book management as an important part of their decision.

Independent auditors have issued the County clean opinions for several consecutive years



Stakeholders have access to monthly revenue and expenditure reports on our website
