Shall the Board of Education of the Laclede County R-1 School District, Laclede County, Missouri, borrow money in the amount of Two Million Seven Hundred Thousand Dollars (\$2,700,000) for the purpose of constructing, renovating, repairing, expanding, improving, furnishing and equipping school buildings and related facilities for school purposes in the District, including, but not limited to (1) constructing classrooms, including hardening three rooms for use as a storm shelter, a principal's office, a secretary's office and a mechanical room at Ezard Elementary, and (2) improving safety, security and technology, and issue bonds for the payment thereof, resulting in an estimated increase to the debt service property tax levy of 49 cents (\$0.49) per one hundred dollars of assessed valuation?

VILLAGE OF PHILLIPSBURG PROPOSITION 1

Shall the Village of Phillipsburg impose a Village sales tax increase from 1/2 percent to 1 percent on the receipts from the sale of retail of all tangible personal property or taxable services at retail, subject to the sales tax imposed by the State of Missouri?

The city-wide sales tax rate will be for a period of four (4) years beginning October 1, 2016 to October 1, 2020 for the purpose of providing for general operations, including personnel, building repair, and upkeep of city buildings, maintenance of equipment and city property, and any other necessary capital improvements.

The approval of this proposition will authorize the imposition of a 1 percent retail sales tax, to be collected in addition to other sales taxes provided for by law on all retail sales made in the Village of Phillipsburg, Missouri that are subject to taxation under the provisions of Sections 144.010 to 144.525, inclusive, of the Revised Statutes of Missouri, as amended.
