## **POSITION OVERVIEW**

The Programming/Operations Director for Four Corners Public Radio is responsible for oversight and management of all programming and operations activities for the radio station.

- Manage and maintain NexGen automation system
- Support KSUT fundraising efforts through specialty programming, production and onair pitching
- Supervise and manage KSUT's announcers and on-air staff
- Manage and schedule week day blend shifts
- Manage and schedule voice track shifts for overnight and weekend programming
- Perform regular sound and air checks with KSUT announcers and on-air staff
- Manage Independent Contractors and locally produced specialty music shows
- Manage and schedule holiday and NPR specialty programming
- In collaboration with KSUT Music Director, manage music libraries
- Manage KSUT website and social media programming posts
- Provide tech support for live in-studio concerts and events
- Ensure EAS protocols are followed
- Maintain traffic "logs" in Allegiance
- Maintain broadcast equipment
- Develop and update Operations Manual as necessary
- Other duties as assigned

# **QUALIFICATIONS**

- Minimum 3 years broadcast experience
- Experience with radio automation systems, preferably NexGen
- Strong voice, clear diction, confident on-air skills
- Knowledge of FCC regulations
- Basic digital audio editing skills

## **REASONING ABILITY**

Work performed is in an office and studio environment with extensive time sitting at a desk or in front of a broadcast console. Some off site work is required to help with special events representing the station. The noise level in the work environment is moderate.
