This is in response to your letter dated April 29, 2014 as it relates to Mr. Johnson. I first saw Mr. Johnson in June 2008 when the patient was referred for abdominal pain and discomfort. He underwent upper endoscopy, which revealed evidence of peptic disease. He also underwent a colonoscopy, which revealed multiple sessile polyps, which were removed, all of which were benign.

The patient was scheduled for a followup colonoscopy approximately three years later. However, I did not repeat the colonoscopy until May, 2013. The patient presented at that time with abdominal pain. He underwent colonoscopy by me and to my surprise was found to have a colon mass in his left colon. The patient underwent biopsies, which confirmed that he had adenocarcinoma. He was subsequently referred to a surgeon, Dr. Peal. Further evaluation revealed that he had aggressive cancer of his left colon with evidence of metastatic disease.

Dear Mr. Johnson:

The Arkansas State Medical Board addressed the complaint you registered against the above-referenced physician at their June 5-6, 2014 Board meeting.

By law, the Board only has the authority to take action against a physician's license if the medical care rendered by the physician rises to the level of gross negligence or ignorant malpractice as defined: "It is carelessness or recklessness to a degree that shows utter indifference to the consequences that may result."

The Board is not allowed to make the determination whether the physician's actions were appropriate or inappropriate, only whether it meets the definition as outlined in the Arkansas Medical Practices Act. This means the action could be inappropriate and still not be a violation of the Medical Practices Act, which the Board must follow to bring charges. The judicial court system has the authority to determine right and wrong; however, this Board can only address actions that are a violation of the Law as passed by the legislature.

After careful review, the Board determined that your circumstances, regardless of its severity, did not meet the definition of a probable violation of the Arkansas Medical Practices Act (Law); therefore the Board could not bring charges proving that gross negligence occurred.

Again, the Board does not have the authority to determine who is right and who is wrong, only whether or not the Law, as outlined in the Medical Practices Act, was maintained. The Board does not have the authority to determine whether a complaint is considered malpractice; only whether or not it is considered "gross and negligent" as defined above. Malpractice issues must be determined by the court system.

Your complaint will be retained in the physician's file and unless new information is received, this case is considered closed.

As follow-up to my phone call on 1/12/12, On behalf of my brother, Robert Taylor, I am making a complaint of negligence against the above said doctor.


Dr. Williams has done numerous diagnostic tests on my brother as a referral from his primary physician, Dr. David Webber of Helena, AR., because of some potential/life threatening test results he had obtained on 7/27/11.

To this day, Dr. William has not discussed all of Robert's test results, especially scan results with me or him and/or has failed to refer him for further work/up or treatment, as he told me during a phone conversation on 10/7/11, that he were referring Robert to a surgeon as we speak (related to removal of hemorrhoids/mass) which Robert never received an appointment with a surgeon or any other health care professional. I had called doctor's office on 10/6/11 for test results done on 10/5/11 after he failed to call me with the results. I was very concern about my brother's health since I knew scan results of 9/16/11. He returned my call on 10/7/11, but never discussed scan results of 10/5/11. He made above statement about surgeon. I also, asked him during that same conversation, what about the "Cysts on his kidneys/liver and other findings" he just blew it off by saying "that has been there all the time". As a nurse, I could not believe his like of concern about the generalized health of his patient and/or scan results of 9/16/11 which I

had obtained an email copies apparently without him knowing, from the scan center after he failed to call me with the results. Before and after phone conversation with Dr. Williams, I had called his office numerous times, leaving messages on his nurse's voicemail and/or speaking with her requesting all of Robert's test results so I could get health care for him. She stated she had to get doctor's consent. I made her aware that Robert had signed papers at scan center and Dr. William's office that his medical history and/or test results could be released to me. His office emailed "half" of scan report done on 9/16/11, which I am enclosing case ID 2428907B and the other half they did not send- case ID 2428907A. I immediately called Ms. Mary Bailey, who is the sister, and apologized to her for the failed communication between me and my office. Upon reviewing the records, I see that the brother did sign a consent giving his sister, Mary Bailey, permission to discuss all of his medical records with Arkansas Diagnostic Center. Also in review of the records, I see that Ms. Bailey apparently has talked to an individual in my nursing department. She indicated she wanted a copy of all the records. My nursing staff failed to communicate this request to the medical records department. Upon realizing that the failure was on our part, I immediately had an authorization form sent to Ms. Bailey. We are awaiting the signed authorization to disclose/release the patient's medical record to Ms. Mary Bailey.

I have also arranged for Mr. Taylor to receive further medical care. Ms. Bailey and I have agreed to continue his evaluation as inpatient at Baptist Medical Center in Little Rock. Mr. Taylor will be admitted on February 14, 2012, to complete his workup.

I initially saw Mr. Robert Taylor on the request of Dr. David Webber, who had a CT scan which showed that he had a questionable rectal mass. The CT also showed that he had a questionable metastatic disease to his liver. After my evaluation, it was obvious he did not have a rectal mass and did not have metastatic disease to his liver. 

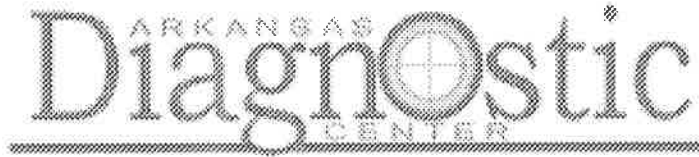

My name is Wilma Tatum, a patient who came to your office for a routine colonoscopy as a preventive measure on August 17, 2007. My decision was greatly influenced by your radio and TV advertisements. I am a middle aged female, who is very conscientious about my health and living a healthy lifestyle.

On August 17, 2007, the date of my colonoscopy, I came into your office with a sense of confidence based on your medical experience and expertise. However, to my dismay I had a traumatic experience as a result of the procedure and your negligence. I woke up in the recovery room, in your Diagnostic Center, in great pain and asked for assistance that I did not receive. While there, I explained to the nurse that I was in great pain and that I had thrown up, however I was told that was routine and that I needed to get up and walk around. Valuable time could have been saved had you or your medical staff taken the time to direct me to the nearest emergency room, Baptist Health which was right down the street from you. I experienced complications immediately after the procedure and the pain continued throughout the night.

On August 18, I called the medical exchange and to my surprise you responded after several hours. When you finally returned my call, I was in the emergency room in extreme pain. You asked me to have the medical staff contact you regarding my medical status. The emergency room physicians contacted you and I was informed that you refused to provide treatment. In fact, during my 4 day stay in UAMS, your lack of concern for your patient was evident as you never even visited me or called to check my medical status.

I am very disappointed and dismayed by your lack of concern and compassion for your patient. Consequently, I had to endure a week of hospitalization and intense pain management, in order for the physicians to assess whether or not I needed surgery. According to my medical records, I was diagnosed with a traumatic perforated colon.

As a result of your lack of follow-up, I have experienced not only the physical trauma but have also experienced some mental anguish as a result of a supposedly routine colonoscopy. If you had come to the hospital or even called me on the telephone, I think I would have more respect for you as a doctor.

Your reputation as an expert in your field preceded you and influenced my decision to come to the Arkansas Diagnostic Center. What a rude awakening!

As a result of the horrific experience, I have lost 3 weeks of pay off from work, incurred medical bills, and unnecessary pain and suffering due your negligence for what should have been a routine colonoscopy.

It is not my desire at this time to contact an attorney or the medical board, although I do believe your practice is desperately in need of a review, oversight and routine monitoring. However, I do feel that you should consider my out-of-pocket expenses which are as follows:

This is in response to your letter dated March 16th. I have enclosed a copy of Mrs. Tatum's medical record.

I was very disappointed to hear that Mrs. Tatum was not pleased with the care that she has received by me. I also was disappointed that she actually experienced some complications post her colonoscopy with polypectomy. The records will reflect that she presented for a screening colonoscopy. She was found to have a very large polyp, which was removed, in her mid-ascending colon. She also had a smaller polyp removed. Post-procedure it appears that Ms. Tatum experienced what we describe as a postpolypectomy syndrome. She had severe pain. She experienced a low-grade temperature. Upon her calling me, I referred her to go the hospital. I was surprised that she actually went to UAMS; however, it was appropriate to go to any hospital. I did talk with the ER physician and informed the physician that she had undergone a colonoscopy with polypectomy. I told him that I would be concerned about a possible perforation of her colon post-polypectomy. I had him to see, evaluate, and to give me a followup of his care. The patient was subsequently admitted to the hospital, and upon admission she underwent IV antibiotic therapy. She gradually improved with antibiotic therapy and bowel rest. Abdominal film was done and showed no evidence of any free air and no evidence of perforation of her colon. She was subsequently discharged.


She reported that she wrote me a letter to tell me about her experience. I did meet with Tatum and told her that I felt that she had a postpolypectomy syndrome and that she had been treated appropriately at UAMS. As I explained to her, I did not feel that she had what they described as a traumatic colonic perforation after colonoscopy. I told her that if indeed that had happened, she would have had to have surgical intervention. She was adamant about being reimbursed by me for this particular complication. I explained to Ms. Tatum that as a physician we always hate to see complications associated with any procedure; however, it was not appropriate for a physician to reimburse a patient for the care that she received post that complication. She obviously became very disturbed and concerned and, as a result of that, wrote a complaint to the State Medical Board.

The Arkansas State Medical Board addressed the complaint you registered against the above-referenced physician at their June 4-5, 2009 meeting.

Please help us in this matter, as we are afraid for our lives

On May 17, 2000, I presented to Dr. Alonzo Dean Williams at the Gastroenterology and Surgical center in Little Rock, AR for a routine colonoscopy, a procedure that is the speciality of Dr. Williams and Gastroenterology Surgical Center, I was injured in that procedure and subsequently abandoned by Dr. Williams when he left the clinic after the procedure without visiting with me post-op. Later that same day while in severe pain I was carried by ambulance to the emergency room at the Baptist Medical Center in Little Rock, Ar, for emergency treatment where I was examined by Dr. Bobby Perry, staff surgeon at Baptist Medical Center and told that they had to do emergency exploritory surgery to repair what was determined to be a hole in my colon that was caused by Dr. Williams during the colonoscopy. I was hospitalized for five (5) days following the Emergency surgery, and even until this present time I am still feeling the effects of the damage done to my intestine by Dr. Alonzo D. Williams.

On May 16, 2002 through my attorney, Mr. Ron Goodman, of Little Rock, AR, a Medical malpractice suit was filed on my behalf, in the Pulaski county circuit court, case # CV-2002-5326 against Dr. Alonzo D. Williams and Gastroenterology and Surgical Center of Little Rock, AR, Within three weeks of the filling of the suit in the proper court (civil division, personal injury) the case was moved into the "Domestic relations division) of the court, since shortly after the filing of the complaint against Dr. Williams I and my family have experienced several incidents that we beleive are directed at us because of the filing of the suit, we have received no less than five (5) phone calls from persons or a person unknown, that shows up on our telephone caller ID as anonamous or unavailable, each time we have been told that if we know what is good for us we should better drop the complaint against Dr. Williams.

Since the filling of the civil suit against Dr. Alonzo D. Williams, many situations have occured, that I am convinced places myself and my family in great danger of being murdered or some other type of retaliation, and are directly related to Dr. Williams, and/or, someone who has knowledge about the civil suit etc. and are either directly connected to Dr. Williams, or has decided on their own to discourage us from continueing with this suit, either way I fear for the safety of me and my family. Many occurances began to unfold starting in 2001 when I asked my primary care physican, Dr. Philipe Masquil (who had been my primary care physican for ten (10) yrs.) for a copy of my medical records, a request which he flatly refused, (stating as his only reason for refusing to give me copies of my medical records was that," they were his


records, and not my records, and that I wasn't entitled to have copies of them"), "it was with regret that I had to file a complaint with the Arkansas medical board in order to get copies of my medical records", shortly thereafter Dr. Masquil left the area and is no longer practicing in the McGehee, Arkansas area. Since the time of Dr. Masquil leaving the area and is no longer at the McGehee Desha County Hospital (where he was on staff), I have been flatly refused proper emergency treatment on at least one occasion by a Dr. Robinson on 11/4/2002 in the emergency room at the McGehee Desha County Hospital.

I was also seen at, and admitted into, the Chicot Memorial Hospital in June 2000 by Dr. Iuliana Shapira who was at that time on staff at the Lake Village Clinic and Chicot Memorial, I was hospitalized for infections associated with the operation that I had previously underwent on May 17, 2000, at which time I was also treated by Dr. J.P. Burge who is staff surgeon at Chicot Memorial, Dr. Burge also noted in his report that "(the midline incision is not the type of incision that he would associate with a Right Hemicolectomy)". I was again a patient of Dr. Shapira in March 2002, and when I returned to see Dr. Shapira again in June 2002, she too had left the area, and is no longer practicing at the Lake Village Clinic and the Chicot Memorial hospital.

On August 19, 2002 I went for a ct scan at the Chicot Memorial Hospital in Lake Village, AR, ordered by Dr. Burge at the Lake Village Clinic, during the scan the radiologist Dr. T. Tuangsith M.D./et, and one other person entered into the area where I was laying in the ct machine and stopped the motion of the machine "although the red light was still on" and raised the hospital gown that I was wearing and asked, "Where was you operated on" and after about one to two minutes they lowered the gown and left the room and the scan continued, later that same day approximately five (5) or six (6) hours later I began to itch very badly in two locations on either side of my stomach/chest area, approximately two days later I noticed what seemed to me to be small burn areas at the places where I had the itch earlier. I sincerely beleive that I have received internal organ damage from the ct scan, and that the damage was intentional and was /is meant to kill me and is directly connected to/with Dr. Alonzo D. Williams.

Please Help us. Me and my family are really afraid for our safety, and also we are afraid to go to the doctors and local medical facilities for medical treatments that we need.

Thank you for your investigation.



I just reviewed the complaint that Mr. Scott wrote to the United States Attorney. It is true that Mr. Scott was a patient of mine May 17, 2000. He underwent a colonoscopy at that time. The patient was found to have a colon polyp and underwent colonoscopy with polypectomy. Post procedure the patient developed some abdominal discomfort and was advised to go to the Baptist ER for further assessment. In talking with the ER physician I explained to him that he had underwent a colonoscopy with polypectomy and was concerned about possible perforation. Abdominal x-ray revealed that he did indeed have evidence of free air in his abdomen. I then consulted Dr. Bobby Perry who I asked to assess. Dr. Perry felt that he needed surgical intervention. He was hospitalized by Dr. Perry and followed by one of my associates during his hospital stay. His hospital stay was uneventful and he progressed well.

It was to my surprise that he filed a lawsuit against me because of this incident. I have had absolutely no contact or conversation with Mr. Leamon Scott or his family since this incident. The suit was subsequently dropped. I was told that he could not find an expert witness to proceed with the case. In our deposition we did point out that one of the complications associated with colonoscopy with polypectomy is possible perforation. Our records clearly demonstrate that he accepted that risk when he underwent colonoscopy.

I am sorry that Mr. Scott feel that his life is in danger, but I can assure you as well as the board I have had absolutely no contact or discussion about Mr. Scott's care other than with my legal team.

On March 16, 2000 the investigator received a request from the Arkansas State Medical Board (ASMB) (attachment 1) to investigate a complaint (attachments 2A - 2W) filed by patient B.A. against her previous physician. Alonzo D. Williams, Sr., MD and DOES 1-5. DOES 1-5 do not include other licensees of the ASMB.

Subpoenas were served to obtain (1) Dr. Williams' medical and billing records pertaining to patient B.A. (attachment 3) and (2) Blue Cross and Blue Shield's (BCBS) billing records and the complete medical file for treatment and bills submitted by Alonzo D. Williams, MD or his clinic, Gastroenterology Center of Arkansas, pertaining to patient B.A. (attachment 4).

Dr. Williams provided two charts relating to patient B.A. Chart 1 contains medical records relating to Arkansas Diagnostic Center (68 pages) and chart 2 contains medical records relating to Gastroenterology and Surgery Center of Arkansas (45 pages). The charts are part of the case file and are available for copying by the ASMB. Dr. Williams also provided two billing records relating to patient B.A. Record 1 (attachments 5A - 5C) lists Arkansas Diagnostic Center billings, and record 2 (attachment 6) lists Gastroenterology and Surgery Center of Arkansas billings.

BCBS provided billing records (32 page packet) containing a Claims Summary (attachment 7) indicating payments to Dr. Alonzo Williams relating to patient B.A. for services dates 3-23-98 through 6-7-99. Prior to 3-23-98 patient B.A. was covered by a different insurance carrier. Records from the previous carrier were not subpoenaed. The packet is part of the case file and is available for copying by the ASMB.

On 3-20-00 the investigator met with Dr. Williams in his office at Arkansas Diagnostic Center. The physician had previously read the complaint filed by patient B.A. The investigator observed Dr. Williams' office and three of his four examination rooms, his nurse's station, procedure area and recovery area. It was noted there was a lock built in the physician's office door and no locks on examining room doors that were checked. Dr. Williams provided the investigator a synopsis of patient B.A.'s medical history while subpoenaed records were being copied. The investigator requested Dr. Williams prepare a statement addressing the complaint.

Refer to attachments 8A - 8B. In his statement the physician indicates "Ms. A. has made the allegations that I have violated the Medical Practice Act in two respects: 1) She alleged that I engaged in sexual contact with her while she was a patient. 2) She also alleges that I was involved in fraudulent billing. Neither of these allegations is true and have absolutely no merit." Dr. Williams continues, "The records will reflect that on each office visit, an interview was conducted by my nurse, and her complaints were outlined in the subjective part of our office notes. She was seen on all office visits during our routine office time. She was never seen by me after hours. She was never examined unclothed without the presence of my nurse." The physician added, "I have never met Ms. A. for lunch and have never been to a hotel with her. These allegations are absolutely false."

Dr. Williams described two non-medical visits by patient B.A. as follows: "Ms. A. was seen in my office on two occasions without a scheduled appointment. After multiple requests by my secretary, she was eventually granted an interview with me. She reported to my secretary that this interview concerned the, "Best Dressed Man" award that I had received. This interview occurred in my office and lasted for approximately five to ten minutes. My secretary was instructed to interrupt this process after about five to ten minutes time so that I could proceed with my normal working schedule, which she did. She was granted a second interview after multiple requests by my secretary. I was initially unclear about the purpose of the interview and on the second visit inquired further about the purpose. She reported that she was currently training to replace the Fashion Coordinator on CNN News, Elsa Klench. She reported that this woman was getting old and she would need a replacement. She felt she was a suitable replacement. This sounded extremely bizarre and was far different from what I had been told about the interview. I then instructed my secretary to never allow her back in the office unless she had a scheduled appointment."

Dr. Williams states, "My physician/patient relationship discontinued with Ms. A. on July 9, 1999 because of increasingly bizarre and threatening behavior on her part. The records will reflect that she received a certified letter from our practice indicating that "The atmosphere you have created is unacceptable and has created a situation that makes it impossible for me to provide you with medical care." She was given the names of local [gastroenterologists] and given a copy of her medical records and instructed to seek medical care elsewhere."

Refer to attachments 9A - 9B. The investigator also interviewed Robbin Nooner, Dr. Williams' assistant. Ms. Nooner was requested to prepare a statement relating to her contact with patient B.A. Ms. Nooner states, in part, "Over the next 3-4 years, Ms. A. would present for scheduled office visits. I would get Ms. A.'s chart, which always included a charge slip. I would escort Ms. A. to my nurse's station, weigh her, and she would always turn her back so as not to see her weight. Next she would go to my station to be interviewed regarding present medical condition. Ms. A. would then be placed in one of the exam rooms. Dr. Williams would visit with her for a short period, then release her back to me with instructions. Ms. A. never complained to me or showed any signs of being sexually violated. In fact she was always in good spirits once she started feeling better medically. Ms. A. even gained 15-20 lbs which is a plus. Also, with the way the office is set up, the nurses are in and out of the exam rooms consistently, and the exam rooms are without locks. I can't see where any sexual contact could have been made during office hours."

Ms. Nooner continues, "My last contact with Ms. A. was a call made to my home (I'm puzzled as to how she got my phone number.) She irately called after apparently seeing Dr. Williams with his (girlfriend) and her daughter at Kroger's. Ms. A. was very irate and angry. She mentioned she noticed they had gone in Kroger's at separate times, and that she carefully planned to reach Dr. Williams's girlfriend before he did. Well she succeeded and when Dr. Williams approached he greeted her cordially and said his good-byes to leave to shop with his group."

"She mentioned the fact that he was cordial and that angered her to no ends. She then waited until Dr. Williams went to his car and verbally attacked him. She said for this she would try to ruin him. I told her I was shocked that she would be calling me as it related to Dr. Williams and his personal business. I quickly told her Dr. Williams and I have a nurse/doctor relationship, and that he would be angry to know I was discussing any of his personal business with her. She then insinuated I was aware of a personal relationship they both shared, I strongly denied this allegation and told her she was wrong to suggest such a thing. Afterwards, she apologized for calling and I've never heard from her again."

B. did continue to call a few more times, but was never scheduled to meet or speak with Dr. Williams regarding this interview again."

"Another thing I remember is on one of her visits, Dr. Williams did not go to his office to meet with her as soon as what she would have liked (he was tied up in the Surgery Center). I went to Dr. Williams' office to let her know that I was sorry she was having to wait so long, but that Dr. Williams was tied up doing procedures, and would be with her as soon as he could. I found her to be easily disturbed, and she became furious with me and did not like the fact that she had to wait so long."

Patient B.A. alleges Dr. Williams "is guilty of fraud by billing both [B.A.] and her health insurance carrier for services not rendered or performed, and for performing procedures not necessary." Note BCBS Explanation of Benefits for patient B.A., presented as part of Plaintiff Exhibit B, date of service 9-25-98 (attachment 2R) indicates the provider is Thorburn, MD for 3 diagnostic x-rays (ultrasounds). Arkansas Diagnostic Center billing statement, (attachment 5B) indicates a charge for the 3 ultrasounds and an office visit. The BCBS Claim Summary (attachment 7) does not indicate Dr. Williams was paid for the ultrasound procedures.

Refer to attachment 2F. The two checks presented as Plaintiff Exhibit C (attachment 2W) were credited to patient B.A.'s balance. Check 6555 for \$67.48 (3-11-98) is not credited on Arkansas Diagnostic Center's current computer system. Refer to attachments 11A - 11B. Dr. Williams provided an explanation of the application of this check to patient B.A.'s account. Check 6586 was applied to patient B.A.'s account 3-24-98 (attachment 5B). A complete analysis of billing and credit records requires an expert analyst.

The allegation that Dr. Williams performed "procedures not necessary" (attachment 2F) must be evaluated by an ASMB selected physician.

On 4-10-00 patient B.A. and Gregory Kitterman, her attorney met with Bill Trice, ASMB attorney and the investigator at Mr. Kitterman's office. The patient indicated she was referred to Dr. Williams in February, 1995. Patient reported a history of anorexia. She indicated she was treated for gastrointestinal symptoms (several office visits) and had several gastrointestinal procedures performed by Dr. Williams.

Patient B.A. stated on 11-13-95 Dr. Williams gave her money to pay for a hotel room and that afternoon she and Dr. Williams had sex. The patient indicated she and Dr. Williams had sex in his office at Arkansas Diagnostic Center in May, 1997 and approximately 10 other times in various examination rooms in the Arkansas Diagnostic Center. Dear Fellow Board Members:

Ms. Abraham has made the allegations that I have violated the Medical Practice Act in two respects:

- 1) She alleged that I engaged in sexual contact with her while she was a patient.
- 2) She also alleges that I was involved in fraudulent billing.

Neither of these allegations is true and have absolutely no merit.

I initially saw Ms. Abraham on a referral from St. Vincents Hospital back in February, 1995. She presented at that time with a history of having extreme difficulty with her swallowing. She reported that since age sixteen she had been followed for psychological and emotional problems. She reported that she had a previous diagnosis of anorexia nervosa diagnosed at age sixteen. She also reported that she continued to be followed for her emotional and psychological problems. I was impressed with her symptoms of inability of swallow. She underwent upper endoscopy, which confirmed that she had a submucosal lesion in her esophagus. She was also found to have significant peptic disease. This lesion was further defined with barium swallow CT scan of her chest. I felt that this lesion was attributing to her inability to swallow. She subsequently was referred to a Thoracic Surgeon and she underwent surgical intervention. (Should note that Ms. Abraham weighed approximately 100 lbs at the time that she presented. With appropriate treatment she gradually improved and her weight became as high as 120 lbs).

The records will reflect that on each office visit, an interview was conducted by my nurse, and her complaints were outlined in the subjective part of our office notes. She was seen on all office visits during our routine office time. She was never seen by me after hours. She was never examined unclothed without the presence of my nurse.

The billing records will clearly reflect that she was charged appropriately for the office visits, which occurred. All care received by Ms. Abraham was appropriate and adhered to the requirements of a normal physician and patient relationship.

I have never met Ms. Abraham for lunch and have never been to a hotel with her. These allegations are absolutely false.


Ms. Abraham was seen in my office on two occasions without a scheduled appointment. After multiple requests by my secretary, she was eventually granted an interview with me. She reported to my secretary that this interview concerned the, "Best Dressed Man" award that I had received. This interview occurred in my office and lasted for approximately five to ten minutes. My secretary was instructed to interrupt this process after about five to ten minutes time so that I could proceed with my normal working schedule, which she did. She was granted a second interview after multiple requests by my secretary. I was initially unclear about the purpose of the interview and on the second visit inquired further about the purpose. She reported that she was currently training to replace the Fashion Coordinator on CNN News, Elsa Klench. She reported that this woman was getting old and she would need a replacement. She felt she was a suitable replacement. This sounded extremely bizarre and was far different from what I had been told about the interview. I then instructed my secretary to never allow her back in the office unless she had a scheduled appointment.

My physician/patient relationship discontinued with Ms. Abraham on July 9, 1999 because of increasingly bizarre and threatening behavior on her part. The records will reflect that she received a certified letter from our practice indicating that "The atmosphere you have created is unacceptable and has created a situation that makes it impossible for me to provide you with medical care". She was given the names of local gastroenterologists and given a copy of her medical records and instructed to seek medical care elsewhere.

The reasons for these outrageous allegations are not clear to me, but I suspect in time when this matter proceeds through the courts, the details and motives surrounding these matters will be clear. I am confident that I will be vindicated as this matter proceeds.

I respectfully request that the Board table this matter to allow it to proceed in the normal course through the Legal System. If the Board has any other questions or concerns I am readily available to discuss this matter further.



Dear Ms. Cryer:

I would like to bring to your attention a matter of great importance to myself and my family. In April of 1993, my mother, Jane T. Zink, went to Dr. Alonzo Williams with severe stomach pains. She had unbelievable cramping and pain on a very bloated stomach. Dr. Williams, at his own clinic, tested my mother and said she had a severe case of gastritis and esophagitis. To verify this, he sent pictures home to show the family. After a period of time and seeing no improvement, we went back and upon doing some rectal procedures, indicated Mother had "severe" diverticulitis that would take a long time to cure. (He prescribed vibramycin, twice a day.) In the interim, Dr. Williams had an ultra sound and CT scan done and stated there was definitely no cancer found anywhere. Confirming her diverticulitis, she was sent home with the antibiotics.

Dr. Williams had scheduled a trip out of the country and continued with his plans to go. While he was out of the country, Mother got worse, passing out more regularly and growing weaker daily. We admitted her to St. Vincent's in May and Dr. Williams' nephew took over. Her heart was beating out of control so her cardiologist, Dr. Joe Hargrove handled the matter. Dr. Hargrove is an outstanding doctor whom we highly praise and credit with saving her life at that time. The heart matter was taken care of and she was released, but stomach problems continued. She had lost thirteen pounds during her stay at St. Vincent's and weight was dropping off at an alarming rate.

The first part of June, I demanded we switch doctors because she was worse and after calling Dr. Williams again and hearing no concern from them we went to Dr. Bruce Sanderson. On Monday, June 7, Dr. Sanderson admitted Mother to Doctor's Hospital. After calling in some specialists, later in the week (Wednesday, June 9) we were told that Mother had cancer and on Saturday we were informed it was pancreatic cancer, Stage 3. As you probably know, regardless of treatment, pancreatic cancer usually claims its victims and my mother died on Monday, August 9, 1993. What a horrible summer for my family and what drastic end to someone diagnosed by Dr. Williams with only severe diverticulitis, gastritis and esophagitis. For your information, while we had Mother in Doctor's Hospital under Dr. Sanderson and Dr. Kumperis' care, we were told on more than one occasion that she never had diverticulitis, much less a severe case.

We are in receipt of your complaint regarding services provided to your mother by the above referenced physician and also in the above referenced facility.

First, let me explain that the Arkansas Foundation for Medical Care, Inc., is the Peer Review Organization (PRO) for the State of Arkansas. It is a physician organization under contract with the Health Care Financing Administration, which administers the Medicare program. The PRO is responsible for reviewing individual patient charts in order to assure that the care provided to Medicare beneficiaries is medically necessary and reasonable, provided in the most appropriate setting (i.e., hospital vs. outpatient), and meets professionally recognized standards of quality.

In order to address the issue(s) raised in your complaint, we will request the medical record for Ms. Zinks' admission to St. Vincent Infirmary. Upon receipt of the medical record, it will be thoroughly reviewed for the quality of care she received.

If our physician reviewers have any questions regarding the care provided, the attending physician and/or facility will be afforded an opportunity to present additional information. After review of all available information a final determination will be made, and you will be notified of the outcome. Please understand, the completion of this review process may be time consuming. Your continued patience is appreciated.

Since a physician's office records do not fall under our review authority, the portion of the complaint concerning services provided by Dr. Alonzo Williams in April of 1993 has been referred to the Arkansas State Medical Board in Little Rock. The State Medical Board should respond directly to you. If you have any questions, you may contact Peggy Cryor, Arkansas State Medical Board, 2100 Riverfront Drive, #200, Little Rock, Arkansas 72202; or call 324-9410.

With these facts listed, I ask you, how can someone who is a specialist in gastroenterology be so far off !!! None of the other doctors involved understood this either. I realize that pancreatic cancer is hard to diagnose, but when he assured us that there was no cancer and stated only severe diverticulitis, I become deeply concerned. I hope you too will be deeply concerned and check into this alarming set of circumstances to find the truth. We had records transferred to Dr. Sanderson and he saw no indication of cancer in her records. I loved my mother very much and nothing will bring her back or change the facts. However, I don't want anyone else's mother to experience the pain and suffering my mother went through. She was in such pain that Dr. Sanderson, upon admitting her to the hospital, had her put on demerol immediately. Dr. Williams only had her on Phenaphen #3 occasionally. Please check into this matter with swift speed and sincere earnest. It has been over five months since I lost my mother and how many others are being misdiagnosed. I purposely have waited to write so I could think rationally, with emotions in tact.

Please understand that I am not a misinformed person or that I may have heard something I did not understand. I am a Business Educator with a Master's Degree and a Secondary Principle Certification. It is not as though I do not understand terms and remarks being made by physicians and have the sense to follow them up to see what is being mentioned. The facts are as written, and Dr. Williams was blatantly wrong.

I look forward to hearing from you soon concerning this matter and hope you will save some others in the community from the same unfortunate set of circumstances we and my mother have gone through. It is not right and a horrible thing to go through with a doctor who is so incompetent.

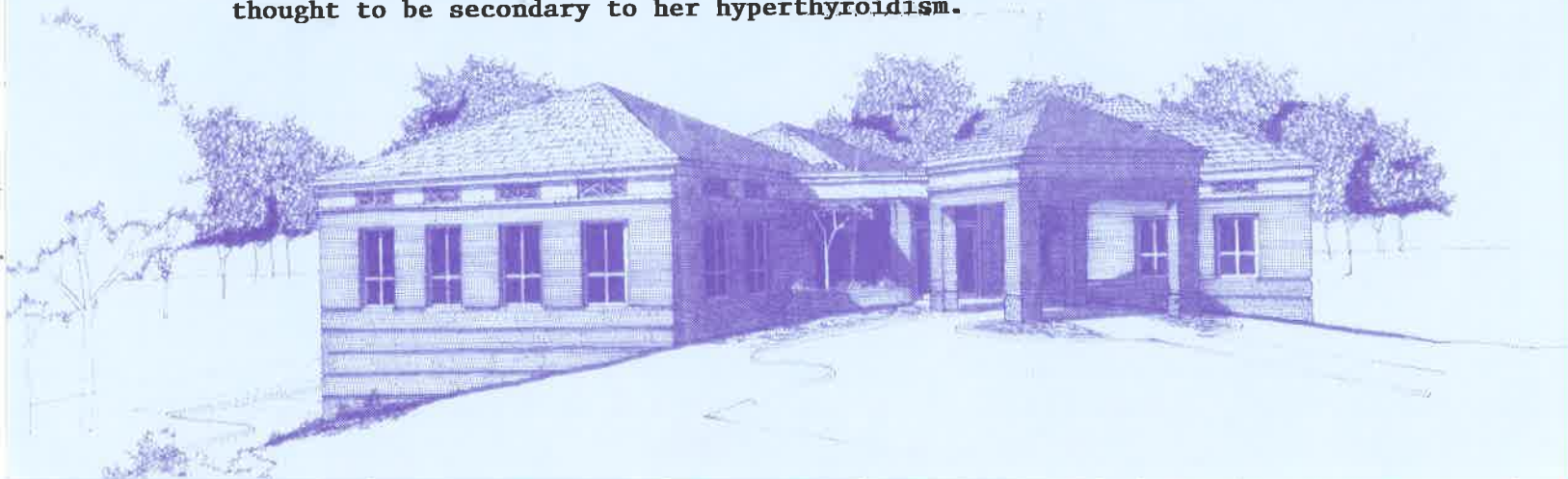

Dear Ms. Cryer:

This is in response to your letter dated 1/26/94. I too was saddened to find out that Ms. Jane Zink was subsequently found to have pancreatic carcinoma and subsequently died. She was initially referred to me by her husband, whom I had been taking care of since 4/87.

Ms. Zink's daughter, Judy Zink, suggested that I misdiagnosed her when she was told she had a case of diverticulitis. She reported that she had been told by Dr. Bruce Sanderson and Dr. Dean Kumpuris, on more than one occasion, that her mother never had diverticulitis. I have enclosed a copy of my initial history and physical as well as a copy of the EGD report which demonstrated evidence of Esophagitis and Gastritis. As she had reported, I gave her a photograph picture demonstrating the Esophagitis and Gastritis. A copy of my colonoscopy has also been enclosed which demonstrated a narrowing in the sigmoid colon with evidence of scattered diverticulosis. The report also demonstrated that she had inflammation around several of the diverticuli suggesting what I described as a mild case of diverticulitis.

The patient was treated for her Peptic Ulcer Disease and was started on some oral antibiotics for her diverticulitis. Because of her persistent pain with the above treatment, she was returned to the office and was placed on analgesics. She also underwent a CT scan of her abdomen and pelvic, a copy of which is enclosed. CT scan, at that time, revealed no evidence of acites or a pancreatic lesion. As Ms. Judy Zink has reported, I left the country and her care was assumed by my colleague, Dr. Phillip Bowden. She was hospitalized and found to have tachycardia thought to be secondary to her hyperthyroidism.



Because of her persistent symptoms, the family sought a second opinion. She was subsequently hospitalized by Dr. Bruce Sanderson. Repeat CT scan during that hospitalization, and a copy is also enclosed, now reveals that she had developed ascites, pancreatic tail prominence, as well as demonstrated mural thickening of the distal sigmoid which suggested inflammation which could be consistent with diverticulosis versus a mass lesion. Dr. Kumpuris was consulted and he performed a flexible sigmoidoscopy, a copy of which is also enclosed. He could only advance to 25 to 30 centimeters secondary to a stricture in this region and he reported that he saw no evidence of diverticulli. I suspect that this is what led Ms. Judy Zink to feel that her mother had no evidence of diverticulitis. However, during that same hospitalization a barium enema was done as ordered by Dr. Kumpuris, and a copy is enclosed, and this revealed that the patient had evidence of sigmoid diverticulosis. I suspect that due to Dr. Kumpuris inability to assess the entire colon he failed to demonstrate the diverticulli seen previously by me on full colonoscopy as well as barium enema, as well as inflammation per CT scan; copies of which are all enclosed.

Again, I am saddened to hear of Ms. Jane Zink's demise. As was previously stated, it is somewhat difficult to diagnose pancreatic carcinoma, but she had no evidence of pancreatic carcinoma when I saw her in May. In the above narrative, as well as the enclosed reports, it is clearly demonstrated that the patient did indeed have evidence of diverticulosis, as well as evidence of diverticulitis. However, in retrospect, I suspect that her pancreatic cancer was also causing some of her discomfort and persistent deterioration.

If you have any other questions as it relates to this case, please do not hesitate to contact me. I have taken the liberty of sending Ms. Judy Zink a copy of this letter as well as all reports. I am currently still caring for her father, George Zink, and it is very important to me that the family is well aware of my competence.





Dear Ms. Cryer:

This is in response to your matter dated 9/1/93. I first saw Mr. Jones upon request from the ER physician at Baptist Medical Center. He presented at that time, with evidence of severe abdominal pain and evidence of icteric sclerae. He also had a history of having GI bleeding. I have enclosed a copy of my discharge summary, which basically outlines the therapy the patient received.

Initially, his icteric sclerae enlarged liver was thought to be secondary to his alcohol abuse. He was initially told of this impression, however, when lab studies were complete he was also informed that he had viral Hepatitis B. The patient had been very persistent about how he contracted this disease, but as I had informed him on several occasions, there was really no way that we could tell. He made several attempts to incriminate his previous dentist, however, again, I told him it could not be pinpointed. Upon discussion with his dentist, upon the patient's request, the dentist, Dr. Perry, informed me that he indeed had not done any procedures on

I regret that the patient is confused about the origin of how he contracted Hepatitis B. We too are not clear on how he contracted the disease. During the hospitalization, once he was found to have Hepatitis, all of the precautions were taken. He was also instructed to have his wife evaluated for possible Hepatitis. She was subsequently found to be Hepatitis negative, and arrangements were made for her to receive the Heptavax vaccine to prevent her from contracting the disease.

Since the patient's colon polyp had not been removed at this point because of his thrombocytopenia, the plans are to arrange for the polypectomy at a later date once the thrombocytopenia has resolved.

Dear Mr. Jones:

The Board reviewed your complaint with understanding of the frustration you experienced in your hospitalization in February of this year. It is always upsetting when hospitalization is required and even more upsetting when you do not understand what is going on. Many of your fears would have been relieved had you had more information.

Unfortunately, hepatitis is very difficult to determine specifically how, when or where it is contracted. Hepatitis affects each person with a slightly different time schedule depending some on the general health of the person. For this reason, neither doctor was able to give you exact answers.


The Board did, however, feel there could have been better communication between the two physicians about the timing or your hospital release. This would enable you to better understand also.

Upon relating this to you, the Board did not feel there was evidence of violation of the Arkansas Medical Practices Act. The Board must comply with this law when taking action against physicians. Lack of communication is unfortunate, but this is not an issue which we could use to take action. I have enclosed copies of the response of both physicians to your complaint in the hope this will assist you toward a better understanding of their action.
