

## 2017 Valley Public Radio's \$10,000 Drawing

**Eligibility:** The 2017 Valley Public Radio \$10,000 Drawing is open to all legal U.S. residents (except residents of FL, NY and RI,) who are at least eighteen (18) years of age, except employees, directors and officers (or any persons who have been employees, directors or officers in the past twelve months) of White Ash Broadcasting ("Sponsor"), or prize suppliers and their affiliates, their partners, subsidiaries, franchises, distributors, retailers, advertising and promotion agencies, and the immediate families or household members of each. The Drawing is subject to all applicable federal, state and local laws and regulations. Void where prohibited or restricted by law or regulations.

**How to enter:** The Drawing begins at 12:00 a.m. PST on July 24, 2017 and ends at 11:59 p.m. PST on September 28, 2017. Any eligible individual who obtains an \$10,000 Drawing Ticket during the Drawing Period will automatically be entered into the Drawing.

### **Primary Rules and Prizes:**

Limited to 800 tickets sold. Prize claimant must be 18 years of age or older. Winner need not be present at drawing to win. Winner must take delivery of the Grand Prize no later than 30 days from the date of drawing. If the winning ticket holder does not take possession of the Grand Prize by this date, Valley Public Radio retains ownership of the Grand Prize and reserves the right to determine its next course of action, including without limitation, the right to designate an alternative winner. The winner of the Grand Prize drawing agrees to let Valley Public Radio use his/her name and photograph in all publicity and marketing materials. No cash substitutes will be allowed. Winner will be responsible for timely payment of all taxes and other costs and/or taxes associated with the delivery of the Grand Prize or required by any government agency.
