**TEMPORARY RESTRAINING ORDER ISSUED TO
WILLIE CHRIS CARTER, SR.**

Based on evidence presented on the record on Tuesday, August 05, 2014, in Division 1, the Court finds and orders that:

1. The State of Missouri is holding its primary election today including an election for the Democratic nominee for state representative in the 76th legislative district.

2. Plaintiff Joshua Peters and Defendant Willie Chris Carter, Sr., are opposing candidates for this nomination.

3. Plaintiff has attempted to serve Defendant Willie Chris Carter, Sr., with copies of his Motion for Temporary Restraining Order and his notice of today's hearing but has been unable to locate Defendant Willie Chris Carter, Sr.


4. Defendant Willie Chris Carter, Sr., has advised Plaintiff Joshua Peters that he has distributed and will continue to distribute the flyer marked as Plaintiff's Exhibit 1, which is attached to the Order.

5. The flyer set out in Plaintiff's Exhibit 1 does not identify who paid for the flyer or otherwise comply with the requirements of Section 130.031.8 of the Revised Statutes of Missouri. In addition, the flyer set out in Plaintiff's Exhibit 1 states information which is not factually correct about Plaintiff Joshua Peters.

6. The Court orders Defendant Willie Chris Carter, Sr., to destroy all copies and any originals of the flyer set out in Plaintiff's Exhibit 1 which are in his possession or under the control of his campaign for state representative and to immediately cease from distributing to anyone, either directly or by any electronic means whatsoever, the flyer set out in Plaintiff's Exhibit 1 (original or copy).

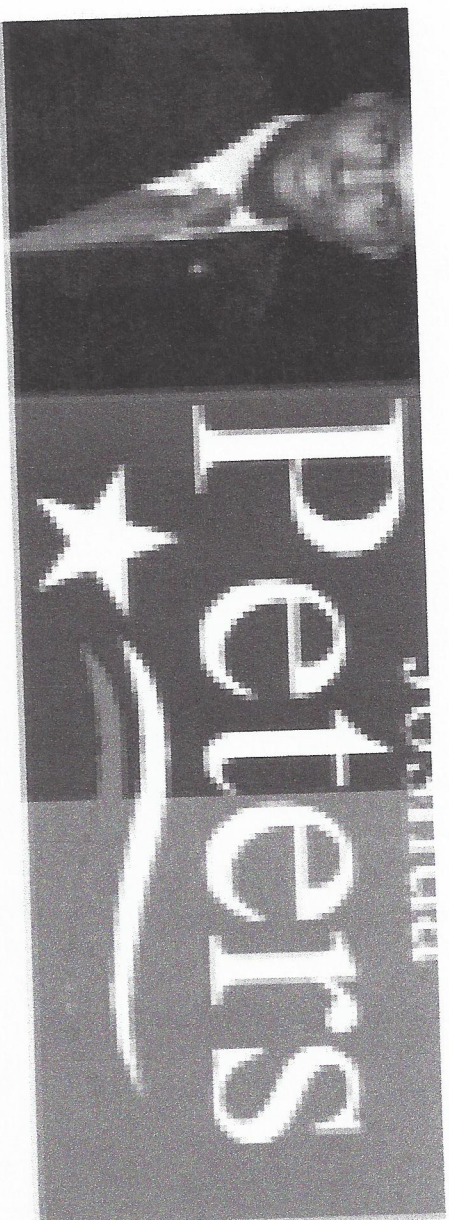

The Court has been advised that the St. Louis Board of Election Commissioners will cause the original and/or any copies of the flyer set out in Plaintiff's Exhibit 1 to be seized from anyone who is distributing this flyer within the boundaries of any polling place in the 76th legislative district in the City of St. Louis, Missouri.
