Responsible for implementation of all program activities to facilitate long-term stability of subsistence harvests and concerns of community membership in areas of fish, game or waterfowl management processes, resource development, competitive uses, environmental protection or other natural resource issues at all applicable state or federal levels. Grants/funding solicitation and fiscal/admin oversight. Supervision of 3-4 full-time/permanent and 6-8 seasonal employees.

1997-2000: Kuskokwim 300 Race Committee

Part-time sales and fund raising activities for organization promoting and sponsoring sled dog racing in Western Alaska. Gather, cut and deliver firewood in addition to occasional construction, maintenance and handyman jobs.

1988-97: Association of Village Council Presidents (AVCP) Inc., (1988-90, Resource Dept. Nunam Kitlutsisti – Protectors of the Land Inc.)

Primary activities involved serving as a liaison between tribal, state and federal governments; organization, facilitation and staffing of regional meetings; review, response and generation of technical and/or regulatory documents; staff recruitment and supervision; identification and solicitation of funding sources including fiscal oversight; operate effectively within highly complex and controversial governmental/social arenas and cross-cultural environment, with main focus on perpetuating the long-term integrity of renewable resources and subsistence way of life for the 56 native villages of the AVCP region. Supervision of 3 full-time and varied seasonal employees.
