Initiation:

On 04/07/2017 at approximately 2237 hours the Bethel Police Department received report of intoxicated individuals going into traffic on the Chief Eddie Hoffman Highway near Trailer Court.

CSP Akerelrea and I, Officer Ulak, responded to this report.

Investigation:

Observations

At this time, I observed the road having good traction in the area of the State Highway and there was good visibility.

I observed there being clouds in the sky and no direct sunlight although there was still light able to be seen through the clouds. Vehicle lights to include street lights were activated at this time.

Contact with Julia

I made contact with Julia who was already with CSP Akerelrea on the side of the roadway near 1490 Chief Eddie Hoffman Hwy.

While walking up to her I heard her state that Elia Anderson told her to jump into traffic and to kill herself. Julia said that she told Elia she would.

Julia said that was her boyfriend when asked. She said that this is how she is trying to piss Elia off. She said she was trying to catch him, and trying not to drink no more without asking her.

I asked Julia if she was suicidal at this time and she immediately said no and that she was trying to go home. She admitted to have been drinking a little bit with Elia but was not.

Julia told me that Elia got her pissed off and that she is trying to follow Elia wherever he was going. She said again that she just wanted to go home. She said she is not wanting to hurt herself when asked again.

Julia said that she only jumped into the roadway when she was with Elia after I asked. I asked if she was going to do this somewhere else and she said she would not. I advised Julia that her actions could be a crime and that she can't just be doing this.

She told me that at the time Elia was telling her to do this is when she replied to Elia that she would. Julia advised me again that she would not do this.

During the contact with Julia she did not show signs of being intoxicated and was clearly able to care for herself.

At this point, I advised her that she would be getting a ride off of the highway back to her residence.

Contact with Elia

Elia Anderson was not on scene upon my arrival to the above location and no contact was made with him in regards to this incident.

Additional

A supplemental report from CSP Akerelrea was added to this case.

Disposition:

This case is being closed off as an informational report with no further contact with person(s) involved.

No criminal charges have been filed for this incident.

INFORMATION

On the date of 04/07/17 at 2239 hours I was dispatched to the STATE HIGHWAY near the TRAILER CT for 2 intoxicated females walking in the road.

While enroute at 2239 hours when a second call came in that a female is jumping in front of vehicles. I just passed the Q2 store at 2241 hours.

Upon arrival I observed a female, in the middle of a west bound lane on the highway who appeared intoxicated. The female was wearing a black jacket with pink pants. I turned on my overhead emergency lights as I pulled up behind her and made contact with the female.

Upon contact the female stated she was going to her house, I told her I had multiple calls about her jumping in front of cars. The female told me "because of him" stated that a male stole her stuff while she was talking on the phone, with an individual named Elia. She was trying to tell that male on the phone to go home with her.

When I asked the female if she has been drinking, she stated that she was not drinking. That female said she was trying to get him pissed off. I asked her why she was trying to get him pissed off and she stated "because he didn't want me". The female stated she was jumping in front of cars because she tried to let him understand what she is doing.

The female gave me her cellphone to talk to Elia Anderson. The female said to say "if you want your woman to be ok tell him were going to pick him up". I asked the female if she was suicidal and she stated that she was not. The female stated that Elia Anderson told her to jump out in front of traffic telling her to kill herself.

Officer Ulak arrived on scene and spoke the female at 2246 hours. Officer Ulak began asking the female if she was suicidal, the female said no. Officer Ulak asked if she only did it the pressence of Elia she said yes. Officer Ulak also asked if she will do this anywhere else she said no.

After talking with her, Officer Ulak told me to give her a ride to her residence at 115 Alex Hately. After I got the female onboard I provided transport to her residence at 2250 hours. I arrived at her residence at 2253 hours and released her there and cleared from the call.
