Mendocino County Public Broadcasting ("MCPB"), licensee of Noncommercial Educational Stations KZYX (FM-NCE), Philo, California, and KZYZ (FM-NCE), Willits, California is a non-stock, non-profit organization. MCPB is filing this application to obtain Commission consent to new members of its Board of Directors.

The selection of MCPB's new Board of Directors took place pursuant to its Articles of Incorporation and By-Laws. The resulting transfer of control occurred gradually, over time, through routine changes in board membership.

This application is intended to bring the station into compliance with the requirement to obtain FCC approval of the board after 50% of the members of the board of directors have changed. The members of the Board last submitted in a transfer of control application with the Commission (FCC File No. BTCED-20110913ABY), granted on September 21, 2011, through the current year, following the annual business meeting each year, are set forth in the chart below.
