MPBN has a volunteer community advisory board (CAB) with Membership reflecting the diversity of the state and MPBNs audiences. The purpose of the CAB is to advise the Board of Trustees and MPBN staff as to whether the programming and other policies of MPBN meet the needs of the communities that the station serves. The CAB meets twice a year and its meetings are also open to the public.

MPBNs revenues come from the voluntary contributions from over 46,000 individual supporters, as well as underwriting support from businesses and nonprofit organizations.
