PITTSBURGH COMMUNITY BROADCASTING CORPORATION (PCBC) / WYEP 91.3FM IS PITTSBURGH'S TRIPLE A MUSIC RADIO STATION, AND THE PARENT COMPANY OF WHOLLY-OWNED SUBSIDIARY ESSENTIAL PUBLIC MEDIA, INC. (EPM), WHICH OPERATES SISTER RADIO STATION WESA 90.5FM, PITTSBURGH'S NPR, LOCAL NEWS, AND TALK RADIO STATION.

PROGRAMMATICALLY, THE STATIONS OPERATE INDEPENDENTLY, WITH CROSS-OVER SYNERGISTIC ELEMENTS TO ENRICH BOTH STATIONS. TO MAKE THE MOST COST-EFFECTIVE USE OF THE FUNDS ENTRUSTED TO BOTH ORGANIZATIONS, THE STATIONS SHARE FACILITIES, AS WELL AS FUNDRAISING AND ADMINISTRATIVE PERSONNEL. AS THE PARENT COMPANY, PCBC OWNS AND MAINTAINS THE BUILDING HOUSING THE CORPORATE OFFICES AND BROADCAST FACILITIES, AND EMPLOYS ALL OF THE SHARED-SERVICES EMPLOYEES THAT SUPPORT BOTH STATIONS. ALL OCCUPANCY AND EMPLOYEE BENEFIT EXPENSES, AS WELL AS PAYROLL EXPENSES FOR THE SHARED SERVICES EMPLOYEES, ARE PAID BY PCBC, AND THE PRORATED ALLOCATIONS FOR EPM'S SHARE OF THESE COSTS ARE THEN REIMBURSED TO PCBC BY EPM.

IN ADDITION, BOTH STATIONS RELY IN PART ON AN ANNUAL GRANT FROM THE CORPORATION FOR PUBLIC BROADCASTING (CPB), CALLED THE COMMUNITY SERVICE GRANT. IT IS A GRANT THAT THE CPB PAYS TO PARTICIPATING PUBLIC RADIO AND TV STATIONS WHICH MATCHES A PORTION OF THESE STATIONS' REVENUES EACH YEAR. THE CPB TREATS ORGANIZATIONS AND THEIR WHOLLY-OWNED SUBSIDIARIES AS A SINGLE ENTITY AND, IN OUR CASE, MAKES THE GRANT TO THE PARENT COMPANY, PCBC. PCBC IN TURN GRANTS THE PORTION ATTRIBUTABLE TO EPM'S REVENUES BACK TO EPM TO USE FOR THEIR ONGOING PROGRAMS.
