This year, our station successfully implemented a major overhaul of our format, schedule and brand identity. This was the result of a strategic reassessment of our station's mission and purpose. One of our biggest goals was finding programming that would more deeply engage listeners in our community and region. There was a perceived need for better and more targeted news / information programming, based on audience data and survey responses we previously received from our members. WESM 91.3 FM accomplished this goal, in part, by partnering with WYPR 88.1 FM in Baltimore, to simulcast WYPR's morning newsmagazine, "Maryland Morning." We also consolidated our programming, to provide more consistent music and news program blocks - with the hope of attracting more listeners from both types of audiences (news and music listeners). While we are still in the first year of implementation, the feedback has been cautiously positive for the most part (though some listeners did prefer the previous schedule). We have also been targeting one hour of special programming each week, specifically for issues that we feel would be relevant to the communities we serve. Topics range widely, from women's history to race relations, foreign policy, science, the environment, education and more. Most of these special programs are obtained through national distribution networks like PRSS Content Depot, or Public Radio Exchange (PRX). Occasionally we also use the latter service to supplement this with shorter-form special programming -- again reflecting a particular topic. As we move forward, we will refine or add to our overall strategy, in order to grow our audiences and serve the public in our communities.

As mentioned in the previous response, WESM 91.3 FM has partnered with WYPR 88.1 FM in Baltimore to simulcast WYPR's "Maryland Morning" newsmagazine. It airs Mondays, Wednesdays and Fridays from 9-10 am. We were fortunate to find a willing partner in WYPR, inasmuch as WESM has a very small staff (only 5 full-time people) and inadequate resources to originate any regional programming on our own. Although WYPR's "Maryland Morning" program focuses more on the Baltimore area (over 100 miles from WESM), the newsmagazine does quite often also cover topics of importance to our local listeners on the Delmarva Peninsula and surrounding areas. This includes coverage of statewide issues, legislation, cultural trends, and more. Both stations feel this is a mutually beneficial arrangement, as it extends the reach of WYPR's flagship morning program considerably on Maryland's Eastern Shore -- while it also provides WESM with regional programming, it would not otherwise be able to produce on its own (nor is any other type of programming available to acquire). We are charged a minimal fee to maintain the connection, and WESM arranged to purchase the audio-over-IP simulcast equipment needed.

Since our new strategic initiatives and partnerships, mentioned in the previous responses, are still only in their first year of implementation -- we have not yet had enough time to assess any measurable impact. Our audience data indicates there was slight boost in overall listening in Fall 2015, but at this point it's unclear if this is a normal aberration (given the small size of our market and small sample group used by Nielsen) or the beginning of a growth trend. We have received a few inquiries for more information from our weekly special programs (mentioned in response #1). With regard to our partnership with WYPR, they seem generally pleased with our joint simulcast efforts. Our hope is to build on this relationship in the future.

As discussed in #1, WESM has been providing special hour-long programming on a weekly basis, with a different topic being addressed each month. We have specifically devoted month-long programming to black and women's history. Our goal is to provide programming to audiences who might not otherwise be engaged in a topic or issue that affects them. More broadly, WESM is licensed to an Historically Black Institution, and most of our staff are minorities. With regard to our non-news or music programming, we do offer programming for diverse audiences, including jazz, gospel, blues, folk and world music. With respect to the latter, WESM offers a wide degree of music from around the world, including one hourly world music program hosted by one of our air staff.

5. Please assess the impact that your CPB funding had on your ability to serve your community. What were you able to do with your grant that you wouldn't be able to do if you didn't receive it?

WESM 91.3 FM continues to remain heavily reliant on funding from CPB to maintain our station operations. 33% of our financial support came from CPB in FY 2015 (an increase from 29% in FY 2014). WESM could not exist without CPB funding. One-third of our funding directly flows from our Community Service Grants, and without it we would not be able to acquire any programming, or maintain our station infrastructure or daily operations. Revenues have declined, in part due to heavier competition from other CPB-funded stations, an audience that is broadly declining (though with some small signs of improvement in that area), and stagnant economic conditions. This means that we rely on CPB funding more than ever before. Our University provides financial support for staff salaries and overhead, however CPB funding is WESM's lifeblood, and without continued funding -- our small, rural station would not be able to function or continue to serve our communities in

Maryland, Delaware and Virginia.
