Offenses:
ASSAULT - INTIMIDATION

ON 03/10/2014, I, SGT. FOURNEY, WAS CALLED BY MAJOR GILMORE IN REFERENCE TO THREATS THAT WAS MADE TOWARD THE CHESTER CITY POLICE CHIEF, ANDRE T. WILLIAMS. UPON ARRIVAL, I SPOKE WITH CHIEF WILLIAMS AND HE STATED THAT AFTER THE CITY COUNCIL MEETING ADJOURNED, HE AND MAJOR GILMORE WERE IN THE RESTROOM WASHING THEIR HANDS WHEN COUNCILMAN ODELL WILLIAMS ENTERED THE RESTROOM AND STATED, "WHY YA'LL STOPPED TALKING?" CHIEF WILLIAMS STATED THAT HE ADVISED COUNCILMAN WILLIAMS THAT THE CONVERSATION BETWEEN HIM AND MAJOR GILMORE WAS FINISHED. COUNCILMAN WILLIAMS STATED THAT "I THOUGHT YOU STOPPED TALKING BECAUSE I CAME IN!" COUNCILMAN WILLIAMS THEN STATED TO CHIEF WILLIAMS "YOU DON'T LIKE ME DO YOU?" CHIEF WILLIAMS ADVISED COUNCILMAN WILLIAMS THAT "I DON'T HAVE A PROBLEM WITH YOU OR ANYONE ELSE. I JUST WANT TO DO MY JOB." COUNCILMAN WILLIAMS THEN STATED TO MAJOR GILMORE, "I DON'T LIKE THE CHIEF NOR YOU!" COUNCILMAN WILLIAMS CONTINUED BY SAYING, "GENE (MAJOR GILMORE) YOU BETTER TELL HIM (CHIEF WILLIAMS) I WILL GET ON A NIGGAS ASS AND I TOLD YOU BEFORE THAT I DON'T LIKE NEITHER ONE OF YA'LL! I KEEP MY STUFF ON ME, AND I KNOW HOW TO USE IT. I WILL TAKE A NIGGA OUT EVEN IN CHURCH IF I DON'T LIKE HIM." WHILE WALKING OUT OF THE FRONT DOOR OF CITY HALL AND WITH HIS HAND IN HIS POCKET AND SHAKING IT, COUNCILMAN WILLIAMS STATED TO CHIEF WILLIAMS, "I HAVE MY STUFF ON ME NOW AND I AM NOT AFRAID TO USE IT." CHIEF WILLIAMS STATED THAT COUNCILMAN WILLIAMS STATED TO HIM WHILE STANDING ON THE STEPS OF CITY HALL, "I AM 79 YEARS OLD AND I AM NOT AFRAID TO DIE! I WILL TAKE YOU OUT AND ANY NIGGA AND BEFORE I GO OUT I WILL TAKE

A BUNCH OF NIGGAS OUT." "GENE (MAJOR GILMORE) YOU BETTER TELL HIM THAT I WILL COME TO YOUR HOUSE AND TAKE YOU OUT IF I HAVE TO BECAUSE I DON'T GIVE A DAMN, I HAVE LIVED MY LIFE." CHIEF WILLIAMS ASKED COUNCILMAN WILLIAMS REPEATEDLY IF HE WAS THREATENING HIM. CHEIF WILLIAMS THEN ASKED COUNCILMAN KILLIAN TO COME AND WITNESS WHAT COUNCILMAN WILLIAMS WAS SAYING. CHIEF WILLIAMS STATED THAT COUNCILMAN WILLIAMS STATED, "I DON'T CARE WHO YOU CALL, I'LL TAKE BOTH YA'LL ASS OUT" AND THEN HE WALKED OFF. CHIEF WILLIAMS AND MAJOR GILMORE RETURNED TO COUNCIL CHAMBERS AND IMMEDIATELY INFORMED MAYOR STRINGFELLOW AND THE REMAINING CITY COUNCIL MEMBERS (REID, BAGLEY, THOMPSON, KILLIAN) AND THE CITY ADMINISTRATOR(WORTHY) OF THE INCIDENT. STATEMENTS WERE GATHERED CONCERNING STATEMENTS THAT WAS MADE IN THE PRESCENCE OF SOME OF THE CITY COUNCIL MEMBERS BY COUNCILMAN WILLIAMS PRIOR TO THE ENCOUNTER WITH COUNCILMAN WILLIAMS AND CHEIF WILLIAMS. CHIEF WILLIAMS CONTACTED STATE LAW ENFORCEMENT DIVISION TO CONDUCT AN INVESTIGATION CONCERNING THE INCIDENT.
