SUBJECT: FINANCIAL NONCOMPLIANCE NOTIFICATION DISCIPLINARY

STATUS

The North Carolina State Board of Education policy for charter schools on financial and governance noncompliance (TCS-U-006) states that a charter school may be placed on a financial noncompliance status if the school shows signs of financial insolvency or weakness. The policy may be found in its entirety at http://sbepolicy.dpi.state.nc.us/

1. Concrete Roses STEM Academy has not provided the required UERS reporting for July and August 2014. As a result, there is no support for the cash draw downs and the school is in violation of State law.

2. Concrete Roses STEM Academy was funded for 300 students based on the projected number of students provided by the school. The school received an authority to draw of \$479,084. The school has drawn down cash of \$285,170. The number of students enrolled at the school is 126 and the initial allotments exceed the actual by 42%.

As a result of the two items listed above, the school is placed on **Financial Disciplinary** status and the access to cash is revoked, effective immediately.

The school will not be provided additional allotments until the average daily membership is provided and the funding is recalculated. The school is required to provide UERS required reporting immediately.
