I am seeking video related to protests and demonstrations following the Sept. 20, 2016 police shooting of Keith Lamont Scott. The activity followed the shooting and continued intermittently through Sept. 24.

We considered seeking the total video available. But after consultation with CMPD, we were informed that there were "boiling points" at different locations we had asked about, and, based upon that consultation with CMPD, our request is for the following videos from the following locations and times:

- Helicopter/Old Concord Rd., 9/20, 22:01 to 22:08 (1st part of Video); 2ndpart 22:38 to 23:01. (Footage from CMPD helicopter.)
- I/85 Protest, 9/21, 01:56 to 02:14. (Traffic camera footage from WT Harris, big crowd on interstate.)
- Trade and Tryon, 9/21, 16:42 to 17:03. (Large group, non-violent protest.)
- Epicenter, 9/21, 19:47 to 20:04. (Thick crowd moving at rapid pace leaving Epicenter and then coming back.)
 - Law Enforcement Center, 9/21, 19:57 to 20:20. (In front of police station, Trade and Caldwell streets, a group moving from the LEC toward the Transit Center.)
 - -Omni, 9/21, 20:28 to 20:39. (Large group outside Omni.)
 - Transit Area, 9/21, 2 separate videos, 1st 23:32 to 23:56 and 2nd is 23:57 to 00:01.
 - Marshall Park, 9/24, 13:38 to 13:59. (Organized protest.)
