I hereby submit my application to be appointed to the position of Lee County Attorney upon the retirement of Michael P. Short. I have had the pleasure to serve as Mr. Short's First Assistant since September of 2011, and I have worked in the County Attorney's Office in Lee County for a total of 8½ years now, having been originally hired as an Assistant County Attorney on July 1, 2008. During that time, I have had the opportunity to handle most of the duties of the County Attorney in Mr. Short's absence. I have also been primarily responsible for the day-to-day operations of the Fort Madison office, including the prosecution of the majority of the misdemeanor and felony cases in North Lee County. I have extensive trial experience, having both prosecuted and defended a total of more than twenty-five jury trials. In addition, I have been the representative of the County Attorney's Office in the Eighth Judicial District Drug Court Program since its inception in 2010. Finally, I have been primarily responsible for handling all juvenile delinquency cases and all Child In Need of Assistance cases in both Keokuk and Fort Madison.

The experiences outlined above have taught me that, to be a successful prosecutor, one must learn to work closely with those in the various agencies with whom I regularly work, including the Lee County Sheriff's Office, Fort Madison Police Department, Keokuk Police Department, Iowa Department

of Human Services, Juvenile Court Services, Eighth Judicial Department of Correctional Services, Iowa Department of Natural Resources, and Lee County Conservation Office. In addition, I know that success in the courtroom is largely dependent upon good police work. As such, I have volunteered to teach criminal law classes to reserve officers as a certified instructor for the Iowa Law Enforcement Academy, and I am proud to teach criminal and constitutional law to undergraduate criminal justice students at Southeastern Community College in Keokuk.

My boss, Mike Short, has served the citizens of Lee County, with distinction, for almost 40 years. My goal as county attorney will be to continue Mr. Short's practice of providing the county with the best possible legal representation and sound judgment. Although I am sure that there will be some minor changes to our office in areas where we can improve, I hope to usher in a smooth transition by continuing many of Mr. Short's policies and procedures. With respect to criminal prosecution, I agree with Mr. Short that a prosecutor's primary responsibility is "to do justice" in the criminal law arena. This means that a prosecutor must not only zealously represent the people and to protect the rights of the victims of crimes, but a prosecutor must also do all that he or she can to ensure that the accused receive fair trials.
