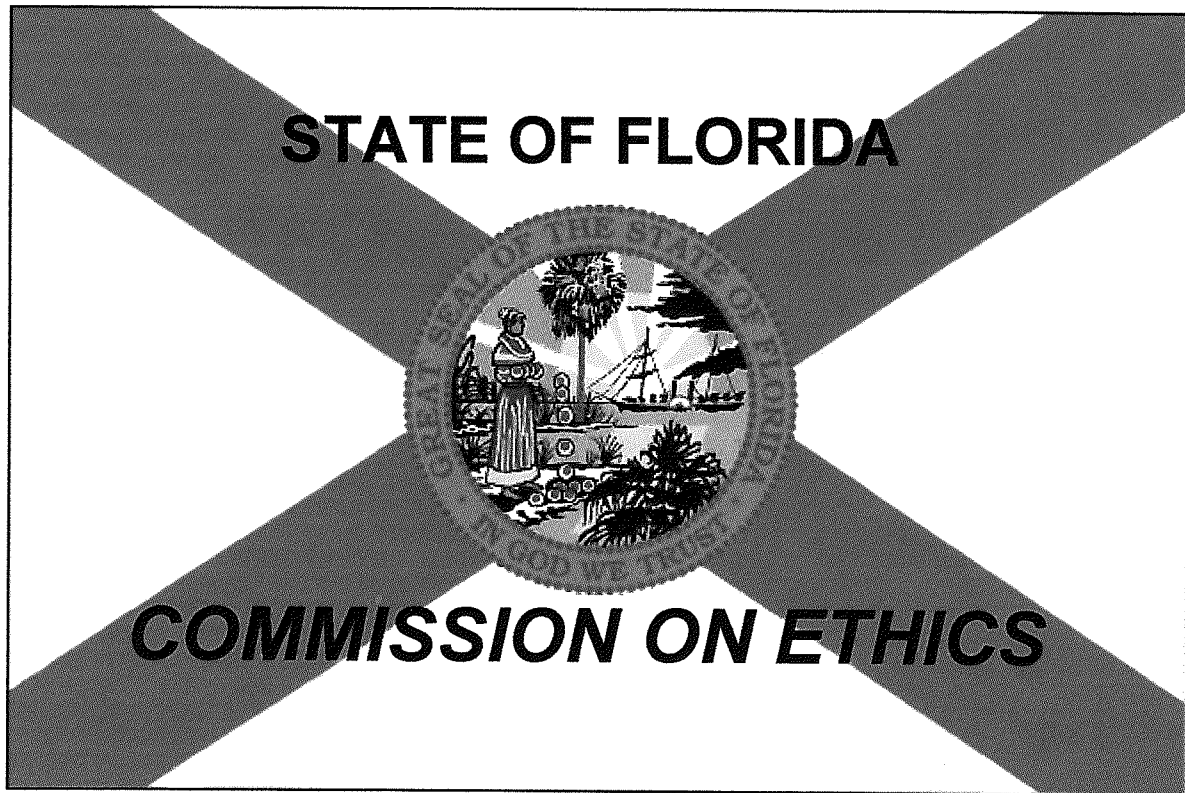


# **REPORT OF INVESTIGATION**



**REPORT OF INVESTIGATION  
COMPLAINT NO. 16-159**

(1) The complaint and amendment in this matter were filed by Carlos Slay, who alleges that Aaron Bean, while serving as a member of the Florida Senate, violated the Code of Ethics for Public Officers and Employees.

(2) Mr. Slay alleges that Senator Bean assisted in securing a \$100,000 line item appropriation in the 2016 State budget, that the appropriation was to support a business venture in which he was involved, and that he voted to approve the appropriation. Mr. Slay further alleges in an amendment to the complaint that Senator Bean charged his Senate office account for the costs associated with travel from his office in Tallahassee to the site of a fundraiser on Amelia Island that was being held by the Nassau Education Foundation, a non-profit charity that he created and his wife serves as Chair of the Board. Mr. Slay claims that it was improper for Senator Bean to request the reimbursement for this private travel expense. Finally, in the same amendment, Mr. Slay alleges that Senator Bean charged his Senate office account for expenses associated with traveling 16 miles from his office in Jacksonville to the grand opening of UF Health North hospital, an entity where he is privately employed. Mr. Slay claims it was improper for Senator Bean to request the reimbursement for this private travel expense as there is no indication this event was associated with his official duties.

(3) The Executive Director of the Commission on Ethics noted that based upon the information provided in the complaint, the allegations were sufficient to warrant a preliminary investigation to determine whether the Respondent's actions violated Section 112.313(6), Florida Statutes (Misuse of Public Position), and Section 112.3143(2)(a), Florida Statutes (Voting Conflicts).

Funding Request

(4) Mr. Slay first alleges that Senator Bean misused his public position to secure a \$100,000 special line item appropriation in the 2016 State budget to assist a Florida non-profit corporation develop a new business venture named "Celphie," an on-line mental health assessment project. Mr. Slay contends that Senator Bean secured this appropriation in order to benefit his friend and business associate John Drew, as well as himself, as a partner in the new business venture. He maintains that Senator Bean was to serve as the business' "pitch man" – its marketing and sales representative. Mr. Slay also alleges that Senator Bean voted to approve the appropriation in the State budget. He reported that his only evidence in asserting this allegation are e-mail communications between Mr. Drew, Senator Bean, and other parties, copies of which are included as pages 7 through 80 of the complaint (specifically the e-mail communications on pages 7, 24, and 42).

(5) Senator Bean was interviewed in the company of attorneys Roger Beaubien and Arthur "Buddy" Jacobs. Senator Bean related that his first involvement in public office was as Mayor of Fernandina Beach. He said that he next served as a State Representative from 2000 through 2008, and was then elected in 2012 to serve in the Florida Senate for District Four. He added that he was re-elected to the Florida Senate in 2014 and 2016.

(6) Senator Bean confirmed that he attempted to secure a \$100,000 appropriation for the Celphie program in the State's 2016 budget, and further acknowledged that he voted in the Florida Senate, one time, for matters related to the approval of the appropriation. He denied that he had any relationship or involvement to the Celphie program as alleged by Mr. Slay, noting that the proposed appropriation was rejected and was not included in the final 2016 State budget.

(7) Senator Bean explained that Mr. Drew, a friend he has known for approximately 30 years, asked him about acquiring State funding for a new program that his wife Dr. Catherine Drew had developed. Named Celphie, the program is an on-line service that allows a person to self-evaluate his or her mental health. He recalled that Mr. Drew's initial funding request was for approximately \$700,000. Senator Bean said that he believes he suggested to Mr. Drew that he (Bean) initially present the project to his fellow legislators as a pilot program in order to prove its validity, further suggesting paring down the funding request to \$100,000, after which they could request further funding once the program proved its viability.

(8) Senator Bean related that during the 2016 Regular Session he was a member of numerous committees, including the Appropriations Subcommittee on Health and Human Services, which was chaired by Senator Rene Garcia. He stated that he brought the appropriation request to Chair Garcia, who accepted it and included it in the subcommittee's recommended budget, which was forwarded to the Senate's Committee on Appropriations. Senator Bean noted that this was only one of many appropriation requests he proposed. Senator Bean stated that after the Senate approved its proposed 2016 budget, it was then reconciled with the House of Representatives through a conference program. He related that the funding request was not approved at this juncture and was dropped from the State's final 2016 budget.

(9) Senator Bean maintains that neither he, nor any relative or business associate is affiliated with the Celphie program, or with its parent company, Florida Psychological Associates, LLC, a Florida Limited Liability Company, for which Dr. Catherine Drew serves as Registered Agent and Chief Executive Officer. Senator Bean further contends that he neither he nor any relative is associated with Mr. or Dr. Drew in any other venture or business. He maintains that he did nothing more for Mr. Drew than he would have for any other constituent who came to him with a funding request.

(10) Mr. Drew confirmed that he approached Senator Bean with the idea of obtaining State funds to assist the Celphie program that his wife had developed. Mr. Drew related that he has known the Senator for many years and although they are friends, Senator Bean is not associated with the Celphie program or any other business venture his wife is involved in.

(11) Dr. Catherine Drew confirmed by telephone that Senator Bean has no interest in the Celphie program or Florida Psychological Associates.

(12) Florida Psychological Associates, LLC, Manager Anna Blackshear related by telephone that Senator Bean is not associated with and has no interest in the Celphie program.

(13) Senator Bean's name does not appear on Florida Psychological Associates State of Florida corporate records, or the Celphie.org website. Further, Senator Bean's 2015 CE Form 6, Full and Public Disclosure of Financial Interests, which includes his 2015 IRS tax return, does not reflect any income derived from or business interest relationship with the Celphie program, or John and Catherine Drew. Note, the 2015 CE Form 6 was the latest form available at the time of this Report of Investigation.

(14) Addressing the e-mails in question, starting with the e-mail on page seven of the complaint that reflects an exchange between Mr. Drew and Senator Bean, and in which Mr. Drew writes, "Are you ready to sit down and give Daigle some marching orders on what you want your marketing material to look like? Content? Etc," Senator Bean recalled that the Drews provided him with a large folder containing information about the Celphie program for his use in "selling" the program to the Legislature. He said that he informed Mr. Drew that the information he (Drew) provided was too voluminous and that if he was to "sell" the idea in the Legislature, the information needed to be summarized on one sheet of paper in order to grab the attention of other legislators who do not like to be encumbered with voluminous materials. Senator Bean contends this e-mail from Mr. Drew was an attempt to get him and John Daigle together in order to accomplish this task.

(15) John Daigle, a principle in the Jacksonville advertising agency, Daigle Creative, confirmed by telephone that he was tasked to create marketing materials for Senator Bean to present to the Legislature to assist him in requesting funding for the Celphie program. He stated that it was his understanding that Senator Bean's only relationship to the Celphie program was to assist in acquiring state funding.

(16) Mr. Drew confirmed that the e-mail was an attempt to compress marketing materials to one sheet of paper for Senator Bean to present to other legislators.

(17) The next e-mail correspondence is included as page 24 of the complaint and reflects a December 14, 2015, e-mail correspondence from Mr. Drew to Senator Bean in which Mr. Drew writes, "We must get you and Daigle Creative together so that you can tell him what you want in the presentation that we are paying him to design and develop. This is the presentation that you will take on the road with you to other states as well as the one that we will use in the Florida Legislature."

(18) Senator Bean stated that when Mr. Drew initially brought the Celphie program to his attention, Mr. Drew wanted him to be involved in some manner. However, Senator Bean said he informed Mr. Drew that he could not be involved with the program in the State of Florida, and declined the offer. Addressing the comment in the e-mail that refers to the presentation that he will take on the road, Senator Bean stated that because he told Mr. Drew that he could not be involved in the program within the State of Florida, Mr. Drew thought he could be involved in the Celphie program in other States. Senator Bean said that he told Mr. Drew that he could not be involved in any aspect of the Celphie program.

(19) Mr. Drew confirmed that the e-mail in question was during a time when he thought Senator Bean might be able to assist with the Celphie program outside the State of Florida.

However, he continued, Senator Bean informed him that he would not be involved with the program other than attempting to secure funding from the Legislature.

(20) Concerning the e-mail correspondence at the bottom of complaint page 42 that Mr. Drew addressed to "everyone," and includes the sentence, "I am truly looking forward to this partnership and FINALY (sic) everyone making money together from a product that will help the community," Senator Bean stated that he was one party of many included in this e-mail correspondence. He also stated that the message was originally intended to set up a meeting among many people and that the part of the message, quoted above, did not pertain to him, but to the others included in the correspondence.

(21) Mr. Drew confirmed that the e-mail was an attempt to schedule a meeting between numerous parties and that this particular sentence at the end of the correspondence did not pertain to Senator Bean.

(22) During the course of this investigation, and subsequent to an interview with Senator Bean, it came to light through various newspaper articles that the Celphie program had received one million dollars in funding in the 2016 State Budget through an appropriation included in the Florida State University College of Medicine's budget. One newspaper article reported that Senator Bean helped to obtain the funding for the program through other House and Senate channels, adding that Senator Bean asked Representative Halsey Beshears to make a separate request for the funding. The article also reported that Senator Bean called Florida State University President John Thrasher to discuss the funding through the University's College of Medicine. The article also cited the e-mails that were previously mentioned in this Report of Investigation in reporting Senator Bean's relationship to the Celphie program and Florida Psychological Associates, LLC, alleging that Senator Bean has a financial interest in the program.

NOTE: The newspaper article also reports that Senator Bean denied he contacted Representative Beshears about the funding request, and further reports that there were lobbyists involved in securing the funding for the Celphie program. The article also reflects that Representative Beshears could not recall requesting the funding through Florida State University, or having a conversation with Senator Bean about the funding, stating that it could have been a lobbyist who made the request.

(23) Senator Bean was interviewed a second time on April 4, 2017, in the company of attorneys Roger Beaubien, Arthur "Buddy" Jacobs, and Richard Coates. Senator Bean reiterated that he has no financial interest in the Celphie program and is not associated in any way with any business ventures in which John and Catherine Drew are associated. He further denied that he was involved in securing the one million dollar appropriation for the Celphie program, although he does acknowledge making a telephone call to Florida State University President Thrasher about the appropriation.

NOTE: The information regarding the funding for the project through Florida state University was not known to this investigator at the time of Senator Bean's first interview, and

so no inquiry was made concerning it. During his second interview, Senator Bean stated he did not volunteer this information because no questions about it were asked.

(24) Senator Bean explained that after the funding request was rejected from the 2016 State budget, he believes he might have suggested to John Drew that he (Drew) might want to consider hiring a lobbyist to assist with the funding request. He stated that within a couple of days he received a telephone call from either lobbyist Rhett O'Doski or lobbyist Derek Whitis, he could not recall which, asking him to call President Thrasher to inquire about Florida State University's interest in administering and managing the Celphe program. Senator Bean confirmed that he called President Thrasher as requested. He stated that he briefly explained the Celphe program to President Thrasher, and that President Thrasher informed him that he was interested in involving the University with the program. Senator Bean stated that he passed that information on to the lobbyist who called him, and that he had no other involvement in the matter.

(25) Senator Bean does not believe he spoke to Representative Beshears as was reported in the newspaper article. However, while he said he does not remember speaking with Representative Beshears, he might have to re-evaluate his recollection if the Representative was insistent that the conversation took place.

(26) Senator Bean maintains that he treated constituents John and Dr. Catherine Drew no differently than any other constituent, including Dr. Laureen Pagel, the Director of Starting Point Behavioral Healthcare, another mental health care provider in Nassau County, and the former employer of Dr. Catherine Drew. He said that he assisted Dr. Pagel with a funding request during both the 2016 and 2017 State budget process.

(27) Senator Bean noted that he was not asked to request funding for the Celphe program in the 2017 State budget. He stated that it was his understanding that the appropriation the Celphe program was awarded in the 2016 budget would be recurring in the 2017 budget.

(28) Senator Bean said that he voted on this matter only one time and that was when he voted to approve the entire 2016 Senate budget, in which this funding was included.

(29) Mr. Drew recalled by telephone that subsequent to the Legislature's rejection of his funding request, he suggested to his wife that she contact lobbyists Derek Whitis and Rhett O'Doski. He stated that the two lobbyists within days had secured the funding through the Florida State University College of Medicine. Mr. Drew maintained that Senator Bean was not involved in this appropriation subsequent to his initial request and that it was the lobbyists alone who secured the funding. Mr. Drew confirmed that the funds were recurring in the 2017 State budget. However, he continued, the funding was cut from the budget during the 2017 Legislative budget process.

(30) Mr. Rhett O'Doski reported that he and Derek Whitis were hired to assist John and Dr. Catherine Drew in obtaining funding for the Celphe program. He stated that subsequent to a telephone conversation with Mr. Drew, he and Mr. Whitis decided that they would accept the Drews as clients. He stated that they mapped out a strategy which included determining

Florida State University's interest in administering the appropriation. Mr. O'Doski stated that it was his idea to contact Representative Beshears and ask him to request the appropriation in the Florida House of Representatives. Mr. O'Doski stated that he believes he spoke with Florida State University's lobbyist Kathleen Daly in order to ascertain Florida State University's interest in administering the program, and that she subsequently confirmed with him that Florida State University would agree to administer the program. Mr. O'Doski maintains the Senator Bean was not involved in this appropriation request, and that he did not ask Senator Bean to contact President Thrasher. Mr. O'Doski confirmed that the appropriation funds were recurring for the 2017 State budget.

(31) Numerous attempts to contact Mr. Derek Whitis were unsuccessful.

(32) Representative Beshears recalled by telephone that Mr. O'Doski asked him to file an appropriation request concerning the Celphe program, and that his only involvement in the matter was to complete and file the appropriation request for the 2016 State budget. Although he stated in a newspaper article that he made the request for Senator Bean, and then later in the same article stated, "It could have been Senator Bean and it could have been a lobbyist," Representative Beshears stated that does not believe that he had a conversation with Senator Bean about this matter. He added, if a conversation between him and Senator Bean had occurred it would be something that he would remember. He also stated that he did not consider the request for the appropriation unusual because Florida State University is in his district and he is a Florida State University alum who believed the Celphe program was good for the community.

(33) Associate Professor and Vice Chair for Research Dr. Heather Flynn, and Associate Dean for Finance and Administration and Florida State University Chief Financial Officer Sharon Woodall, each confirmed by telephone that Florida State University administered the funds for the Celphe program through the State appropriation the College of Medicine received in the 2016 State budget, and that the funds were recurring in the 2017 budget.

#### Travel Reimbursement

(34) Mr. Slay alleges that on January 26, 2016, Senator Bean left from a Senate subcommittee meeting he was attending in Tallahassee and traveled to Amelia Island, Florida, to attend a fundraiser being held by the Nassau Education Foundation, a non-profit charity. Mr. Slay reported that the fundraiser was for a charity that Senator Bean created, and which his wife Abigail Bean was serving as Board Chair. He maintains it was improper for Senator Bean to charge his Senate office account for travel costs associated with the trip. Mr. Slay provided a copy of Senator Bean's voucher for travel reimbursement that he received through a public records request. This voucher is appended as Exhibit A. The voucher reflects that between January 25 and January 28, 2016, Senator Bean claimed a mileage reimbursement of \$172.66 for round-trip travel between Fernandina Beach and Tallahassee, totaling 388 miles.

NOTE: Also documented on the travel expense voucher, above the mileage reimbursement, is "Session Subsistence – 1/25/2016 8:00:00 AM – 1/28/2016, 6:30:00 PM, Tallahassee, \$570.00."



(35) According to the Nassau Education Foundation website:

The Nassau Education Foundation (NEF) is directed by a voluntary Board comprised of business, education and community leaders. Our vision is to see the community united to maximize the support for public education by providing funding that gives all students the advanced skills and knowledge needed to compete in the 21st century economy. The Nassau Education Foundation raises money through corporate and community donations to fund a teachers' grants program in support of innovative projects that enhance the educational experience.

(36) Senator Bean acknowledged that he traveled to the January 26, 2016, fundraising event, but denies that he created the charity. Senator Bean explained that the Nassau Education Foundation has been in business for approximately two and one-half years and is part of a consortium of education foundations throughout the State. He said that although he has volunteered his time, along with others, including his wife, in an effort to start the fledgling foundation in Nassau County, he has never served on its Board or committees, or served in a position that could control its funds. He acknowledged that in January 2016, his wife Abigail Bean had been voluntarily serving on the Foundation's Board, noting that she was hired as the Foundation's Executive Director sometime during the summer of 2016.

(37) Senator Bean stated that the Foundation asked him to be the Master of Ceremonies for its January 2016 annual teacher of the year event, which is a fundraiser to provide grant funding to teachers. He added that a citizen's panel reviews and awards the grant applications from teachers. The event, he continued, was held during Senate Committee meetings in Tallahassee and that on the afternoon of January 26, 2016, he traveled to Amelia Island to attend the event, returning to Tallahassee the next morning. During his interview with this investigator, Senator Bean said he believed he had been reimbursed for his round-trip travel from Tallahassee to Amelia Island. He deferred to his staff to confirm his reimbursement because his staff completes and submits the necessary documents to claim reimbursements.

(38) Senator Bean's legislative assistant Dee Alexander reported that she is the staff member who completes and submits the Senator's travel requests and reimbursement statements. Ms. Alexander reported that, upon investigation, she discovered that Senator Bean had not been reimbursed for the trip. She stated that there was no documentation recording a reimbursement and that it was not submitted because the fundraising event was not an event in which the Senator could claim reimbursement.

(39) Office of Legislative Services Finance and Accounting Director Lisa Swindle reported that travel documents reflect that Senator Bean was in Tallahassee from January 25 through January 28, 2016, for duties related to the 2016 legislative session, and he was reimbursed for travel related to those duties. She advised that there is no record of the Senator claiming travel expenses for his round trip travel to Amelia Island on January 26, 2016. She referred to the travel voucher, which is appended as Exhibit A, that reflects his reimbursement for expenses and mileage for his legislative duties in Tallahassee between

January 25 through January 28, 2016, and contains no record of reimbursement for his travel to Amelia Island.

(40) Mr. Slay reported that Senator Bean is employed by UF Health North in Jacksonville in its Community Relations Department. He related that on February 12, 2015, Senator Bean attended a UF Health North hospital grand opening ceremony in Jacksonville and charged his Senate office account for the 16 miles he traveled for the event. Mr. Slay contends that as an employee of UF Health North, the Respondent should not have billed the State for his travel expenses for an event that could be related to his job responsibilities.

(41) Senator Bean confirmed that he is employed at UF Health North and his title is, "Relationship Development Officer." He stated that his duties include working with the Development and Community Relations Departments to promote good will for the hospital as well as attracting potential donors and establishing new business for the hospital. He reported that an official invitation to the grand opening was received at his Senate office, and his staff scheduled his appearance at the event on his legislative calendar. He confirmed that although he is employed by UF Health North, he attended the event in his role as State Senator, sitting with other State officials who also attended the event. Senator Bean related that the day on which the hospital grand opening event was held was a regularly scheduled work day for him as an employee of UF Health North. He added that he might have attended the event as an employee, but his attendance would have been at the discretion of his supervisor.

(42) Senator Bean explained that because his staff handles his travel reimbursements, he was unaware that he had been reimbursed for the mileage traveled from his Jacksonville office to the event until it was brought to his attention through the instant complaint. Upon this discovery, he continued, on February 2, 2017, he wrote a check to the Intradistrict Account for \$7.76 to refund the account for the amount that had been claimed as a travel reimbursement. The "Intradistrict Expense Travel Report" that reflects the trip and mileage claimed and the \$7.76 refund check are appended as composite Exhibit B.

(43) Legislative assistant Dee Alexander confirmed that an official invitation was received at Senator Bean's legislative office in Jacksonville, inviting him to attend the hospital grand opening. She stated that Senator Bean was informed of the invitation and his attendance to the event was scheduled on his legislative calendar. She added that the invitation was not retained. Ms. Alexander reported that when she completed Senator Bean's February 2015 Legislative Expense Travel Report, as she normally does, she used the events that were documented on his legislative calendar as a guide for his travel expenses. She stated that she then electronically submitted the report for reimbursement, which included the mileage for the hospital grand opening, without consulting with Senator Bean as to its accuracy.

(44) A copy of the "UF Health North Ribbon-cutting invite list" from UF Health North is appended as Exhibit C. As reflected on the document, an invitation was sent to Senator Aaron Bean, Florida Senate, Florida Senator, District Four.
