

***WMUK 102.1 FM Drawing Rules for Tickets to  
“Kalamazoo Symphony Orchestra Presents: Star Wars: A New Hope”***

1. WMUK 102.1 FM (“the Station”) will conduct a ticket drawing on September 15, 2017 for two (2) pairs of tickets to see “*Kalamazoo Symphony Orchestra (KSO) present Star Wars: A New Hope in Concert*” at Miller Auditorium in Kalamazoo, MI on Thursday, October 12, 2017 at 8:00 pm. Two (2) winners will be chosen by random drawing. (Each of the four tickets is valued at \$65.00 each, total combined value of \$260.00.)
2. WMUK will announce the names of the winners on-air between 4:45 p.m. and 6:00 p.m. Eastern Standard Time on Friday, September 15, 2017. Winners’ names will be drawn at random from all eligible entries. No more than one (1) pair of tickets will be awarded to each winner. Unless they opt out of the drawing, all entrants consent to having their name read on air should their name be selected. Anyone who donates, pledges, or asks to be entered between 12:00 a.m. July 1, 2017 and Friday, September 15, 2017 9:00 a.m. EST, and provides complete contact information will be entered. Entry is also available by mailing name, postal address, email address and phone number to “KSO Star Wars Ticket Drawing, WMUK 102.1 FM, 1903 West Michigan Avenue, Kalamazoo, MI 49008-5351”. Mailed entries must arrive at WMUK by September 15, 2017 at 9:00 a.m. EST. No donation, purchase, pledge or other form of consideration is necessary to be entered in the drawings.
3. One (1) entry per person is allowed. Those making a pledge multiple times, and/or sending multiple letters of entry will be entered in the drawing once and only once. Any legal resident of any one of the 50 United States or the District of Columbia over the age of 18 years may enter, excluding employees and interns of WMUK, their family members or persons living in their household. Only two (2) pairs of tickets will be awarded (one pair for each of the two winners).
4. Entrants agree to indemnify and hold harmless the Station from any and all liability resulting or arising from the drawing, to release all rights to bring any claim, action or proceeding against WMUK. The value of the tickets may be taxable to winner as income. All federal, state and local taxes, and any other costs not specifically provided for in these rules are solely the winner’s responsibility.
5. Odds of winning depend on the number of entries.
6. The drawing will be conducted by WMUK staff in the Station’s studios. Winners’ names will be announced on-air, and each winner will be notified by phone and/or e-mail. If a winner is unable or unwilling to collect the prize, or if WMUK is unable to contact a winner, another winner will be drawn at WMUK’s sole discretion. WMUK shall have no responsibility or obligation to a winner or potential winner who is unable or unavailable to accept, claim or utilize the tickets.
7. Tickets will be sent via postal mail to the 50 United States or District of Columbia address provided by the winner. WMUK assumes no responsibility for lost, stolen, or undeliverable tickets sent via mail carrier.
8. WMUK assumes no responsibility for incorrect or inaccurate entry information whether caused by any of the equipment or programming associated with or utilized in this drawing or by any human error which may occur in the processing of the entries in this drawing. WMUK is not responsible for any cancellation or postponement of the *KSO Star Wars: A New Hope* performance or for any action of Miller Auditorium that would render the tickets unusable.
