WRKF BOARD OF DIRECTORS MEETING

March 23, 2016

APPROVAL OF MINUTES

It was moved by Secretary Brandt and seconded that the minutes of the February 3, 2016 be approved.

FINANCIAL

David said two bills for 2015 server and engineering expenses came in 2016. Membership and underwriting revenues are tracking ahead. (The financial report is attached to the minutes).

TRANSMITTER

Cyril recommended framing the transmitter replacement in three stages:

- 1. Board commitment: \$15K from Cyril + \$35k=\$50k
- 2. Financing by supplier=\$50K
- 3. Capital campaign=\$50k

Thanks to Cyril for his generous pledge of \$15k.

David said NPR approved cross programming with KRVS/WWOZ so each carries the others primary station on its secondary channel.

Janet said it would be good to have revenue projections from the added service.

There was discussion of dedicated fundraising events such as a Transmitter Party at the site and mentioning it at the Founders Luncheon.

Mary Ann wants to see what stations around the country are doing with the extra channels.

Cyril said a technology company might want to underwrite it.

The possibility of grant funding from foundations and others was discussed.

Robyn said Girl Scouts received matching funds via BRAF for a Girl Scouts facility improvement; will find out fund details. Next steps: Request bids from two companies. Develop financial plan and timetable.

Ticket and sponsorship pricing was discussed. Mary Ann said members should get a discount on tickets. General agreement on pricing as presented. We will need to select the founders award recipient for 2016.
