Hello Mr. Andrews,

I wanted to follow up on your previous correspondence in order to let you know the status of your public records request.

Our records reflect that we received and acknowledged your public records request on Tuesday, July 31st, 2018.

On Monday, August 6th, 2018, our office followed up on the specifics of your request and asked for clarification on search terms and email domains.

On Friday, August 10th, 2018 we received your response instructing our office to 'use the names of the individuals, the company names, the domain for the company, and the domain for the lobbyists and their firms as search terms for an email search,' and that 'I believe you will find out the domains as you begin to conduct the search'. In this correspondence, you also indicated that you would like to start receiving these records on a rolling basis beginning Thursday, August 16th.

On Wednesday, August 15th, 2018 we received follow up correspondence from you indicating that you would like to include seven additional search terms in your request.

On Thursday, August 16th, 2018 our office responded to your previous two emails with an outline of how we would be proceeding with processing your request, including search terms and the unspecified email domains.

On Friday, September 7th, 2018 we received correspondence from your office indicating that you would be filing a petition to compel the production of the requested records, were they to not be produced within five days.

During the sixteen business days between our correspondences, our office began processing your request as stated on August 16th. As per your request, our intention is to release the records on a rolling basis, and focus on producing the records responsive to item one in your request first. Due to the broad nature of your request, the estimated results are numerous. Our office is currently processing your request and we are continuing to compile responsive documents.
