Dane County District Attorney Ismael Ozanne, Milwaukee County District Attorney John T. Chisholm, and Iowa County District Attorney Larry Nelson file this Motion to Intervene in the above entitled proceedings, consistent with the directive of the court on December 4, 2015.

On December 2, 2015, the Wisconsin Supreme Court issued an decision and order, denying the motion for reconsideration and limiting the authority of the Special Prosecutor in the above entitled proceedings to those duties necessary to terminate the underlying John Doe proceedings in the following cases:

No. 12JD000023


Shortly thereafter, on December 4, 2015, the Wisconsin Supreme
Court issued the following order:

On the court's own motion and in light of the court's per curiam
opinion and orders issued on December 2, 2015, including the
court's ruling that Attorney Francis Schmitz has no authority to act
as the appointed special prosecutor with respect to the above-listed
matters (except with respect to the limited tasks assigned to him in
the December 2, 2015 per curiam opinion denying his motion for
reconsideration);


IT IS ORDERED that if any or all of the district attorneys of
Columbia, Dane, Dodge, Iowa, and Milwaukee Counties wish to
request permission to intervene as a party for all purposes in the
above-referenced matters, such motion or motions for intervention
shall be filed with the clerk of this court on or before December 18,
2015.

Accordingly, pursuant to Wis. Stat. §§ 809.13 and 809.63, the respective District Attorneys below file this motion to intervene in the above entitled proceedings.


