THE ABOVE NAMED COMPLAINING WITNESS BEING DULY SWORN, ON INFORMATION AND BELIEF STATES THAT:

Count 1: SECOND DEGREE SEXUAL ASSAULT

The above-named defendant on or about Friday, July 12, 2013, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, by use of force, did have sexual contact, penis to body, with RBB/Victim #1, without the consent of that person, contrary to sec. 940.225(2)(a), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

Count 2: CHILD ENTICEMENT (EXPOSING SEX ORGAN)

The above-named defendant on or about Wednesday, July 17, 2013, at 8581 N. 63rd Street., in the Village of Brown Deer, Milwaukee County, Wisconsin, with intent to cause a child to expose a sex organ in violation of sec. 948.10, did cause RBB/Victim #1, DOB 08/30/1996, a child who had not attained the age of 18 years, to go into a room, contrary to sec. 948.07(3), 939.50(3)(d) Wis. Stats.

Upon conviction for this offense, a Class D Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than twenty five (25) years, or both.

Count 3: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about January 1, 2002 and December 31, 2003, at 4044 N. Elmhurst Rd., in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact with a child under the age of thirteen, RBB/Victim #2, DOB 04/24/1995, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Count 4: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about January 1, 2002 and December 31, 2003, at 4044 N. Elmhurst Rd., in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact with a child under the age of thirteen, RBB/Victim #2, DOB 04/24/1995, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Count 5: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 01/01/2005 and 12/31/2006, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, did have sexual contact with a child under the age of thirteen, RBB/ Victim #3, DOB 04/24/1995, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Count 6: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 01/01/2005 and 12/31/2006, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, did have sexual contact with a child under the age of thirteen, RBB/Victim #3, DOB 04/24/1995, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Count 7: REPEATED SEXUAL ASSAULT OF A CHILD

The above-named defendant between about 01/01/2007 and 12/31/2010, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, did commit repeated sexual assaults involving the same child, RBB/Victim #3, DOB 04/24/1995 where fewer than three of the assaults were violations of sec. 948.02 (1) Wis. Stats., contrary to sec. 948.025(1)(b), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

Count 8: ATTEMPT SECOND DEGREE SEXUAL ASSAULT

The above-named defendant between about 09/01/2012 and 09/30/2012, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, attempted to have sexual contact with RBB/Victim #3, who the defendant knew was unconscious, contrary to sec. 940.225(2)(d), 939.50(3)(c), 939.32 Wis. Stats.

Upon conviction for this offense, an attempt to commit a Class C Felony, the defendant may be fined not more than Fifty Thousand Dollars (\$50,000), or imprisoned not more than twenty (20) years, or both.

Count 9: EXPOSING GENITALS OR PUBIC AREA

The above-named defendant between about 09/01/2012 and 09/30/2012, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, for purposes of sexual arousal or gratification, did cause a child to expose their genitals, contrary to sec. 948.10(1) and (1)(a), 939.50(3)(i) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

Count 10: THIRD DEGREE SEXUAL ASSAULT

The above-named defendant between about 09/01/2012 and 09/30/2012, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, did have sexual intercourse with RBB/Victim #3, without that person's consent, contrary to sec. 940.225(3), 939.50(3)(g) Wis. Stats.

Upon conviction for this offense, a Class G Felony, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

Count 11: SECOND DEGREE SEXUAL ASSAULT

The above-named defendant between about 09/01/2012 and 09/30/2012, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, by use of force , did have sexual contact , hand to penis, with RBB/Victim #3, without the consent of that person, contrary to sec. 940.225(2)(a), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than One Hundred Thousand Dollars (\$100,000), or imprisoned not more than forty (40) years, or both.

Count 12: EXPOSING GENITALS OR PUBIC AREA

The above-named defendant between about 09/01/2012 and 09/30/2012, at 8581 North 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, for purposes of sexual arousal or gratification, did expose his genitals to a child, contrary to sec. 948.10(1) and (1)(a), 939.50(3)(i) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

Count 13: THIRD DEGREE SEXUAL ASSAULT

The above-named defendant between about 11/01/2012 and 11/30/2012, at 8581 N. 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, did have sexual intercourse with RBB/Victim #3, without that person's consent, contrary to sec. 940.225(3), 939.50(3)(g) Wis. Stats.

Upon conviction for this offense, a Class G Felony, the defendant may be fined not more than Twenty Five Thousand Dollars (\$25,000), or imprisoned not more than ten (10) years, or both.

Count 14: EXPOSING GENITALS OR PUBIC AREA

The above-named defendant between about 11/01/2012 and 11/30/2012, at 8581 N. 63rd Street, in the Village of Brown Deer, Milwaukee County, Wisconsin, for purposes of sexual arousal or gratification, did cause a child to expose their genitals, contrary to sec. 948.10(1) and (1)(a), 939.50(3)(i) Wis. Stats.

Upon conviction for this offense, a Class I Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

Count 15: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 04/09/1998 and 04/08/2002, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (hand to

penis or genitals) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 16: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 04/09/1998 and 04/08/2002, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (defendant's mouth to child's penis) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 17: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 04/09/1998 and 04/08/2002, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (defendant's penis to child's thighs or buttocks) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 18: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 04/09/1998 and 04/08/2002, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual intercourse (defendant's penis to child's anus) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 19: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between about 04/09/1998 and 04/08/2002, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual intercourse (defendant's penis to child's anus) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 20: SEXUAL ASSAULT OF A CHILD UNDER 13 YEARS OF AGE

The above-named defendant between 04/09/1997 and 04/08/1998, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (child's mouth to defendant's penis) with a child under the age of thirteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.02(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed forty (40) years.

Count 21: REPEATED SEXUAL ASSAULT OF A CHILD

The above-named defendant between 04/09/2002 and 04/08/2004, at 4044 North Elmhurst Road and "Yankee Hill," in the City of Milwaukee, Milwaukee County, Wisconsin, did commit three or more violations of sec. 948.02 (1) or (2) Wis. Stats. involving the same child who had not yet attained the age of sixteen, DBS/Victim #4, DOB 04/09/1989, contrary to sec. 948.025(1), 939.50(3)(b) Wis. Stats.

Upon conviction for this offense, a Class B Felony, the defendant may be sentenced to a term of imprisonment not to exceed sixty (60) years.

Count 22: 2ND DEGREE SEXUAL ASSAULT OF CHILD

The above-named defendant between about 11/10/1991 and 11/09/1994, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (hand to penis, while on the moped) with JDB/Victim #5, date of birth 11/10/1978, a child who had not attained the age of sixteen years, contrary to sec. 948.02(2), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than ten (10) years, or both.

Count 23: 2ND DEGREE SEXUAL ASSAULT OF CHILD

The above-named defendant between about 11/10/1991 and 11/09/1994, at 4044 North Elmhurst Road, in the City of Milwaukee, Milwaukee County, Wisconsin, did have sexual contact (hand to penis, while in the automobile) with JDB/Victim #5, date of birth 11/10/1978, a child who had not attained the age of sixteen years, contrary to sec. 948.02(2), 939.50(3)(c) Wis. Stats.

Upon conviction for this offense, a Class C Felony, the defendant may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than ten (10) years, or both.

PROBABLE CAUSE:

I am a Village of Brown Deer law enforcement officer and I base this complaint on information contained in police reports prepared by members of the Village of Brown Deer Police Department, in the ordinary course of business, concerning allegations of repeated child sexual assault, and related offenses, reportedly perpetrated by the above named defendant, Ronnie Johnson, on information and belief the current "Vice President of Charter Education" for the "Universal Academy" and the former Principal of "Young Leaders Academy" or "YLA," a so called "charter school" serving students in the city of Milwaukee.

Said reports contain the statements of RBB/Victim #1, RBB/Victim #2 and RBB/Victim #3 and their parents, among others, including several members of the Village of Brown Deer Police Department. What is contained in this Complaint constitutes a paraphrase of said statements and is not exhaustive of all known information concerning these matters and this investigation. Investigation into these and related allegations remains ongoing. Said police reports and this Complaint are subject to supplementation and/or Amendment as said investigation progresses.

As to Counts #1-#14 Generally**Interview of "JR"**

Said police reports reflect that on 07-23-13, investigators with the Village of Brown Deer Police Department spoke with "JR," an adult female and the mother of RBB/Victim #1 (currently 16 yoa),

RBB/Victim #2 (currently 18 yoa) and RBB/Victim #3 (currently 18 yoa). JR indicates that she resides with her three sons and her husband, RR.

JR states that sometime after midnight on 07-23-13, her three sons had disclosed to her that they had been sexually assaulted by the above named defendant, Ronnie Johnson. JR states that Ronnie Johnson is a family friend, one son's former 5th grade teacher, and RBB/Victim #3's "godfather," and her sons' former school principal. She states that RBB/Victim #1 (currently 16 yoa), RBB/Victim #2 (currently 18 yoa) and RBB/Victim #3 (currently 18 yoa) all attended the Young Leaders Academy ("YLA"), while Johnson was the "YLA" principal. She states that "YLA" is a "Charter School." She states that RBB/Victim #1 (currently 16 yoa) attended "YLA" from 1st grade through 8th grade, while her twins, RBB/Victim #2 (currently 18 yoa) and RBB/Victim #3 (currently 18 yoa) attended "YLA" from 2nd grade through 8th grade. JR states that the defendant is currently starting a new charter school called "Universal."

JR states that when her sons were younger, they did not have a strong father figure and that the defendant took on what appeared to be a kind of "father figure" role for her boys.

JR further states that she believes that her sons first started going over to the defendant's residence in about 2003. JR states that she thought the circumstances seemed a little odd at first but that she knew other "YLA" students went over to Johnson's house. She states that she allowed her sons to go over to Johnson's residence but at first made sure that they went as a group. JR states that she did allow her sons to spend the night at the defendant's home as well.

JR states that Johnson had a pool table, televisions, gaming systems and fun things for the kids to do. Throughout the years, JR's sons continued to go over to Johnson's residence by themselves. At times, Johnson would ask if her sons wanted to go over and other times her sons would ask to go over to Johnson's residence. Johnson would pick her sons up and bring them to his house or she would take them. The visits would vary from a few hours to spending the night. It was not unusual for her sons to sleep over at Johnson's house. Johnson would also talk with her sons by phone.

JR also states that the frequency of the visits also varied from a couple times a month to less frequent as they got older. JR went on to state, however, that as her sons were preparing for college, she encouraged them to seek Johnson's assistance because he "helped get kids into college."

JR states that at some point RBB/Victim #2 no longer wanted to go over to Johnson's house and stopped going, without explanation. Since then, she said, RBB/Victim #2 has "hated" Johnson.

JR states that RBB/Victim #3 went to Johnson's house on the most consistent basis and spent the most time over at Johnson's house, which continued through this year.

JR states that on 07-22-13, her husband got a phone call from Johnson asking to speak with RBB/Victim #1, but RBB/Victim #1 refused to speak with him, which she thought was odd because RBB/Victim #1 had just recently been with Johnson. About 15 minutes later, Johnson called back again looking for RBB/Victim #1 and her husband told Johnson to send a text to RBB/Victim #3 who was then upstairs with RBB/Victim #1.

She further states that a short time later, RBB/Victim #1 went outside and was talking with Johnson. At this point, JR went to bed. She states that later, she heard RBB/Victim #1 yelling and their front door slam. JR states that she went downstairs and found that both RBB/Victim #3 and RBB/Victim #1 had left the house and could not be found. JR explained that RBB/Victim #2 was away at college orientation in Chicago and was not home.

JR states that she then called RBB/Victim #3's phone and sent messages, both of which he did not answer immediately. JR's husband then called Johnson to see what had happened. JR states that Johnson informed them that RBB/Victim #1 was "mad" about school and an incident that had happened with his sister.

JR states that she called Johnson back to see what actually occurred between him and RBB/Victim #1. She states that Johnson told her that RBB/Victim #1 "might have been mad about a story crafted by [RBB/Victim #2] about how Johnson had touched [RBB/Victim #2] when he was younger." While on the phone, JR states that she received a text message from RBB/Victim #3 at 12:37am on 07-23-13, which read, "I'm sorry mom but there is some stuff that you are about to find out."

JR states that this culminated in her boys disclosing sexual assault and abuse at the hands of Johnson, who had been their school principal, "godfather" and a very trusted family friend. JR states that upon learning about what had happened certain circumstances and behaviors that seemed unexplainable now made sense. She also states that she is concerned because she is aware that "lots of kids," mainly boys would go over to Johnson's house, including some of her sons' friends.

JR states that she is very concerned for her son RBB/Victim #3 because he had the most contact with Johnson and that he is a "very sensitive person" and has been "suffering from panic attacks."

As to Counts #1-#2: RBB/Victim #1

Generally as RBB/Victim #1

Said police reports also contain the statement of RBB/Victim #1 (presently 16 yoa).

RBB/Victim #1 disclosed to investigators that he had recently been sexually assaulted by the above named defendant, Ronnie Johnson, at his home located at 8581 North 63rd Street in the Village of Brown Deer, Milwaukee, County, Wisconsin.

RBB/Victim #1 states that Johnson was his school principal while he attended "YLA" and was his "mentor" while growing up. RBB/Victim #1 states that Johnson would refer to himself as the "Godfather" and acted as a "father figure" and was a mentor to numerous "YLA" students. He states that Johnson allowed students to "hang out" at his residence and would talk to them about their problems.

RBB/Victim #1 states that when he was about 7 or 8 years old, he and his brothers (RBB/Victim #2 (currently 18 yoa) and RBB/Victim #3 (currently 18 yoa)) started going to Johnson's old residence in Milwaukee (unknown location). He states that when Johnson moved to his current Brown Deer address (noted above), about 8 years ago, the brothers continued to come to his residence.

RBB/Victim #1 described Johnson's current Brown Deer residence as a single story house with tan siding on N 63rd Street just south of Wabash Avenue with a basketball hoop and big grill in the driveway. He states that Johnson referred to his residence as the "Ranch." Investigators then showed RBB/Victim #1 an employment photograph of Johnson, and RBB/Victim #1 identified the photograph as being that of the above named defendant, Ronnie Johnson.

RBB/Victim #1 states that he his brothers would come over to Johnson's Brown Deer residence to "hang out." He also states that he knew that other "YLA" students also came over to Johnson's residence. RBB/Victim #1 states that Johnson had video games, a pool table and that they would hang out and watch television. Often times, he and his brothers, would ask Johnson for permission to come over to his residence and their mother allowed them to go.

RBB/Victim #1 estimated that they (he and his brothers) would come over to Johnson's house a couple times a month and that Johnson would normally pick them up. The brothers would usually spend the night at Johnson's residence. RBB/Victim #1 states that he rarely went to Johnson's house by himself when he was younger.

RBB/Victim #1 states that he recalls that when RBB/Victim #2 was about 11 years old, he stopped wanting to go over to Johnson's house, for unknown reasons. However, RBB/Victim #3 and RBB/Victim #1 continued to go over to his house. Eventually, as RBB/Victim #1 got older, he started going to Johnson's residence less and less. However, RBB/Victim #3 continued going to Johnson's residence by himself.

RBB/Victim #1 described RBB/Victim #3 as one of Johnson's "godsons," which meant he was a "favorite" of Johnson. Johnson called his favorite students "godsons." RBB/Victim #1 identified several other boys among Johnson's other "godsons" or "favorites" from "YLA" and states that Johnson had even taken one of the "favorites" on a trip to New York.

RBB/Victim #1 believed that some of Johnson's "godsons" continue to go over to Johnson's residence currently, including RBB/Victim #3.

RBB/Victim #1 states that since about March 2013, he has been speaking with Johnson more frequently through phone calls, and text messages. RBB/Victim #1 identified Johnson's cell phone number 414-XXX-XXXX. RBB/Victim #1 also started coming over to Johnson's house about twice a month to do "odd jobs" for cash (cut grass). He states that Johnson would either pick him up in his black Saab or he would take the bus. He states that he would normally spend the night, and in the morning Johnson would take him home or to school. RBB/Victim #1 states that he normally slept on a bed in the basement. In the basement was a large room with a pool table, television, a pull out couch and a bed.

Count #1: Second Degree Sexual Assault of RBB/Victim #1

RBB/Victim #1 states that he was first sexually assaulted by Johnson about two weeks ago while he, RBB/Victim #1, was 16 years of age. He states that Johnson had called RBB/Victim #1 to come over and cut the grass. He states that Johnson picked him up at home on 07-11-13 at 6:55p.m. RBB/Victim #1 then showed investigators a text he sent Johnson at 6:44pm on 07-11-13, which read, "Call when you on yo way." RBB/Victim #1 also showed investigators Johnson's reply message, which stated, "Here."

RBB/Victim #1 states that Johnson then brought him back to his (Johnson's house) (located at the above referenced address), that he cut the grass and Johnson paid him \$25 cash. He states that after midnight on 07-12-13, RBB/Victim #1 was in the basement talking to a friend, "CL" on Johnson's black IPAD. RBB/Victim #1 then showed investigators a text message, which he sent to "CL" telling her to call him at 414 XXX-XXXX (a later check showed that this phone number was a GoogleTalk number).

RBB/Victim #1 states that he was lying on his back on the bed with his feet on the ground, wearing shorts and a t-shirt, and talking to his friend when Johnson came into the basement and told RBB/Victim #1 he had to get off the phone. RBB/Victim #1 states that he did not hang up the phone and that Johnson then laid onto the bed next to him, resting his head on RBB/Victim #1's upper ribcage. Johnson then reached over and ended the phone call, on the IPAD, and told RBB/Victim #1 that he had not given Johnson a "hug." RBB/Victim #1 responded, "I'm good, and then Johnson proceeded to roll on top of RBB/Victim #1, with Johnson's legs extended off the bed. RBB/Victim #1 states that Johnson was wearing shorts and a shirt. RBB/Victim #1 states that Johnson then used his knees to force RBB/Victim #1's legs apart, while RBB/Victim #1 was trying to hold his thighs together. RBB/Victim #1 states that Johnson then told him, "Let me be in control."

RBB/Victim #1 states that he tried lifting up his torso to raise Johnson off of him and also used his hands to try and push Johnson's chest off of him. Johnson then used his forearms to push RBB/Victim #1's hands off of Johnson's chest and Johnson would collapse back down onto RBB/Victim #1's body. During this time, as RBB/Victim #1, was pushing at Johnson, Johnson kept saying "higher, harder." RBB/Victim #1 states that he could feel Johnson's erect penis against his body making contact with his clothed penis, torso and thighs, as Johnson was pushing his pubic

area against RBB/Victim #1's body. He states that he was positive that it was Johnson's erect penis that was making contact with his body and that the contact was made by use of actual force and without his consent.

RBB/Victim #1 states that he kept telling Johnson, "Come on bro, you forcing it" and thought Johnson was "enjoying it." RBB/Victim #1 estimated that this incident lasted for a couple minutes until RBB/Victim #1 was able to push Johnson off of his body. After being pushed off onto the bed, Johnson began to get up and reached over toward RBB/Victim #1. RBB/Victim #1 states that with his left hand, Johnson then grabbed his (RBB/Victim #1's) penis over his clothing, without consent, for about 2-3 seconds until RBB/Victim #1 swatted his hand away. As Johnson was grabbing RBB/Victim #1's penis, Johnson told him to "get that under control."

RBB/Victim #1 states that Johnson then walked up stairs and he (RBB/Victim #1) remained in the basement until the next morning. He states that the next morning Johnson gave him a ride home in his black Saab vehicle. He states that neither of them spoke of the incident. RBB/Victim #1 states that he did not tell anyone about the incident because Johnson was "helpful" to the family and he "wanted to forget about it."

RBB/Victim #1 also showed investigators additional text messages between him and Johnson on July 12 and 13, 2013:

10:24pm Johnson (J) - They was coming out wasn't they
RBB/Victim #1 (R) - Who was coming out where?
J - U saw them wen I was sleepin didn't u
R - What is you talking about bro

10:32pm J - They got inside me

10:38pm R- Huh? Wtf is you talm about bro

11:09pm J - (Demon photograph)
R - Bro l'm confuses

11:28pm R - *confused

11:33pm J - Possessed

11:39pm R - You were possessed by a demon
J - U saw it??

July 13

12:01am R - No

12:13am J - They back come here QUIK

RBB/Victim #1 states that he did not know what this text conversation meant but thought maybe Johnson was referring to the above described sexual assault.

RBB/Victim #1 reported that on July 16, 2013, he asked RBB/Victim #3 to come with him to Johnson's house because Johnson wanted some odd jobs done (clean yard). RBB/Victim #1 told RBB/Victim #3 that Johnson had been on some "gay shit," which made him uncomfortable. He states that RBB/Victim #3 did not want to go with; however, RBB/Victim #1 still wanted to make some money.

At 11:00pm on 07-16-13, RBB/Victim #1 went to Johnson's residence to do odd jobs. Johnson picked him up and brought him to the residence. RBB/Victim #1 had planned to spend the night at the house and do the yard work in the morning.

Counts #2: Child Enticement of RBB/Victim #1

RBB/Victim #1 states that on this occasion he was alone in the basement lying on the basement bed playing with his own cell phone shortly after midnight on 07-17-13 when Johnson came in the basement and began lecturing RBB/Victim #1 about wasting his time while at the house and then went back upstairs. He states that Johnson then sent him a series of text messages. After receiving the messages, RBB/Victim #1 went upstairs to see what Johnson wanted to speak about. Johnson was in his bedroom, which has a tan futon and a king size bed. Johnson was on the bed and RBB/Victim #1 was on the futon as they began talking about "life."

While RBB/Victim #1 was laying on the futon looking at his phone, Johnson came onto the futon and laid on top of RBB/Victim #1, who was laying on his back. Johnson then started laughing. RBB/Victim #1 told Johnson that he was again "forcing it" but Johnson continued and told RBB/Victim #1 that he needed to "take off his shorts" at which point RBB/Victim #1 pushed Johnson off of him onto the futon. Johnson then grabbed RBB/Victim #1's shorts pocket and started to pull his shorts down about 1-1 ½ inches, until RBB/Victim #1 grabbed hold of his shorts and stopped Johnson. RBB/Victim #1's penis was not exposed during the incident although he believed that Johnson's intent was to expose his penis. RBB/Victim #1 then got up and went back down into the basement. In the morning, Johnson gave RBB/Victim #1 a ride home after RBB/Victim #1 cleaned up the yard and paid him cash.

Once again, RBB/Victim #1 and Johnson did not talk about the incident and RBB/Victim #1 did not tell anyone about the incident because Johnson is well respected and he down played it by saying "nothing really happened." RBB/Victim #1 states, however, that Johnson lured him into his Johnson's room, he believes to attempt to expose his (RBB/Victim #1's) penis and possibly assault him and that he did not consent to these actions. RBB/Victim #1 was 16 years of age at the time.

RBB/Victim #1 states that during the day of July 17, 2013, he learned from RBB/Victim #3 that their brother, RBB/Victim #2 had been sexually assaulted in the past by Johnson and documented it in a journal. RBB/Victim #1 states that RBB/Victim #2 had just recently shown RBB/Victim #3 the journal entry. RBB/Victim #3 explained that RBB/Victim #2 did not want RBB/Victim #1 to know.

RBB/Victim #1 said that he wanted to make some more money, so he sent Johnson text messages on July 18 about doing more odd jobs.

RBB/Victim #1 states that he intended to go cut the grass to get the money and to confront Johnson about RBB/Victim #2's journal. RBB/Victim #1 took the bus to Johnson's residence and was thinking about how to approach the subject with Johnson. He states that at about the same time he arrived at Johnson's, his step-father also arrived at Johnson's residence, as he and Johnson are coworkers and friends.

RBB/Victim #1 states that he did not confront Johnson while his step-father was at the residence and just cut the grass. RBB/Victim #1 remained at Johnson's residence alone with Johnson and was in the basement and was talking on his cell phone to his friend, "CL," at about 3:00am on 07-21-13 when Johnson came into the basement and told him to get off the phone.

RBB/Victim #1 states that he refused to get off the phone because he was afraid that Johnson would attempt to assault him again. RBB/Victim #1 states that he did not get off the phone and told Johnson he was leaving. He then left Johnson's residence and walked home to his residence. As RBB/Victim #1 left, he got a text message from Johnson at 3:19am on 07-21-13 which stated, "Lol this guy exits at 3:11...UUSon, come back to the flat," and "Bro...UYOU FORCING IT HARDULMAO".

RBB/Victim #1 did not reply to Johnson and walked all the way home to his residence (2426 N 11th St) arriving home around 5:30am. RBB/Victim #1 planned on having no further contact with Johnson. Rashad received additional text messages from Johnson but did not reply.

RBB/Victim #1 states that late at night on 07-22-13, Johnson called his step-father and asked to speak with RBB/Victim #1. RBB/Victim #1 refused to speak with Johnson. A short time later, RBB/Victim #3 received a text message from Johnson saying that he was outside their house. RBB/Victim #1 then went outside to confront Johnson about RBB/Victim #2's journal. RBB/Victim #1 went outside, found Johnson in his vehicle and got into the vehicle.

RBB/Victim #1 then asked Johnson why he thought RBB/Victim #2 stopped coming over to his house as a child. RBB/Victim #1 states that Johnson then began breathing heavily and did not respond. RBB/Victim #1 told Johnson that RBB/Victim #2 had told RBB/Victim #3 that Johnson sexually assaulted him. Johnson said RBB/Victim #2 "was lying." RBB/Victim #1 states that he also called RBB/Victim #2 on the phone who confirmed that the assault happened. RBB/Victim #1 then got out of Johnson's vehicle and was yelling for him to get away from their house. As Johnson began to drive away, Johnson asked RBB/Victim #1 to come over tomorrow to let the cleaning service in and that he would pay him \$70. RBB/Victim #1 yelled "no" at Johnson and Johnson drove off.

RBB/Victim #1 and RBB/Victim #3 then walked away from their house because they did not know how their parents would react to the information as Johnson is a family friend. He states that they went to their Aunt Nicole's house but somehow, their father, RK, found out where they were there and came to pick them up.

RBB/Victim #1 then told their father, R.K, about RBB/Victim #2's journal, and that he had been assaulted. Shortly thereafter both RBB/Victim #1 and RBB/Victim #3 told their father that Johnson had sexually assaulted them.

RBB/Victim #1 states that he is not aware of anyone other than him and his brothers that had been sexually assaulted by Johnson; however, RBB/Victim #1 expressed concern that some of Johnson's other "godsons" may have also been victims as they were frequently with Johnson.

As to Counts #3-#4: RBB/Victim #2

Generally as to RBB/Victim #2

Said police reports also contain the statement of RBB/Victim #2 (presently 18 yo).

RBB/Victim #2 disclosed to investigators that he had been sexually assaulted by the above named defendant, Ronnie Johnson, at his then home located at an unknown location in the City of Milwaukee, Milwaukee County, Wisconsin.

RBB/Victim #2, who is currently 18 years old, also reported a sexual assault by his former school principal at Young Leaders Academy, the above named defendant, Ronnie Johnson. RBB/Victim #2 also described Johnson as a mentor, support system and father figure. Investigators also showed RBB/Victim #2 an employment photograph of Johnson which RBB/Victim #2 identified as being that of Johnson. RBB/Victim #2 also states that Johnson called himself the "Godfather" and his residence, the "Ranch."

RBB/Victim #2 states that he met Johnson when his brother, RBB/Victim #1, started going to "YLA" in the 1st grade. He states that he and his brother RBB/Victim #3 started going to the school there in 4th or 5th grade through 8th grade. RBB/Victim #2 states that Johnson was the "YLA" principal the entire time he attended the school.

RBB/Victim #2 did not remember how he and his brothers started going over to Johnson's residence but recalls that he was 7 or 8 years old when he and his brothers started going over to Johnson's residence in Milwaukee. Johnson had a pool table, video games, and they would watch television. Johnson had food for them and he treated them like they were his kids. Johnson would bring the brothers over to the house. Some nights, they would stay over at Johnson's residence and other times they would go home. RBB/Victim #2 estimated that they went over to his residence about 2 days a week.

Counts #3-#4: First Degree Sexual Assault of a Child: RBB/Victim #2

RBB/Victim #2 states that Johnson assaulted him when he was 7 or 8 years old within about a year of RBB/Victim #2 starting to go over to Johnson's residence. He states that this assault occurred at Johnson's old residence and did not recall the address but believed that it was near Roosevelt Dr. in the city of Milwaukee. (On information and belief located at 4044 N. Elmhurst in the City of Milwaukee.)

At nighttime, RBB/Victim #2 was in Johnson's bedroom with his brothers watching television. The brothers went downstairs to play pool, but RBB/Victim #2 remained in the bedroom with Johnson. He states that both he and Johnson were clothed in "pajama type clothing." RBB/Victim #2 states that Johnson then told him to come lay in the bed by him. RBB/Victim #2 states that he went in the bed and was lying on his back and Johnson was lying next to him. RBB/Victim #2 indicates that Johnson was to the right of him in the bed. RBB/Victim #2 states that Johnson then told him, "I want you to know that you're my favorite twin. You have a gift." RBB/Victim #2 states that he and Johnson were under the covers during this incident.

RBB/Victim #2 states that Johnson did "sexual things" to him and that Johnson told RBB/Victim #2 that he could not tell anyone about the incident. RBB/Victim #2 states that Johnson used his bare hands to massage RBB/Victim #2's shoulder and arms underneath his clothing.

Count #3

RBB/Victim #2 states that Johnson then put his hand down his (RBB/Victim #2's) clothing and began *touching his (RBB/Victim #2's) penis and testicles*. He states that Johnson "caressed" his penis and testicles and then pulled down his pants. RBB/Victim #2 states that Johnson then removed his own pants, so that Johnson's genitalia were also exposed. RBB/Victim #2 states that he did not know if Johnson had an erection or if he removed his pants completely.

Count #4

RBB/Victim #2 states that Johnson then told him to lie on his side and RBB/Victim #2 rolled over onto his left side (which he demonstrated during the interview). He states that Johnson laid behind him and then placed his penis in between RBB/Victim #2's "butt cheeks" and was *rubbing his penis against RBB/Victim #2's "butt cheeks."* He states that he does not believe that Johnson inserted his penis into his anus. Eventually, Johnson stopped these actions as RBB/Victim #2's brothers were coming upstairs. He states that Johnson was still lying next to him and they both were still under the covers. RBB/Victim #2 states that he did not believe that Johnson ejaculated during the incident. RBB/Victim #2 remembers falling asleep, waking up the next day, eating breakfast and going home.

RBB/Victim #2 states that he did not say anything during the incident and did not tell anyone about this incident at the time.

RBB/Victim #2 states that he was 11 or 12 when he stopped going over to Johnson's because he did not like his "lectures." Also when RBB/Victim #2 was in 7th or 8th grade, he reported having a "flashback," to the incident and at the time he was very stressed. RBB/Victim #2 reported that at this time, he wrote about the assault in his journal. RBB/Victim #2 had the journal with him during the police interview. RBB/Victim #2 said that he had had the journal since 7th or 8th grade.

RBB/Victim #2 showed investigators the journal entry. The journal was seized as evidence and placed on inventory. The entry was not dated, and stated:

Took a nap. That one dream is back in my life again. The memory that I want to forget, the day my brothers left (young age) 7ish/8 and I was told come here, as I climbed in the bed, he began to hug and rub on me, saying you are my fav (sic) twin. Don't ever tell anyone I told you that or about this. Wrapping me in his arms beginning to kiss my neck. The man that made me feel the way I do today, reason why I have so much hatred (sic) towards but still respect for some reason. I fail to understand it because I was so young but looking back it's a memory I will never forget.

RBB/Victim #2 states that he did not include Johnson's name because he did not want anyone to know who he was talking about. Officer Fus asked if Johnson had kissed RBB/Victim #2's neck during the incident as it was written in the entry and RBB/Victim #2 said yes.

RBB/Victim #2 states that he went back to Johnson's residence in 8th grade for a party for a friend and another of Johnson's "godsons" or "favorites," but that there were numerous kids at the party. Since the party, RBB/Victim #2 did not go to Johnson's residence in Brown Deer until his junior and senior year of High School to complete college information. RBB/Victim #2 had gone with his brother RBB/Victim #3 and his father. RBB/Victim #2 used Johnson's desktop computer in the basement and RBB/Victim #3 used a laptop while at the residence.

RBB/Victim #2 states that RBB/Victim #1 had within the last month started going over to Johnson's residence and that RBB/Victim #1 told him that he was going over there for "jobs," but RBB/Victim #2 did not know exactly what RBB/Victim #1 was doing.

RBB/Victim #2 states that RBB/Victim #3 had a closer relationship with Johnson and that he was always over at Johnson's residence. RBB/Victim #2 did not know exactly what RBB/Victim #3 did while at Johnson's. He states that RBB/Victim #3 still went over to Johnson's residence while they were in high school. RBB/Victim #2 said that Johnson treated RBB/Victim #3 like he was "his child."

RBB/Victim #2 states that he did not remember exactly when, but recalled asking RBB/Victim #3 where RBB/Victim #1 was. He states that RBB/Victim #3 told him that RBB/Victim #1 was at Johnson's house. RBB/Victim #2 states that RBB/Victim #3 then said something about Johnson being "weird;" however, RBB/Victim #2 could not recall the exact phrase. RBB/Victim #2 states that he had told RBB/Victim #3 that he thought he knew what RBB/Victim #3 was talking about. RBB/Victim #2 states that it was at this time that he then took out his journal and read his entry about the sexual assault. RBB/Victim #2 said that he just read the entry and told RBB/Victim #3 that the entry was the reason he did not like spending time with Johnson. He states that RBB/Victim #3 then began crying and told him that Johnson had also touched him; however, RBB/Victim #3 did not provide any details.

Then on the night of July 22, 2013, while RBB/Victim #2 was in Chicago for college orientation, RBB/Victim #1 spoke with him on the phone, told him that RBB/Victim #3 told RBB/Victim #1 about Johnson sexually assaulting RBB/Victim #2 when he was a little kid and asked if it was true. RBB/Victim #1 then told RBB/Victim #2 that Johnson had tried to be on some "gay shit" with him as well.

RBB/Victim #2 states that he told RBB/Victim #1 that it was in fact true and RBB/Victim #1 was upset. RBB/Victim #2 then called their father and told him to go pick up RBB/Victim #3 and RBB/Victim #1 from Johnson's but he did not tell his father what was going on. RBB/Victim #2 said he went to bed and did not know exactly what happened during the night and the next day he eventually came back to town.

Although RBB/Victim #2 did not report viewing any pornography at Johnson's residence, he said that when he was in 8th grade, RBB/Victim #3 and two other students had found a "fake vagina" sex toy in the basement in the computer room in the corner behind something.

RBB/Victim #2 confirmed that at the conclusion of his interview with investigators that during the sexual assaults he described as happening when he was 7 or 8 Johnson had pulled off RBB/Victim #2's clothing including his pants and underwear, so that RBB/Victim #2 was nude from the waist down. RBB/Victim #2 also confirmed that during the assault, Johnson's groping of his genitals and Johnson's penis sexual contact was with RBB/Victim #2's buttocks and that it was skin-to-skin contact.

As to Counts #5-#14: RBB/Victim #3

Generally as to RBB/Victim #3

Said police reports also contain the statement of RBB/Victim #3 (presently 18 yoa).

RBB/Victim #3 disclosed to investigators that he had been sexually assaulted by his mentor and former school principal at "Young Leaders Academy" (YLA), the above named defendant, Ronnie Johnson.

RBB/Victim #3 states that he met Johnson through "YLA" and has known him for 11 years. RBB/Victim #3 explained that Johnson played a fatherly role for him and several other "YLA" students. Johnson called himself the "Godfather," and called the students he mentored his "godsons." Johnson mentored them, lectured them, and helped them prepare for college as they got older. RBB/Victim #3 states that Johnson also mentored some of his close friends/classmates including: "***" (now 17 yoa), "***" (now 18 yoa), and "***" (now 15 yoa).

RBB/Victim #3 states that Johnson lives in Brown Deer. RBB/Victim #3 did not know Johnson's exact address, but described the residence as being located on N 63rd St, just south of W Wabash Ave on the west side of the street. The residence is a single family ranch with red/burgundy brick and a stand alone basketball hoop on the right side of the driveway. RBB/Victim #3 reported that all incidents occurred at Johnson's residence in Brown Deer. Investigators then showed RBB/Victim #3 an employment photograph of Johnson, and RBB/Victim #3 identified the photograph as being that of Johnson.

RBB/Victim #3 states that he and his two brothers have been coming over to Johnson's residence in Brown Deer to "hang out" for about nine years. RBB/Victim #3 states that at the start the brothers would ask to go over to Johnson's residence because their friends also went over to his residence. He states that in the beginning all brothers went over to Johnson's house together. Johnson would normally pick them up in his car and bring them back to the residence. Most of the time, it was just the brothers at the residence with Johnson. On occasion, the other friends would also be over at the same time. Johnson called his residence the "Ranch," and it was a place for them to hang out and play video games, basketball, pool and watch movies. Johnson always has food/soda at his residence for them.

RBB/Victim #3 states that the brothers would go to Johnson's residence about 2-3 times a week and they would sleep over almost every time. The frequency and fact that the brothers all went to Johnson's residence together remained consistent until about Middle School. He states that RBB/Victim #2 stopped going over to Johnson's residence in Middle School.

RBB/Victim #3 did not report receiving any gifts from Johnson, but noted that during Middle School, Johnson would take him out to lunch. Johnson also told RBB/Victim #3 that he wished he were his "real son."

During Middle School, RBB/Victim #1 also stopped talking to Johnson; however, RBB/Victim #3 continued talking to Johnson and began going over to his residence by himself. RBB/Victim #3

continued to go to Johnson's residence about 2-3 times a week including through high school. RBB/Victim #3 states that he would usually go by himself, but occasionally the other mentioned friends would come over. Johnson would normally pick him up and RBB/Victim #3 would stay overnight.

RBB/Victim #3 states that when he went over to Johnson's residence to spend the night, he would sleep either in Johnson's bedroom or in Johnson's spare bedroom. He states that in Johnson's room there is a king size bed where Johnson would sleep, and a tan futon, which is where RBB/Victim #3 would sleep. There is also a bathroom in the bedroom. RBB/Victim #3 states that he and Johnson both would sleep in basketball shorts and t-shirts. RBB/Victim #3 would shower at the residence and would bring his own clothing/supplies with him.

RBB/Victim #3 would also do odd jobs for Johnson like cutting the grass, folding clothes, cleaning the house and shoveling snow. Johnson would pay him cash. Johnson also gave RBB/Victim #3 a cell phone and began paying for the bill about 2 years ago in exchange for cutting his grass. RBB/Victim #3 had the phone and Johnson was paying for the bill until about March 2012. RBB/Victim #3 states that he no longer has the phone and Johnson is no longer paying for his cell phone. RBB/Victim #3 did not remember the phone number.

RBB/Victim #3 states that he also would frequently talk with Johnson on the phone. RBB/Victim #3 provided Johnson's cell phone numbers: 233-8173 and 759-3533.

RBB/Victim #3 recalls that he thought that it was about Thursday (July 18th) when RBB/Victim #1 asked him to go over to Johnson's house because Johnson was acting "gay." RBB/Victim #3 said "no;" however, RBB/Victim #1 still went to Johnson's house. Later, RBB/Victim #3 told RBB/Victim #2 "people be acting gay." RBB/Victim #2 asked if it was Johnson and RBB/Victim #3 said yes.

RBB/Victim #3 states that RBB/Victim #2 then showed him his "Twilight" movie themed journal, which he had since about 7th grade. RBB/Victim #2 read an entry about how Johnson had been a supportive person for him until he sexually assaulted him. RBB/Victim #3 states that RBB/Victim #2 was crying and provided no specifics. RBB/Victim #3 then told RBB/Victim #2 "*everything that had happened,*" between him and Johnson.

At this point, investigators asked RBB/Victim #3 what he told RBB/Victim #2, but before answering RBB/Victim #3 looked away and started crying again. RBB/Victim #3 went on to state that he had said he to RBB/Victim #2 that ever since he was little, Johnson would continuously touch on him, lay on him while he was sleeping and grab his private areas.

RBB/Victim #3 reported that all the assaults by Johnson had occurred at Johnson's residence in Brown Deer.

Counts #5-#6: First Degree Sexual Assault of a Child: RBB/Victim #3

RBB/Victim #3 states that the first time he was sexually assaulted by Johnson was sometime in 2005 or 2006 when he was in the 5th grade and would have been 10 or 11 years old. RBB/Victim #3 had gone to Johnson's residence in Brown Deer with his brothers, RBB/Victim #2 and RBB/Victim #1. The brothers spent the night at Johnson's residence and slept together on a futon in Johnson's bedroom, while Johnson slept on the king size bed in the same bedroom. At some point during the night, Johnson woke up RBB/Victim #3 and told him to sleep in Johnson's bed. RBB/Victim #3 went into Johnson's bed and fell asleep. RBB/Victim #3 then woke up to Johnson on top of him. Both RBB/Victim #3 and Johnson were clothed wearing "sleeping clothes." RBB/Victim #3 was lying on his back and Johnson was lying on top of him with his body parallel to RBB/Victim #3's in the missionary position. *Johnson then grabbed RBB/Victim #3's buttocks over his clothing. Johnson then "bear hugged" him. RBB/Victim #3 states that he felt that Johnson's penis was erect and could feel Johnson's penis making contact with his (RBB/Victim #3's) body. He states that Johnson then began "moving up and down" on his torso in a humping and thrusting action for approximately 8*

minutes. Johnson then rolled off of RBB/Victim #3 and left the room. RBB/Victim #3 states that he did not know if Johnson ejaculated.

RBB/Victim #3 and Johnson did not speak during the incident. RBB/Victim #3 remembered that the next morning Johnson took them all home. RBB/Victim #3 and Johnson never talked about the incident. RBB/Victim #3 did not tell anyone about the incident. RBB/Victim #3 did not go back to the residence for several weeks, but returned because it was a "fun place to be."

Count #7: Repeated Sexual Assault of Same Child (Contact): RBB/Victim #3

RBB/Victim #3 next reported that at least three times between 2007 and 2010 (when RBB/Victim #3 was between 12-15 yoa) RBB/Victim #3 was at Johnson's residence when Johnson groped Ryan's pubic area or attempted to "grope" his genitals. RBB/Victim #3 described the incidents as follows, stating that they had all happened the same way and he did not remember each specific incident. He states that Johnson would sit next to him in the living room, both fully clothed, as they talked. RBB/Victim #3 states that Johnson would "try to be slick about it." He states that Johnson would tell him "I love you," and would ask why RBB/Victim #3 was not saying it back. RBB/Victim #3 states that he would not respond. He states that Johnson would then reach his hand over and slide his hand underneath his underwear/shorts and would touch his pubic area under his clothes (specifically the pubic mount at the top of the penis). RBB/Victim #3 would then push Johnson's hand away, therefore Johnson would not make contact with the shaft of RBB/Victim #3's penis or his testicles. He states that Johnson would then act like "nothing had occurred" and continued talking. RBB/Victim #3 ignored Johnson's actions and did not say anything to him. RBB/Victim #3 never reported these acts when they were occurring.

RBB/Victim #3 also reports that at least three times between 2007 and 2010 (when he was between the ages of 12 and 15), RBB/Victim #3 was at Johnson's residence when Johnson committed additional assaults. During these incidents, RBB/Victim #3 was in Johnson's bedroom, either talking to Johnson or watching television. RBB/Victim #3 would be laying on his stomach on the futon in Johnson's bedroom. Johnson would approach RBB/Victim #3 and would lay on RBB/Victim #3's back, so that Johnson's pubic area was against RBB/Victim #3's buttocks. During the incidents, both Johnson and RBB/Victim #3 were fully clothed. While lying on top of RBB/Victim #3, Johnson would rub his genitals against RBB/Victim #3's buttocks by moving his body back and forth for a short period of time. RBB/Victim #3 did not know if Johnson had an erection during these incidents but surmised that Johnson's movement was in an attempt to achieve an erection. During the incidents, Johnson would "lecture" RBB/Victim #3. RBB/Victim #3 did not say anything during the incidents. Johnson would eventually stop, get off of RBB/Victim #3 after about 4 minutes and would act as though nothing happened.

Counts #8-#9: Second Degree Sexual Assault of Unconscious Victim and Exposing Genitals of a Child: RBB/Victim #3

RBB/Victim #3 then went on to report about another sexual assault perpetrated against him by Johnson and again began crying and looking away from the interviewing officer. RBB/Victim #3 reported that sometime in September 2012, when he was 17 years of age, he was at Johnson's residence alone to get help with a college application. At the time, RBB/Victim #3 was alone and had been picked up by Johnson. While at Johnson's residence, Johnson engaged in a sexual conversation with RBB/Victim #3, asking RBB/Victim #3 if he had sexual contact with girls. RBB/Victim #3 said no and felt uncomfortable.

Later that night, RBB/Victim #3 went to bed and slept in Johnson's bedroom on the tan futon, which had a tan futon mattress. RBB/Victim #3 explained that there was normally a tan colored comforter folded up on the futon that he would use to sleep. RBB/Victim #3 states that he slept wearing basketball shorts, boxer briefs and a t-shirt. Johnson slept in the king size bed in the same room. Johnson was wearing a t-shirt and basketball shorts. RBB/Victim #3 states that he was lying on his stomach on the futon, *when he awoke to Johnson lying on top of his back, with the comforter removed.*

Johnson reached his hands underneath RBB/Victim #3's body – initiating this contact while RBB/Victim #3 was initially asleep or “unconscious” and began grabbing RBB/Victim #3's penis over his clothing and was stroking it. Johnson then reached underneath RBB/Victim #3's clothing and began grabbing his nude penis. RBB/Victim #3 tried to brush Johnson off his back, but was unsuccessful. Eventually, Johnson let go of RBB/Victim #3's penis, rolled RBB/Victim #3 over onto his back and pulled off RBB/Victim #3's shorts and underwear, exposing his penis. Johnson then used a small rectangular tan futon pillow to cover RBB/Victim #3's face during the incident. RBB/Victim #3 said that the pillow matched the futon cover. RBB/Victim #3 then showed interviewing officers with his hands that the pillow was about 12 inches by 8 inches. Johnson only placed the pillow on RBB/Victim #3's face, but did not hold it against his face. RBB/Victim #3 said that he (RBB/Victim #3) then held onto the pillow to keep his face covered, because he did not want to see Johnson.

Count #10: Third Degree Sexual Assault (Penis to Mouth Intercourse): RBB/Victim #3

Johnson then put his mouth on RBB/Victim #3's penis and began “sucking” his penis without consent. RBB/Victim #3's penis was semi-erect. Johnson told RBB/Victim #3, “This is what girls are going to do to you”. Johnson then grabbed RBB/Victim #3's hands and put them on Johnson's head. RBB/Victim #3 then tried to push Johnson's head off his penis, but Johnson continued to suck on his penis. RBB/Victim #3 said his penis was semi-erect and that he did not ejaculate.

Counts #11-#12: Second Degree Sexual Assault Use of Force and Exposing Genitals to a Child: RBB/Victim #3

After about 5 minutes of the assault, Johnson stopped and took off his shorts and shirt and was now nude with his penis exposed. Johnson laid his nude body on top of RBB/Victim #3, as he continued to lie on his back. RBB/Victim #3 felt Johnson's erect penis touching his body. RBB/Victim #3 felt Johnson's “force” on top of him and explained that Johnson's weight was on top of him and that Johnson began “thrusting” and “humping.”

Johnson then rolled RBB/Victim #3 over onto his stomach and laid his nude body on top of RBB/Victim #3's backside. He then felt Johnson insert his erect penis in the opening between his upper thighs (not into buttocks). Johnson began thrusting so that his erect penis moved up and down between RBB/Victim #3's thighs. Johnson then removed his penis from between RBB/Victim #3's legs and placed it on his buttocks. Johnson continued to “hump” and rub his penis against RBB/Victim #3's buttocks. Johnson then ejaculated onto his back, as he felt a wet substance on his lower back. Johnson then used a towel to wipe the wet substance off his (RBB/Victim #3's) back. He states that he did not know where Johnson got the towel and could not describe it.

Johnson then got up and walked to a nightstand, which was to the right of the king size bed. Johnson opened the nightstand drawer and brought back a condom. RBB/Victim #3 was now lying on his back on the futon, with only his t-shirt on. Johnson then stroked RBB/Victim #3's penis until it was erect and put a condom on his penis. RBB/Victim #3 pulled his t-shirt over his head and was crying, so he could not describe the condom. RBB/Victim #3 said that he was scared and did not want Johnson to see him crying.

After putting the condom on RBB/Victim #3's penis, Johnson laid on top of RBB/Victim #3, in the missionary position. Johnson put RBB/Victim #3's penis between Johnson's upper thighs and Johnson began moving his thighs up/down on RBB/Victim #3's penis. Johnson told RBB/Victim #3, “It's taking you a long time. Girls will love this.” Johnson then got off of RBB/Victim #3 and while next to RBB/Victim #3, Johnson began stroking his penis, which still had on the condom.

As Johnson was stroking RBB/Victim #3's penis, RBB/Victim #3 would try to move and get up, but Johnson would just grip his penis tighter. Johnson continued to stroke RBB/Victim #3's penis for about 6-7 minutes until RBB/Victim #3 eventually ejaculated into the condom. After ejaculating into the condom, Johnson removed the condom from RBB/Victim #3's penis. Johnson then put

RBB/Victim #3's underwear and shorts back on him. Johnson walked into the bathroom, while RBB/Victim #3 remained laying on the futon. Johnson exited the bathroom and went into the king size bed. RBB/Victim #3 then got up a short time later and went into the bathroom and washed himself up.

RBB/Victim #3 then slept on the futon. During the incident, RBB/Victim #3 never said anything but by the way he was crying and covering his head and at times, although he “froze” given his demeanor, the force used at times, and the totality of the circumstances, there was no reason for the defendant to believe consent he was freely “consenting” and he in fact was not consenting and was compelled through use of force (holding penis tight when he tried to move – use of the weight of his body as force).

After the incident, RBB/Victim #3 and Johnson did not speak about what had happened. The next day, Johnson gave RBB/Victim #3 a ride to school or home. RBB/Victim #3 did not consent to these actions and did not tell anyone about the incident. RBB/Victim #3 did not return to Johnson's house for several weeks, and could not explain why he continued to return.

RBB/Victim #3 next described another sexual encounter that occurred when he was 17 years of age. Sometime after September 2012 and before November 2012, RBB/Victim #3 was at Johnson's house alone and spent the night after getting help with college paperwork. After taking a shower, RBB/Victim #3 was in Johnson's bedroom changing and was nude when Johnson came into the room. Johnson used his cell phone and took photographs of RBB/Victim #3 nude without telling RBB/Victim #3 that he was taking the photographs. Johnson asked RBB/Victim #3 if he wanted to see the photographs and showed RBB/Victim #3 the photographs, which consisted of a nude photograph of RBB/Victim #3's buttock and a nude photograph of RBB/Victim #3's pubic area, including RBB/Victim #3's nude penis. When asked, RBB/Victim #3 did not remember how close up/zoomed in the photographs were. At the time, RBB/Victim #3 was 17 years old. RBB/Victim #3 did not give Johnson consent to take the photographs. RBB/Victim #3 asked Johnson if he was going to delete the photographs and Johnson never replied.

Counts #13-#14: Third Degree Sexual Assault and Exposing Genitals of a Child: RBB/Victim #3

RBB/Victim #3 reported that around November 2012, at the age of 17, RBB/Victim #3 returned to Johnson's residence at the urging of his mother, so Johnson could assist with college preparation. RBB/Victim #3 was at Johnson's house alone and spent the night. RBB/Victim #3 slept in the spare bedroom, which is next to Johnson's bedroom. RBB/Victim #3 woke up on his back with Johnson next to him, attempting to pull down RBB/Victim #3's shorts and underwear. Johnson pulled RBB/Victim #3's basketball shorts down – exposing his penis - and put his mouth on RBB/Victim #3's penis. Johnson began sucking on RBB/Victim #3's penis. Johnson had a cell phone in his hands and appeared to be attempting to record the incident or take a photograph. RBB/Victim #3 told Johnson to “get off” of him and slapped the cell phone away from Johnson. Johnson stopped sucking RBB/Victim #3's penis, and said “if you don't want it to happen, all you have to do is say no or stop.” Johnson then walked out of the room.

RBB/Victim #3 did not give Johnson permission or consent to commit these acts. RBB/Victim #3 estimated that the incident lasted about a total of 3 minutes. RBB/Victim #3 was unsure if the incident was actually recorded on Johnson's cell phone. RBB/Victim #3 went to sleep and in the morning, Johnson took him to school. RBB/Victim #3 and Johnson never talked about the incident and RBB/Victim #3 did not tell anyone. After the incident, RBB/Victim #3 did not come back over to Johnson's residence until after his birthday.

RBB/Victim #3 reported that in January 2013, he received a random phone call from Johnson. Johnson told RBB/Victim #3 that he still loved him and that their relationship was “complicated.” RBB/Victim #3 did not respond and only listened to Johnson talk.

RBB/Victim #3 reported that sometime in spring of 2013, Johnson made arrangements by phone with him to help him finish college paperwork and take him on a shopping spree to purchase new clothing. Johnson told RBB/Victim #3 to bring some old clothing with him. Johnson picked RBB/Victim #3 up at his house and RBB/Victim #3 gave several of his old clothing items, including Ralph Lauren Polo shirts and a pair of black faded Levis Jeans (size 32x32 or 32x34), to Johnson. RBB/Victim #3 said that these items were eventually put inside Johnson's residence, but RBB/Victim #3 did not know what Johnson was going to do with the clothing or if he still had them.

RBB/Victim #3 and Johnson then went into the Brown Deer Walgreens (60th/Brown Deer Rd). Johnson purchased a \$250 Prepaid Visa Card and paid for it with a check. Johnson gave the card to RBB/Victim #3 and told him that he needed to use the money to replace his old clothing. RBB/Victim #3 would be allowed to keep whatever money was left after he purchased his clothing. Johnson told him it was "a lesson in money management." Johnson and RBB/Victim #3 drove out to Brookfield Square, where they went shopping at a Target, JcPennys and other unknown stores. During the shopping spree, RBB/Victim #3 purchased about 8 shirts, 4-5 pants and a pair of shoes. That evening, Johnson and RBB/Victim #3 returned to Johnson's residence.

Additional Sexually Assaultive Conduct Against RBB/Victim #3

At night, RBB/Victim #3 went to bed on the same futon in Johnson's room, wearing basketball shorts and a t-shirt. Again, RBB/Victim #3 awoke while on his back to Johnson next to him. Johnson pulled RBB/Victim #3's shorts and underwear off and rolled RBB/Victim #3 onto his side. Johnson said, "Did you miss me? You going to act like you miss me." Johnson then rolled RBB/Victim #3 to his back and put his mouth on RBB/Victim #3's penis and began sucking. RBB/Victim #3 pulled his t-shirt over his face and Johnson grabbed RBB/Victim #3's hands and put them on Johnson's head. RBB/Victim #3's penis started to become erect during this incident, which lasted for about 7 minutes. RBB/Victim #3 pushed Johnson's head away from his penis and Johnson stopped sucking on RBB/Victim #3's penis. RBB/Victim #3 did not ejaculate. Johnson then took off his shirt and shorts and laid his nude body on top of RBB/Victim #3, who was wearing only a t-shirt. RBB/Victim #3 was still lying on his back when Johnson began "humping" on top of RBB/Victim #3, in the missionary position. Johnson then rolled RBB/Victim #3 over onto his stomach. RBB/Victim #3 said Johnson then laid on top of him and inserted his penis between the back of RBB/Victim #3's upper thighs (not into anus or between buttocks). Johnson then began thrusting so that Johnson's penis moved up and down between the back of RBB/Victim #3's thighs. After a short time, Johnson stopped the thrusting movement and then RBB/Victim #3 felt a wet substance on his lower back. Johnson then used a towel to wipe off RBB/Victim #3's back. Again RBB/Victim #3 could not describe the towel or where it came from.

Johnson then got up and walked to the same nightstand, which was to the right of the king size bed. Johnson opened the nightstand drawer and brought back a condom. RBB/Victim #3 was now lying on his back on the futon, with only his t-shirt on. Johnson then put the condom on RBB/Victim #3's penis and then put Vaseline from a Vaseline container onto the condom, which was on his penis. RBB/Victim #3 believed that the container of Vaseline had been on the floor next to the futon, but did not recall the size of the container. Johnson then straddled RBB/Victim #3's torso, so that Johnson was facing RBB/Victim #3. Johnson grabbed hold of RBB/Victim #3's penis and "put it in." Johnson inserted RBB/Victim #3's penis into Johnson's anus and Johnson sat down on RBB/Victim #3's penis. Johnson then "rode" RBB/Victim #3's penis for a couple minutes. RBB/Victim #3 did not ejaculate and Johnson stopped.

Johnson got off of RBB/Victim #3 and then began stroking and "jacking" RBB/Victim #3's penis for a couple more minutes, which still had the condom on. RBB/Victim #3 did not ejaculate and Johnson stopped his actions. Johnson took the condom off of RBB/Victim #3 and put his shorts/underwear back on and Johnson went into the bathroom. Johnson went to bed and RBB/Victim #3 later went into the bathroom to wash himself. RBB/Victim #3 then slept on the futon.

RBB/Victim #3 did not say anything to Johnson during the sexual encounter as he was in “shock” but RBB/Victim #3 did not give consent for the contact. RBB/Victim #3 did not consent to Johnson’s actions and said he had “no choices,” that he panicked and that Johnson was bigger than him.

The next morning, Johnson took RBB/Victim #3 to school and RBB/Victim #3 told Johnson that he did not want to talk to him. RBB/Victim #3 had not been back to his residence since.

RBB/Victim #3 reported receiving a text message from Johnson on the night of 07-22-13, stating that he was outside of their house, for an unknown reason. RBB/Victim #3 said that he knew RBB/Victim #1 had recently been over to Johnson’s residence. RBB/Victim #3 told RBB/Victim #1 about the message and RBB/Victim #1 went out to confront Johnson about the journal. RBB/Victim #3 came back into the house, was mad, so they started walking. RBB/Victim #1 told RBB/Victim #3 that Johnson had assaulted him as well. RBB/Victim #3 and RBB/Victim #1 went to their aunt’s house, where their father eventually picked them up and brought them back to their home (mother’s). RBB/Victim #3 then told them that Johnson had been assaulting him.

Additional Information

Johnson’s Milwaukee Residence

After the interviews of the three boys, investigators inquired of their stepfather as what Johnson’s address was before living in Brown Deer. The stepfather states that Johnson previously lived at the above referenced address of 4044 N. Elmhurst in the City of Milwaukee. He described the residence as an upper/lower duplex and that Johnson lived in the lower unit. Johnson lived at the residence from at least 1991 until he moved to Brown Deer. The boy’s stepfather indicates that he was aware that Johnson had taken in a boy by initials “DG” (now about 33 yo), who lived with Johnson at this old residence from the time “DG” was in 6th grade through High School. The stepfather explained that Johnson had purportedly “taken” “DG” in and “allowed” him to live with him (Johnson).

“Young Leaders Academy” or “YLA” Information

Investigators further note that the “Young Leaders Academy” (YLA) website indicates that “YLA” is a public charter school on the YMCA North side Campus located at 1350 W North Avenue in the City of Milwaukee. “YLA” was established in 2002 with grades K4-8th grade.

Execution of Search Warrant and Seizure of Evidence

The following is an excerpt from the list of items law enforcement seized during execution of the search warrant:

Master Bedroom

I photographed the entry door frame which had hand written lines, dates and letters, which appeared to be height markers. On a jewelry stand next to the door, I recovered a black wallet, containing Johnson’s drivers license and Johnson’s checkbook.

On the queen size bed, I recovered an HTC cellular phone, a Sprint black iPhone, a silver MacBook laptop, and a greenish hand towel. When illuminated with an alternate light source, a possible biological stain fluoresced.

I recovered two Trojan condoms and a YLA pin, which were in a jewelry box on top of the nightstand, which was to the right of the bed. In the top right dresser drawer of the same nightstand, I recovered various YLA graduation programs.

There was a futon located at the foot of the bed. The futon had a black metal frame with two futon pad mattress. I recovered a small rectangular tan pillow and a tan colored comforter, that was folded on the futon.

The bottom futon mattress was tan in color and the top futon mattress was a black and tan colored pattern. The top black/tan patterned futon cover was removed and collected.

When the bottom tan futon mattress was illuminated with an alternate light source, two possible biological stains fluoresced. I recovered a swatch of each stain by cutting out the area that had fluoresced. I also removed and collected the tan futon cover from the mattress.

When I removed the tan futon cover, I found that the mattress had another black futon cover on it. I observed a visible whitish colored small stain on the black cover. I cut out and collected a swatch of the black futon cover, which contained the stain. I also removed and collected the black futon cover.

I recovered an envelope addressed to "Ron Johnson The Godfather" with an address of 4044 N Elmhurst Rd in Milwaukee shoebox on the bottom of the left nightstand. The envelope contained a typed letter from "Ron" to "Dallas", that was dated 1999.

From inside the top left drawer of the nightstand to the left of the bed, I collected a lady bug massager and an address book. Folded inside the address book, were two envelopes.

The first envelope was addressed to Ronn Johnson, was post marked July 28, 2010 and had a return address to "DBS" at the Waupun Correctional Institute. Inside the envelope was a one page letter written to "Ronn" from "B***" dated 07-27-10. In a portion of the letter it stated:

I don't know what your purpose was to come see me here, from deliberately lying to my face, to attempt to place me at ease from what you've done to me, or to mocking me or calling my bluff...The past will catch up with you Ronn, since I'm indigent, polygraph tests are free. Sure you can refuse one, but I can just file a USC 1983 civil complaint against you for punitive mental damages and distress, than (sic) have you subpoenaed to take one. The things I've done in the past have caught up to me with prison time, now your past will catch up with you with the same. And people in prison don't take lightly of thos with child molestation (sic) cases. Threats, No truth. Yes. In every way. Don't bother coming up here. It'll be a waste of time...I only asked you for a father...But you picked the wrong time to do what you did.

The second envelope was addressed to Ronnie Johnson, was post marked July 12, 2010 and had a return address to "DBS" at the Waupun Correctional Institute. Inside the envelope was a 3 page, 2 sided letter written to "Ronn," dated 07-11-10 and signed "Love B***" In a portion of the letter it stated:

Ronn: I have a question for you that might shock you a lot. I want you – no I need you to answer it straight forward. Truthfully. Why were you making me do those things to you, and why were you doing them to me? Sexually? Having me touch you, and making me lay on my stomach while you're on top of me? And everything else that was going on when I was @ that very young age? I'm every way, you molested me Ronn. It may no have been in a violent way, but you did. You sexually molested me. Why? I sometimes sit and wonder if that is one of the reasons why I was acting how I was. Doing what I was doing. Running the streets and all. Not slaming (sic) you @ all, but everything stems from something. I was wondering because I ran across my old Psychologist, Dennis Jackson's address and wrote him. We've been writing each other for about a month & a half now and last week, maybe 9 days ago, he asked me: "Bryan, you ever work out that problem you had with you God Father." Me I'm knowing what he is talking about, but I'm not wanting to face it, so I ask what he mean and he says Remember you told me he was touching you. You both

came in and he denied it.” Push comes to shove and he told me to confront the issue. So I am. Its crazy b/c I ran across my old teacher Mr. Adams from Carson Academy, and as you know, I was one of the kids he touched and molested. I didn’t go to court on him but I gave a statement, the same thing happened w/ him, he touched me, I told my mom and she didn’t at all believe me, even gave me a woopin for lying. But when she saw it for her self. I told her, Deitrich (sic) my principal@ Jackie Robinson and Dennis but it seems no one believed me but Dennis. They all told me I was lying on you...Why Ronn? I was a child. A kid. I believe that one reason why I began running away, smoking, which lead to stealing, which led me to more crimes...Everything stems from something. I don’t know...But please answer these questions. Mail about to go out, let me get this to you. But answer this, why shouldn’t I tell the police about this? With no response, I’ll know how to go about doing things...08-23-10...Love B.***

Family Room

I recovered a silver IPAD, which was on a table next to the television. I recovered an IPAD box with its back signed “Ron Johnson,” which was on raised hearth by the fireplace. I also recovered a Panasonic video camera and numerous VHS tapes that were on an electronic shelf next to the television. I also recovered a Wii gaming system that was on the floor next to the television.

Kitchen

I photographed boxes containing single serve chip bags on the kitchen floor. I also collected several refrigerator photographs of unknown juveniles.

Additional

On the dining room table, I recovered a “Cleaning Authority” receipt letter for services dated 07-23. I recovered “2012 Johnson Ranch” photograph, which was on the dining room shelf., I also recovered an prison letter/envelope dated 07-16-13, sent to Johnson from “DS,” which had been on the dining room table.

On the hallway wall was a frame containing photos and memorabilia for “RB.”
On the sun room window sill, I recovered a silver Motorola razor flip style phone.

The collected items were packaged in clean paper bags and were placed on inventory #13-755.

[AMENDED COMPLAINT / PROBABLE CAUSE FOR COUNTS #15-#23 BEGINS HERE]**As to Counts #15-#21: DBS/Victim #4****Generally as to DBS/Victim #4**

I further base this complaint on additional police reports generated by this same law enforcement agency during the course of its ongoing investigation into these matter. Said police reports contain the statement of DBS, victim #4 in this matter, hereinafter referred to as DBS.

Said police reports indicate that DBS, an adult male subject, with the date of birth of 04/09/1989, is currently incarcerated at Waupun Correctional Institute. Reports further reflect that DBS was identified as a so called "Godson" of the above named defendant, Ronnie or "Ronn" Johnson, and the author of several letters addressed to the defendant which were recovered from the defendant's residence during the execution of a search warrant and are described and quoted above.

Said police reports indicate that investigators with the Village of Brown Deer Police Department met with DBS at Waupun Correctional Institute on 07/31/2013. Reports indicate that upon being told that police were there to speak to him in relation to an investigation related to the above named defendant, DBS immediately said, "that's my Godfather".

DBS then asked what police wanted from him as the defendant "practically saved his life." I asked DBS how he met the defendant. DBS said he met the defendant when he attended the Youth Leadership Academy Saturday Program when he was in 3rd grade. DBS said at the time the defendant was the Executive Director of the Program. DBS said later when the Young Leader's Academy Charter School opened; he then transferred to that school, which was when he was in eighth grade. DBS said the defendant held the position of the School Principal when he transferred in the eighth grade.

DBS said at the time he resided with his adopted mother, Delores. DBS provided contact information for Delores. DBS also provided the address for his previous residence when he lived close to the defendant in Milwaukee as 4028 North 45th Street. DBS again described the defendant as a self-appointed "Godfather" and the closest figure he had to a father in his life.

DBS again asked how he was involved in this investigation. Investigators explained to DBS that his name was found in the residence at the time of the search warrant. Investigators also informed DBS that there were other victims that have been identified and that he was not the only one. DBS then paused, sighed, and then said, "I *don't want to bring this stuff back up in my life, maan.*" DBS was very hesitant and reluctant to continue the conversation.

PO Guenette then informed DBS that police believed he was also a victim of sexual abuse at the hands of defendant. DBS then nodded his head up and down in a yes motion. DBS said "*y'all must have seen the letters that I wrote him.*" PO Guenette then asked DBS to describe the events. DBS said "*I just wanted to know why he did what he did.*" DBS continued and said it started when he was nine or ten years old when the defendant resided on Elmhurst, at the above referenced location in the city and county of Milwaukee. DBS said the assaults started as touching when the defendant would hug him, touch him, and rub him.

DBS said the defendant befriended his mother, Delores and that both Delores and the defendant wanted the defendant to have a positive role in his (DBS's) life. DBS said that the defendant would take him out to eat, skating, and go-karting. When DBS started getting into trouble, Delores and the defendant made an agreement for DBS to reside with the defendant. DBS said he resided with the defendant from 2002 until 2003.

DBS said the first assaults he recalls happened after he would fall asleep in the defendant's bed. He said that he would awake to the defendant "touching him." DBS said he was scared but figured that

the defendant was supporting him and his mother (Delores) and he “*figured his life would go shit*” if he reported the conduct or did not let the defendant touch him. DBS said that the defendant supported him financially and helped Delores out a few times. DBS later told investigators that the defendant would buy him clothes, bikes, and would give him an allowance for chores that he would do throughout the house.

Count #15: Sexual Assault of a Child Under 13 (Hand to Penis) of DBS/Victim #4

DBS estimated that when he was about ten years old the defendant started touching DBS’s penis and testicles over DBS’s clothing as well as underneath his clothes with his hand. DBS said this occurred in the bedroom and living room of the defendant’s residence and whenever they were alone.

Count #16: Sexual Assault of a Child Under 13 (Mouth to Penis) of DBS/Victim #4

DBS recalled one incident that occurred during the day when he was nine or ten years old. DBS said he was laying on the couch watching television in the living room when the defendant returned home. DBS said at this time the blinds were closed, which DBS said was unusual for the defendant during the daytime. DBS said the defendant went to his bedroom and changed into lounge clothes and then came into the living room and gave DBS a hug while DBS was laying on the couch. DBS said it was not uncommon for the defendant to give hugs because the defendant was an affectionate person. DBS said after giving the defendant a hug, the defendant then started kissing DBS’ neck and “touching him.” At the time, DBS said he was young and did not really know what was going on. DBS continued and said the defendant then pulled his basketball shorts and his underwear down and started giving him oral sex. DBS described the oral sex as the defendant placing his mouth on DBS’s penis. DBS said the above incident was not the first time that the defendant had assaulted him.

Count #17: Sexual Assault of a Child Under 13 (Penis to Thighs of Buttocks) of DBS/Victim #4

DBS further indicated that the defendant did this on a number of occasions and the typically after performing oral sex, penis to mouth, on DBS, the defendant would turn DBS over to his stomach and then he lay on top of DBS. DBS said that the defendant would grab some sort of lubricant and put it on the inside of DBS’ legs and then the defendant would “hump” him. DBS clarified that both he and the defendant were nude when this would occur. DBS said the defendant would place his penis between the back of DBS’ upper thighs and then the defendant would move his body back and forth. DBS said he could recall feeling that the defendant’s’ penis was hard as he moved it back and forth between DBS’ legs.

DBS could not recall how the assaults would stop or if the defendant ejaculated or not. DBS was not sure how long the sexual assault lasted. DBS also could not remember whether his penis was erect or not. DBS was not sure whether the defendant put a condom on or not. When asked if the defendant would say anything or not to DBS, DBS said that the defendant would tell him: “*This is between us, you’re my son.*”

When asked how often the defendant would assault him as described above, DBS replied, “*all the time.*” DBS said that the defendant always told him that of all the “Godsons,” DBS stayed with him the longest. DBS also described this hierarchy system that the defendant had. DBS said the defendant had pictures of all of his “Godsons” and he would place the pictures of them on his piano. DBS said if a picture was on the bench that would mean that you were not doing well. DBS said that there would be some pictures on the piano keys and then finally there would be pictures on the top of the piano. DBS said his picture was always on the top of the piano.

Counts #18-#19: Sexual Assault of a Child Under 13 (Penis to Anus) of DBS/Victim #4

DBS continued and described another incident that started like the incident described above but the defendant penetrated DBS’s anus with his penis. DBS said that he believed the defendant’s penis “slipped” from between his legs and into his anus. Once the defendant’s penis was inside of DBS’s anus, the defendant continued to move back and forth and then he would eventually stop. DBS said

after the first time the defendant penetrated DBS's anus, DBS said he bled all over and cried for a week. DBS said there was no conversation between him and the defendant after the intercourse. In fact, DBS said that the defendant helped DBS clean up the blood and then took him out to eat. DBS estimated he was ten years of age.

DBS said that the defendant only penetrated his anus with the defendant's penis on *two occasions*, the one mentioned above and one other time. DBS described the second incident as he was again 10 years old and they were in the bedroom watching a movie. The defendant assaulted him like he described above where the defendant rolled DBS over to his stomach and would lay on top of him. DBS would place the lubricant between his legs. DBS could not recall whether the defendant preformed oral sex on him or not this time.

Count #20: Sexual Assault of a Child Under 13 (Victim's Mouth to Defendant's Penis) of DBS/Victim #4

PO Guenette also asked DBS if the defendant ever made him do anything sexual. DBS said "yes, *oral sex*" meaning DBS was required to perform mouth to penis sexual contact and/or intercourse on the defendant. When asked how often, DBS said "not often." DBS stated that the oral sex (his mouth to defendant's penis) did not happen very often and started when he first met the defendant when he was approximately eight years of age. DBS said while he was performing oral sex on the defendant, the defendant would eventually push DBS's head away from his penis and then the defendant would ejaculate. DBS said prior to the defendant ejaculating, DBS said the defendant would masturbate with his hand and then ejaculate on his stomach. I asked DBS how he knew that the defendant ejaculated and DBS said a fluid came out of the defendant's penis and onto his stomach. DBS said the assaults started when he was eight years of age by DBS performing oral sex and then they escalated to the defendant laying on top of him and placing his penis between his legs and in his anus.

Counts #21: Repeated Sexual Assault of a Child of DBS/Victim #4

DBS said that the defendant continued to have sexual contact with in various ways and multiple times up until he was about age 16. DBS indicates that the defendant perpetrated well in excess of three separate acts of sexual contact / sexual assault on him between the above dates, after he turned thirteen but prior to his 16th birthday. He states that the defendant would engage in sexual contact of the type that forms the factual basis for Counts #15 through #17 above still after he turned thirteen. He indicates that the acts of mouth to penis, penis to thighs or buttocks and hand to penis continued during the above time period at the above locations in the city and county of Milwaukee.

As to Counts #15-#21 Generally

Toward the conclusion of the interview, investigators asked DBS to summarize the assaults and when they occurred. DBS confirmed that the assaults started when he was eight years (approximately 1997) of age by the defendant rubbing and massaging him and then DBS performing oral sex on the defendant. When DBS was nine years of age (approximately 1998), the sexual intercourse progressed by The defendant assaulting him with his penis between his legs. When DBS was ten and eleven years of age (approximately 1999, 2000, 2001) the defendant penetrated DBS' anus with his penis on two occasions. DBS again said the assaults stopped when he was 15 or 16 years of age. DBS said the assaults happened even when he was in custody at Ethan Allen and Wales when he would receive a weekend pass to go home and visit. DBS said he was placed in Ethan Allen in 2002 and then to Wales in October of 2003. DBS said the assaults happened a lot but not at specific intervals. DBS could not estimate the amount of times that he was assaulted by the defendant, but said it was more than three times. In 2005/2006, DBS reported the touching to his mother.

Additional Information

DBS said the assaults occurred in the defendant's Milwaukee home on Elmhurst and at the defendant's condo at Yankee Hill. DBS said that after the defendant's house on Elmhurst caught fire

the defendant moved to a high rise condo at Yankee Hill. DBS was not sure what the address was at Yankee Hill.

DBS said he was only at the defendant's residence in Brown Deer on one occasion in the summer of 2007. DBS said the defendant needed some money from DBS, so DBS drove to the defendant's residence and gave him \$2700.00.

DBS said the defendant stopped assaulting him when he became older and started selling drugs. DBS estimated that he was 15 or 16 years of age when the assaults stopped. DBS said that when he started getting in trouble he believed that the defendant started distancing himself from DBS, so DBS believed that the defendant was another father figure walking out of his life. DBS said he would always do what the defendant wanted him to do. DBS said at one point in his life when DBS was trying to take care of his ten-year old daughter and considered enlisting into the Army, the defendant told him not to so DBS did not. DBS said that the defendant paid for him to get his GED. DBS enrolled but did not attend the classes.

PO Guenette asked DBS if the assaults only occurred when he was living with the defendant. DBS said no they also occurred when he would visit at the defendant's residence. DBS said his relationship with his mother was "rocky" so he would frequently go over to the defendant's house. DBS said that he and the defendant stopped communicating for awhile and then when DBS went to prison the defendant and he started writing again. DBS said he wanted to know why the defendant did what he did so he wrote the letters to ask him.

PO Guenette then informed DBS that he brought the letter dated July 11, 2010. DBS recognized the letter and acknowledged that this letter was the first time that he confronted the defendant about the assaults. (Pertinent portions of said letter are quoted above.)

DBS said after he wrote this letter, the defendant came to visit him while he was in custody. DBS said that he and the defendant did not talk about the letter or about DBS's questions to the defendant. DBS said he was scared to bring it up to the defendant. DBS said he just wanted some type of explanation. DBS said the defendant would say, "*people make mistakes*" but he would never actually acknowledge the assaults.

During the interview, DBS speculated as to whether the defendant's acts of purchasing him items while he was in prison and sending him money was an attempt to "keep him quiet." DBS said that the defendant purchased him his television, radio, fan, typewriter, shoes, clothing, underwear, shirts, socks, and money. DBS said at the time he believed that the defendant was his "Godfather" and was looking out for him but now he believed that he was buying these things to keep him quiet. DBS said that the defendant was his main source of income while he was in prison. DBS said he could not get a job because he was going to school so the defendant was his main source of income. DBS said "*I don't understand this, man.*"

DBS was not aware of anyone else that was assaulted, but he figured he was not the only other victim. DBS said he only told Delores and Deitrich. Investigators then asked DBS if he told his psychiatrist about the assaults as in one of DBS's letters, he mentioned telling a psychiatrist, Dennis Jackson. DBS said he wrote Dennis one time. DBS said he disclosed that the defendant used to touch on him. DBS said he did not go into details about the touching but that he wanted to know why the defendant would touch him.

Review of Prison Records

Investigators also requested and obtained the visiting log for DBS while he was in custody at Waupun Correctional. Said records indicate that since 2010, the defendant visited DBS eight times, with the last visitation on 07/14/2013.

Investigators also obtained DBS's 2013 financial records (his "canteen") with Waupun Correctional. Since 01/10/2013, the defendant deposited money into DBS's account four times for a total dollar amount of \$325.00.

As to Counts #22-#23: JDB/Victim #5

Generally as to JDB/Victim #5

I further base this complaint on additional police reports generated by this same law enforcement agency during the course of its ongoing investigation into these matter. Said police reports contain the statement of JDB, victim #5 in this matter, with a date of birth of 11/10/1978, hereinafter referred to as JDB.

Said police reports indicate that JDB had been identified as a potential victim of sexual assault by the above named defendant, Ronnie Johnson, when letters that he had written while he was incarcerated were recovered from the residence of the defendant. Investigators also received a tip on August 1, 2013 from the National Center for Missing and Exploited Children (NCMEC) hotline made by JDB. In that tip JDB reported that he had been the victim of sexual assault by the defendant.

During the course of an interview with investigators from the Village of Brown Deer Police Department, JDB indicated that he became aware of the defendant's arrest and this investigation when the mother of his child, who works at the Milwaukee County Correctional Facility South, called him and told him about it. She subsequently sent him a news article with this information. JDB said that the first thing he thought of after reading the article was that: "*He finally got caught*". JDB said that he thought that if he would "*have said something back then it probably would have been over a long time ago.*" He said that this made him feel bad that others had to suffer because he did not say something.

JDB said that he had met the defendant when he was attending Lee Elementary School. He said that his mother was a teacher at Lee Elementary and that she introduced him to the defendant who was also a teacher at the school. JDB said that the defendant was not his teacher. He thought that the defendant taught 2nd or 3rd grade while he was in 4th or 5th grade at the time. JDB said that the defendant invited him to read a story to his class at the school.

JDB said that shortly after meeting the defendant he would go over to visit at the defendant's house. JDB said that this mother encouraged him to visit because she thought the defendant would be a positive influence on him. He said that the defendant lived on 37th and Elmhurst, which he stated was right off of Capitol Dr. in Milwaukee. JDB said that he remembered watching movies and eating popcorn while visiting the defendant. JDB said that he asked if his sister could come over to visit too, but that the defendant did not want her to. JDB remembered that there were two "godsons" before him that were visiting the defendant's house.

Count #22: Second Degree Sexual Assault of a Child of JDB/Victim #5

JDB stated that when he was about 13 or 14 years old, between the above dates, he remembers that he was living in the Berryland housing projects at 6029 N. 41st St., and that the defendant told him that he would teach him to ride his moped. JDB said that he would sit on the moped and that the defendant would sit behind him. JDB said that The defendant would put his hands around him and pull him close into his (the defendant's) pelvis. He said that the defendant would "*grind*" on him and *put his hands into his crotch area and fondle him (his genitals) while they were riding the moped.* JDB remembered feeling that the defendant had an erection, which he could feel on his backside, while they were riding in this manner. JDB remembered riding the moped like this all the way from the defendant's house on Elmhurst to JDB's house at Berryland. JDB estimated that this

had occurred approximately 5 or 6 times. JDB recalled that he was so excited to be able to drive the moped that he didn't notice that what the defendant was doing was wrong.

(It is noted that although this types of assault occurred more than one time this charge concerns the first such incident specifically.)

JDB states that this conduct occurred in relatively close proximity to the defendant's Milwaukee home on Elmhurst Road and that the sexual contact happened in the city and county of Milwaukee between the above dates when he was less than 16 years of age.

Count #23: Second Degree Sexual Assault of a Child of JDB/Victim #5

JDB said that when he got older, the defendant began to teach him to drive the car. JDB said that he would sit on the defendant's lap behind the wheel of the car. JDB said that the *defendant would put his hands around JDB into his crotch area and fondle him (hand to penis or genital sexual contact) through his clothing as they drove.* JDB could not remember noticing if the defendant had an erection while they were driving in the car in this manner. JDB later described the car as a black foreign car with a license plate of "Are Jay." He could not remember the make or model. He thought that it looked like an old BMW, but it might have been a Volkswagen Jetta. He said that the defendant liked Jettas.

JDB states that this conduct occurred in relatively close proximity to the defendant's Milwaukee home on Elmhurst Road and that the sexual contact happened in the city and county of Milwaukee between the above dates when he was less than 16 years of age.

Additional Sexually Assaultive or Potential Sexually Assaultive Behavior

JDB also stated that when he first started staying overnight at the defendant's house he would sleep in the defendant's bed. He said that the defendant would lay next to him and snuggle up behind him, "like you would do with your woman." JDB said that he would lay on his side facing away from The defendant and that the defendant would lay down behind him facing JDB's back. He said that the defendant would put his arms around him pull him close, like when he was on the moped.

JDB said the defendant would also touch him while they were on the bed. He said that the defendant touched him on the thigh, and that his hands would "*always be around here*" and he indicated his crotch area to me. JDB said that the defendant would always touch him over his clothing. JDB said that he thought he was wearing pajamas or his underwear and a t-shirt at the time. He said that the defendant was wearing jogging pants or athletic shorts. JDB remembered being kissed on the face or ear once by the defendant while the defendant was laying with him on the bed. *He said that the defendant would be feeling, touching and grinding on him.* He said that, "*He'll get up on you, I guess to get in a comfortable spot, but it keep on going*". JDB remembered thinking "*you never going to get comfortable?*" While describing the defendant's movements to investigators, JDB demonstrated by moving his hips back and forth. JDB said at the time he thought the defendant was trying to get comfortable on the bed behind him, but now he knows that is "*crazy*." JDB said that is why he was here, at the police department, now. He said that he wished he had come here a long time ago. He said now he thinks the defendant was grinding and humping on him when they were in the bed. Investigators asked JDB if he remembered the defendant having an erection while this was occurring on the bed. He could not remember, but he said that he thinks that the defendant must have. JDB thinks that with all the grinding that the defendant was doing he could not help but to have an erection.

JDB recalled one occasion in which the defendant put his hands down the front of JDB's pants. JDB could not remember when this occurred exactly. He said that they were both standing in the defendant's room and that the defendant just came up to him and put his hands down the front of his pants and grabbed his penis. JDB said that this caused him to "jump back" as it surprised him. He said that it seemed as if the defendant thought that it was some kind of game. JDB said that the defendant never did this to him again.

JDB told me that the defendant's activities on the bed made him uncomfortable so on later visits he would either sleep on the floor or, eventually, on a beanbag chair that was in the defendant's bedroom.

JDB described an incident that occurred when he was about 15 years old as he slept on the beanbag chair. JDB told me that he was having a dream that felt extremely sexually pleasing. He said that it was late at night, maybe 2 or 3 in the morning, and he woke up in the dark and found the defendant on top of him. JDB described seeing the defendant "raise up and backed off of me". He said that the defendant got back onto his bed in the room. JDB said that he turned over into a fetal position and that was when he felt that his crotch was soaking wet. JDB said that at that age he was not sure if he could ejaculate, but that he was "*soaking wet*." JDB told me that after that day he went home, put on a pornographic movie and masturbated for the first time. JDB said that the feeling he got while doing this was the same as what he was feeling during the dream. I asked JDB what was happening in the dream that he was having. He could not remember exactly what was happening, but he said, "whatever it was it was feeling good." He said that it, "made me release" and this is what made him go home and watch the movie. He said that he wanted to "feel this feeling." When asked again what was happening in the "dream." JDB said that it was "*like wet*," like he was "*getting head, like someone sucking you*." When asked what he meant by the defendant being "on top" of him when he woke up. He said that when he woke up the defendant was "*coming off of him*" and going back on the bed. He said that the defendant was "*hovering over him*" and described it as the defendant leaning over him while indicating his crotch area.

JDB also said that he had received "a massage" from the defendant. He said that this activity was occurring around the same time period in which he was sleeping in the bedroom with The defendant. JDB described getting a back massage, "*like how I do my woman now*." He said he would lay on the floor on his stomach and that the defendant would lay over his back with his knees on either side of him. JDB said that he could feel the defendant's "*thing*" on his butt. He said that The defendant would then rub his back. JDB said that the defendant would either on his bare back if he was shirtless, or he would put his hands under JDB's shirt. JDB said that the defendant had used electric massagers on him. He said that it was like the defendant was experimenting and he would ask JDB how it would feel. JDB did not remember the defendant ever putting the massager into his crotch or buttocks, but he did remember him using it on his inner thigh and asking JDB how it felt.

Additional Information

JDB also indicated that he was told to call the defendant "Godfather" and that the defendant referred to him as his godson. He said that when he first met him, the defendant told him, "I am the Godfather." JDB indicated that the assaults occurred at the defendant's house on Elmhurst in Milwaukee and that this location was never referred to as "The Ranch" to his knowledge.

JDB said that he would end up at the defendant's house because the defendant would call and pick him up and take him to his house. JDB said that he remembered doing a lot of work such as household chores like dishes, house cleaning, cutting grass, taking out the garbage. JDB said that sometimes other kids from the neighborhood would come over and they would play basketball or games. He said that the defendant had "whatever a child would want." JDB said that if the defendant did not have something and you asked for it, he would either get it or take you to get it. JDB said that he would make you work for it though.

This Complaint does not exhaust all known information. Investigation into these matters remains ongoing. This Complaint is subject to amendment prior to commencement of the preliminary hearing to add additional victims and related criminal charges.
