WVIK seeks out high quality local and nationally produced programming, with sensitivity to community issues and the needs of a diverse audience. We offer locally produced news programming - and we are the only radio news room in our market - offering both long and short format reporting, using a variety of sources, with input from our Community Advisory Board, to ascertain community interests. Our locally produced arts and entertainment programming is similarly guided. And our classical music programming is determined by the Music Director, by keeping abreast of local and national interests. We've partnered with seven regional orchestras and performing arts organizations to offer a rebroadcast of a local performance for nearly 52 weeks a year. This includes a partnership with the local orchestra to bring in nationally recognized small ensemble musicians, who perform in a local venue for deeply discounted ticket prices, and then rebroadcasting the performance on WVIK. We offer our broadcast over-the-air and on the web.

In FY2015 WVIK continued a partnership with the Quad City Symphony Orchestra, bringing a concert series to the community, offer both a live performance and rebroadcast of the concert. We included these concerts in a broadcast series we offer weekly of 7 regional performing arts organizations we call "Sunday Symphonies." In addition we partner with several local arts and non-profit organizations, including the Figge Museum, River Action, River Music Experience, The Heritage Center - University of Dubuque, a local magazine Radish and WQPT n order to provide their content as programming on WVIK. We also regularly interview and promote many of the arts and cultural venues in our community. We enjoy creating trade relationships with many of these organizations in exchange for tickets to events that we offer our donors and underwriters. We also continue to regularly share programming and news reporting with regional public broadcasting entities including Iowa Public Radio, Illinois Public Media, WCBU, WNIJ, WQPT and Tri-States Public Radio.

We measure the success of our partnerships or initiative through audience ratings, steady or growing attendance to performances, financial support from our community and anecdotally good will from our supporters. WVIK see's itself at the center of arts and culture in this community connecting our audience to the local culture that is available in our community. We do that by promoting, reporting, interviewing and broadcasting samples of the offerings regularly. Our audience for both news and music has seen regular growth in the last 4 years, our revenue has increased steadily 21% while our audience grew 35%. Anecdotally, we find that acquiring local support is easier as we gain more partnerships, increase visibility, offer listener testimonials, and increase the number of underwriting clients.

The CPB community service grant continues to provide the funding to offer nationally produced as well as the most listened to public radio programs offered from NPR, American Public Media and other national distributors. This important funding allows us to offer this high quality programming to our community, but also include the local impact of national news and culture in our programming. We also access our music broad rights through our relationship with the CPB. If we no longer had this important source of funding, we'd struggle to cover nearly 13% of our annual budget, and would most likely not be able to continue to offer some of the most popular programs. We find our CPB funding also helps up to leverage local sources of revenue as well.
