WVIK seeks out high quality local and nationally produced programming, with sensitivity to community issues and the needs of a diverse audience. As the only radio news room in our market, we offer locally produced news programming, both long and short format reporting, using a variety of sources, with input from our Community Advisory Board, to ascertain community interests. Our locally produced arts and entertainment programming is similarly guided. And our classical music programming is determined by the Music Director, by keeping abreast of local and national interests. We've partnered with seven regional orchestras and performing arts organizations to offer a rebroadcast of a local performance for nearly 52 weeks a year. This includes a partnership with the local orchestra to bring in nationally recognized small ensemble musicians, who perform in a local venue for deeply discounted ticket prices, and then rebroadcasting the performance on WVIK. We offer our broadcast over-the-air and on the web.

In FY2016 WVIK continued a partnership with the Quad City Symphony Orchestra, bringing a concert series to the community, offer both a live performance and rebroadcast of the concert. We included these concerts in a broadcast series we offer weekly of 7 regional performing arts organizations we call "Sunday Symphonies." In addition we partner with several local arts and non-profit organizations, including the Figge Museum, River Action, River Music Experience, The Heritage Center - University of Dubuque, a local magazine Radish and WQPT, Quad Cities Public TV, in order to provide their content as programming on WVIK. We also regularly interview and promote many of the arts and cultural venues in our community. We enjoy creating trade relationships with many of these organizations in exchange for tickets to events that we offer our donors and underwriters. We also continue to regularly share programming and news reporting with regional public broadcasting entities including Iowa Public Radio, Illinois Public Media, WCBU, WNJI, WQPT and Tri-States Public Radio. New in FY2016 we collaborated with a local donor who's philanthropic interests include the environment and worked with Nahant March, Scott County Conservation District, the Figge Art Museum, and many others to develop TallGrassQC.Org, a repository of local environmental education and news. We also initiated a statewide collaboration with Illinois Public Radio stations selling underwriting packages for multiple stations to a single donor.

We measure the success of our partnerships or initiative through audience ratings, steady or growing attendance to performances, financial support from our community and anecdotal comments of good will from our supporters. WVIK see's itself at the center of arts and culture in this community connecting our audience to the local culture that is available in our community. We do that by promoting, reporting, interviewing and broadcasting samples of the offerings regularly. Our audience for both news and music has seen regular growth in the last 5 years, our revenue has increased steadily 23% while our audience grew 26% from Fall 2015.

We continue to partner with the Great Quad Cities Hispanic Chamber of Commerce, proving the important program "Latino USA.", who's host, Maria Hinojosa, will be visiting the Quad Cities and the Augustana College campus through our support in facilitating her visit. In addition our news department regularly covers issues of import to all our minority communities, as well as offer the reading information service for the visually impaired on our sub carrier. We believe our programming is appropriate and of interest of all communities.
