

The total tax levy proposed above includes the Uniform Rate of Tax required under Amendment 74, 25.4 mills for maintenance and operation of schools, 0 mills for dedicated maintenance and operation millage (Capital Outlay/Current Expenditures) dedicated for purposes authorized by law and 7.7 mills for debt service previously voted as a continuing debt service tax pledged for the retirement of existing bonded indebtedness. The district may use surplus revenues produced each year by debt service millage for other purposes.
