

### **Supplemental Narrative**



I, Sgt. Jeff Haines was contacted by Sheriff Meeks regarding the case and stated that he received an email from Patricia Gager informing him that Cody Songer was currently living in Tishomingo Oklahoma and wanted to know why he hadn't been interviewed.







The interview was audio and video recorded and the original disc was placed into evidence at the Hunt County Sheriff's Office.



I asked Mr. Songer if he knew why I wanted to talk to him and he replied "I know exactly why you're here. You're here about Carey Parker".



Mr. Songer stated that he thought it had been about two months later that he told Carey Parker that the relationship wasn't "going to work out" and they separated. Mr. Songer stated Carey Parker began "stalking" him and followed him to a party.

Cody Songer stated that he was hanging out after the break up with a guy named Todd Langford. Mr.

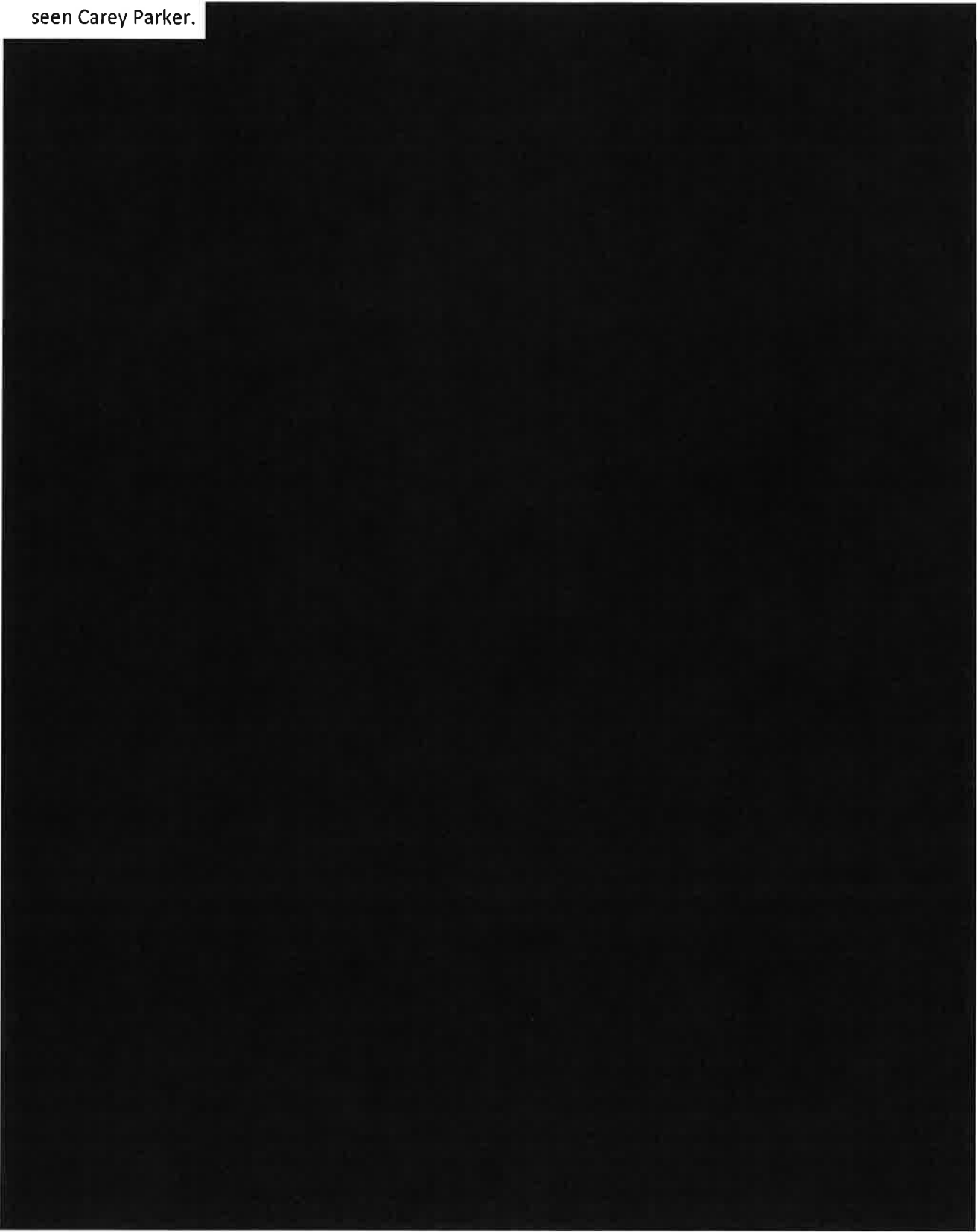
[REDACTED]. Mr. Songer stated that he was at a party in what is now known as Hawk Cove at a trailer home by the old grocery store and it was him Jim Wilburn, "some guy" with the last name of Jones and he thought the first names were either "Jim" or "John" but he could not recall. Mr. Songer stated there was a female at the party that everyone knew as "Cactus" who he described as an "Indian". Mr. Songer stated that "Cactus" [REDACTED]

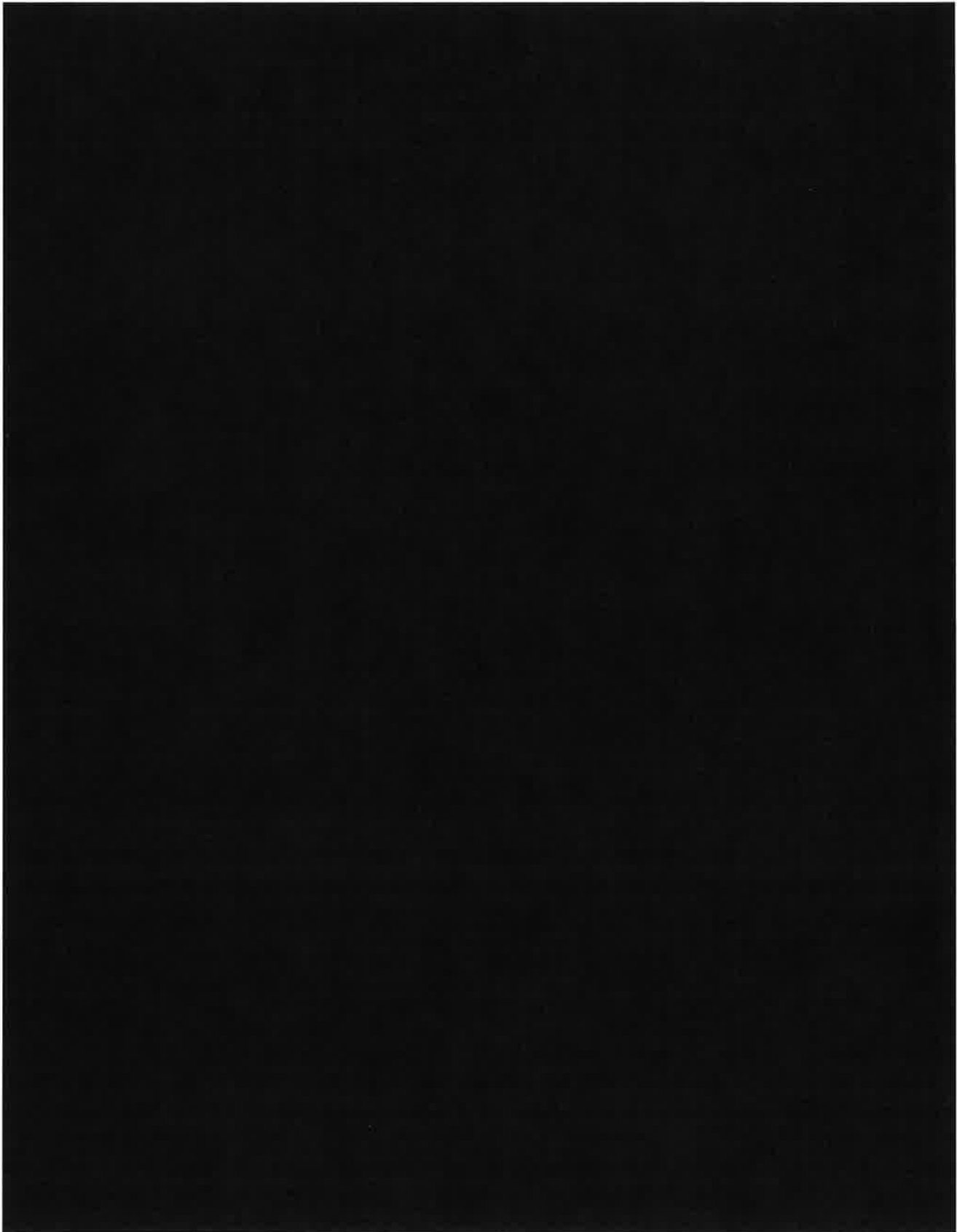

Mr. Songer stated that while they were all partying Carey Parker showed up and Todd Langford told him that she didn't need to be there and he told Todd that it wasn't a problem that "he had no beef with her (Carey Parker). Mr. Songer stated that everyone continued to drink and dance and that he danced with both "Cactus" and Carey Parker.

Mr. Songer stated that Carey Parker had "a couple of drinks" and came over to him and made a statement to the affect that he (Mr. Songer) wanted to sleep with "Cactus". Mr. Songer stated that he told Carey Parker that not only did he want to sleep with "Cactus" but he was going to that night. Mr. Songer stated that Carey Parker threw a drink in his face. Mr. Songer stated that Todd Langford got mad about it and Jim Wilburn stepped in and escorted Carey Parker outside and was outside with her for about 30 minutes before he came back inside. Mr. Songer stated that Jim Wilburn told everyone that he was going "down the road" with Carey Parker and he would be back later. Mr. Songer stated that Jim Wilburn returned to the party and Carey Parker got into her car and left. I asked what kind of car Carey Parker drove and he stated a brown Chevy Camaro. Mr. Songer stated that was the last time that he

seen Carey Parker.







Mr.

Songer stated "that was the last he had seen of her".



Mr. Songer

repeated that the last time that he seen Carey Parker was when she left from the party.




[REDACTED] Mr. Songer stated that I could ask "Cactus", Todd or "Jones" of which two of those names was either a street name and/or last name only with no additional identifiers.


[REDACTED] Mr. Songer further stated that had nothing to do with her being missing and that he "washed his hands of her" when he moved out and the last time he seen Carey Parker was when she left the party.

[REDACTED] . Mr. Songer repeated the same statement about the last time he seen Carey Parker was at the party.




. I asked if Jim acted strange when he returned to the party. Mr. Songer stated that he appeared fine and they just had a normal conversation and when they got back Carey had left the party and they all went on with their night and he hung out with "Cactus". I asked again if he knew the real name for "Cactus" and he stated that the only thing he knew was that he had heard she got married and moved "up north" somewhere.



. I asked Mr. Songer if he struck Carey Parker when she threw the drink in his face and he immediately replied "Nope".









Mr. Songer stated that they were only drinking and there were no drugs at that party. Mr. Songer corrected himself and stated there were no drugs there "as far as he knew" and then added that Carey Parker didn't stay there long enough to do any drugs.


I then confronted Mr. Songer that based on his statements he could remember the name of the girl he called "Cactus" and he couldn't recall the first name of the guy he knew as "Jones" but he was certain that there were no drugs at the party.

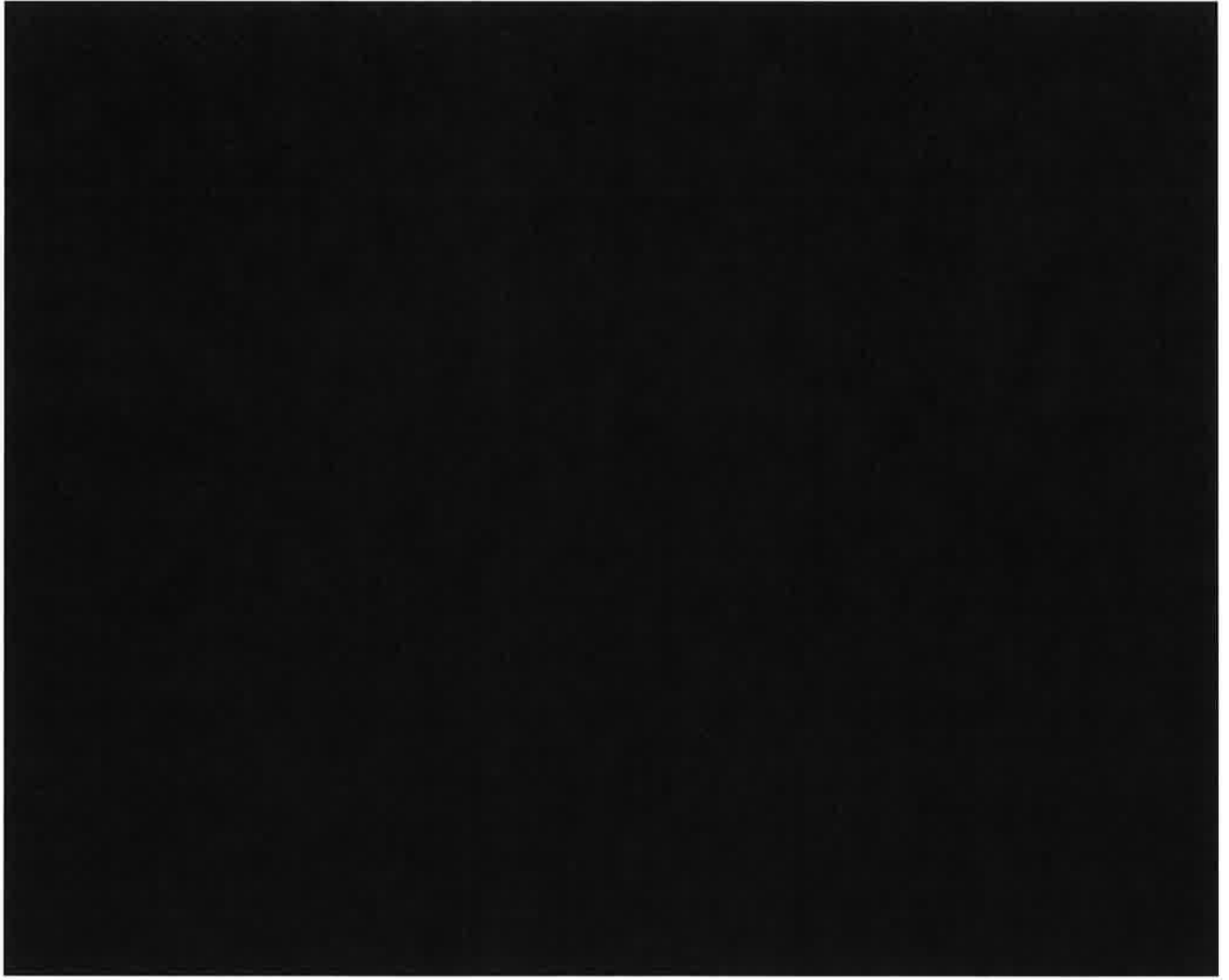


. Mr. Songer replied "No that I know of! She walked out that door perfectly happy but pissed off me and threw a drink in my face. That was the last I seen Carey Parker. Todd was standing there". I then stated that according to him he talked to her after the party but Mr. Songer corrected me stating that Carey Parker had called the business asking for him and when he was never there she showed up at the party and they talked.



Mr. Songer stated that he had no idea what happened to her (Carey Parker) or who would have been involved and the last time he seen her was when she was driving away from the party. Mr. Songer stated that she (Carey Parker) was at the party and had a "couple of mixed drinks" and that she didn't finish the second one because she threw it in his face.
