- Insufficient evidence to file the case
- Complainant signed non-prosecution affidavit / refused to cooperate
- Unable to obtain requested additional paperwork
- Case was not filed before Statute of Limitations ran
- Unable to show sufficient elements of offense under penal code
- Complainant has refused to sign a complaint and/or statement
- Co-Defendant convicted, Insufficient evidence this Defendant
- Defendant has completed pretrial Diversion
- Case should be filed as a Class C Misdemeanor
- Case being forwarded to the District Attorney's office for prosecution as a felony.
