The focus of these advertisements, blogs, public service announcements and other messages was on the role of broadband in innovation, private investment, and competition. Millions of Americans were reached by this information campaign.

Broadband for America conducted educational outreach by one-on-one and group discussions and presentations to policy makers, educators, opinion and thought leaders, and members of the general press. Over one thousand were reached during these efforts. Broadband for America representatives attended events and acted as partial or full sponsors throughout the country focusing on demonstrations of broadband education and broadband use in the community. These conferences and related events attracted hundreds of attendees in multiple locations over the year.
