Minutes of the Red River Radio Network Advisory Board Meeting Held on Thursday, September 21, 2017:

The Advisory Board Meeting was called to order at precisely 12:07 PM at the Network's station in Shreveport, Louisiana.

- Board President, Ms. Mary Charlotte Decker called the meeting to order and asked for a reading of the prior Advisory Board meeting minutes (July 19th Meeting), these prior Board Minutes were unanimously approved by the Advisory Board with a motion made by Mr. Leonard Wilson and a 2nd made by Ms. Sally J. Langston.
- 2. Station General Manager, Mr. Kermit Poling made his current state of the radio station remarks:
- Mr. Poling announced StoryCorps would be coming to Shreveport with a kickoff celebration scheduled for Friday, October 13th at 11:30 am through November 10th, 2017. They will be parking their converted Airstream trailer at the Shreve Memorial Library Broadmoor Branch located at: 1212 Captain Shreve Drive in Shreveport. Additionally, Red River Radio would be hosting a meet & greet and listening event for StoryCorps at Artspace (708 Travis Street, downtown Shreveport) on Thursday, November 2nd between 6:00 and 9:00 pm.
- Mr. Poling stated we had a decrease in new listener members, as well as, a decrease in membership pledges of \$90,000.00 which is approximately 10% of our entire budget for last fiscal year. A partial explanation for this decrease in membership pledges can be directly attributed to 900 non-renewing listener members from the prior fiscal year. The Christmas Fundraiser (North Louisiana Food Bank school backpack program) assisted the station in offsetting up to \$50,000.00 of the \$90,000.00 decrease in membership pledges.
- Mr. Poling introduced Mr. Davis Land our newest East Texas news reporter focused primarily on the Lufkin and Nacogdoches, TX region.

- Finally, Mr. Poling announced the Henderson/Overton, TX radio station, KPXI, located at frequency 100.7 is available for sale at \$475,000.
 - 3. Station Membership Coordinator, Henry Edwards, announced the Fall Fundraising Drive.
 - 4. Station Development Director, Ranae Moran, spoke about the scheduled meet & greet and listening event hosted by Red River Radio and scheduled for Thursday, November 2nd at Artspace located in Downtown Shreveport on Texas Street.
 - 5. The Board of Directors unanimously approved the appointment of Mr. Joe Kane as the Board Secretary for the 2017 2018 fiscal year with a motion made by Mr. Leonard C. Wilson and a 2^{nd} made by Mr. Curtis W. Fenley, III.
 - 6. The resignation of Mr. Jim Conerly was thoughtfully discussed and accepted by the Community Advisory Board of Red River Radio.
 - 7. The Community Advisory Board meeting was officially adjourned at 1:17 PM with a motion made by Mr. Curtis W. Fenley, III and a 2nd made by Rev. Pike Thomas.
