I have seen young people, successful and prosperous, offer thanks to the Congresswoman because she lowered her shoulder and helped break down an obstacle or open a door that was holding them back. Your Honor, I have seen all of these things with my own eyes.

Corrine Brown is a dedicated public servant, a person who always went the extra mile to help people. And she did not care what political party they were, or where they came from. I watched a series of Republican mayors in Jacksonville cross party lines to endorse Corrine, because, as they said, "she delivers." I watched African-American families in Florida's panhandle walk into her office to thank her for her efforts on their behalf, even though they lived literally hundreds of miles outside of her congressional district. I watched her organize a massive relief effort for Haiti, involving trucks, trains and boats, for people who could in no way help her (or had any means to help her), because, as she told me, "If I don't help these people, how are they going to eat?"

I even got the opportunity to meet President Clinton before he left office in 2001. I asked him about Corrine, and he said, "When we see her coming into the White House, we just tell her yes. Whatever she needs for her constituents, we just say yes. Because we know, if we

say no, she'll just wear us down and beat us up, and we'll end up giving in and saying yes anyway, so we oughta just say yes on the front end and save everyone a lot of time."

Whether it's an unemployed person from Sanford, a wealthy person from north Jacksonville, or anyone in between, Corrine Brown has consistently been there, working for them, fighting for them, always trying to solve problems, remove obstacles and make their lives a little bit better.

I know you are in the process of deciding what sentence to hand Ms. Brown. I hope, as you do so, you will reflect on all the good that she has done over the course of her tenure in office, think about all of the many, many people whom she has helped – many who could not even vote for her, much less give money to her campaign or benefit her in any way whatsoever. She helped them not because it was her job, but because it was her mission; she helped them because, as she saw it, that's why God put her on this earth.



I am writing this letter to share my personal observations of the character and substance of Corrine Brown that comes before you for sentencing.

I have known Corrine Brown for almost 16 years on both a professional and semi-personal level. She has been a dental patient of record since May 23, 2002 and I can strongly vouch for her exceptional commitment to help those in her congressional district as well as those individuals who need help who are fortunate enough to meet or interact with her. Her dedication to her job as a Congresswoman was clear to me by the fact that she always seemed to take time out to listen and try to assist anyone who she felt would benefit from her help. I have seen her upon entering the building where she worked as a Congresswoman, take the hand of a homeless woman who was denied access to a public bathroom and escort her in to use the ladies bath as her guest. It was back in 1992, my first year as a legislative specialist for a statewide education association that I met then, Florida Representative Brown here in Tallahassee. As an advocate for public school educators, I was fortunate to have an unwavering supporter in Representative Brown, of the issues favorable to both, teachers and students across the State.



I am very sad and very dishearten to have to write this letter in support of Congresswoman Corrine Brown. A woman of good Character and of good courage. I personally feel some responsibility for her misjudgement of character. Because she helped me to obtain a Right to Sue Letter from EEOC-Miami Office in April 2010. A year after EEOC-Miami stated they mailed the letter that I never received.

I have often witness Congresswoman Corrine Brown in action when she would come to Orlando to attend our School Board Meetings on behalf of the Community at the request of the Community to assure us in having equitable and quality education for all students. My most memorable Orange County School Board meeting was in 2010 when OCPS wanted to elect a Chair in addition to Superintendent. Congresswoman Brown disagree with the Board and agree with the Community that the chair would add expense that could be allocated for a new teacher and it would also allow a double vote for the Chair person. The Board won the decision but the Community was still very thankful that Congresswoman Brown came to support the Community for better education.

Therefore, when I hear and read that Congresswoman Corrine Brown, put personal gains over less fortunate children that would obtain educational scholarships I am in disbelief. I feel Congresswoman Brown is being Blackball for helping Blacks and others less fortunate when her colleagues and other would not take the risk to help minorities. I have canvass for many politicians and in my community there is no other truly compassionate for all children to receive an equitable and quality education then Congresswoman Corrine Brown. I ask the Court to consider my Letter of Support for Congresswoman Brown.

I mention in paragraph one that I had to contact Congresswoman Brown's office for assistance in obtaining a Right to Sue Letter from EEOC-Miami Office (2009) when they had denied me because I didn't have an attorney to represent me. Around September 3, 2009, I first went to visit then District 39 House of Representative Geraldine Thompson and she called FCHR (Florida Commission of Human Relations) and they said Hopkins EEOC Complaint was dually filed but only EEOC-Miami Office investigated the charge. However, Florida Statute 760.11(8) states FCHR was to also complete an investigation within 180 days. In 2008-2009 Hopkins was not aware of this statute until around September 2011, and FCHR never

responded to Hopkins Letter of request regarding their State Statute. Hopkins was then wrongfully terminated during EEOC pending (510-2009-01529 dismissed 5/2011) **510-2011-003877 (3/2012)**.

Representative Thompson (2006-2011) sat on the Board of EEOC and 2006-2012 she sat on the Board FCHR (Florida Commission of Human Relation). After the call to FCHR, Representative Geraldine Thompson, said she could not help me since FCHR did not do the investigation and that she was a State Representative and Congresswoman Brown handles Federal complaints. Rep. Thompson stated Congresswoman Brown was the Federal Representative for our community. Rep. Thompson did schedule an appointment with Congresswoman Brown's office. I completed an application same day and think I got a phone call from Brown's office 3-5 days and a letter from Congresswoman, I believe in 10 day.

Congresswoman Brown, did obtain me a Right to Sue (2010), a year later because Hopkins (I), former employer JP Morgan Chase misrepresentation and spoliation of evidence 1st and third party (EEOC-Miami). After 2010, I did not contact Congresswoman Brown's Office again until 2016. For fear of her and her office be retaliated against for helping me as I had became oppressed and destitute. I did not want anyone else to suffer as I did. But it turns out Congresswoman got Blackball 2009-2016 the same time my cases were in court. "Go Figure".

I retired in 2008 and I have continued my interests in the quality of life for the residents of Jacksonville by serving on numerous boards, including eight years and counting on the Jacksonville Public Library Board of Trustees.

I have known Congresswoman Brown since high school, but I got to know her more personally when she and I were colleagues at Florida Junior College, now FSCJ. Then and now, her passion for people and interest in the uplifting and well-being of people who are around her are qualities that are unmistakable when meeting her. She always strives to make something better. Her interest is in people and she has a way of listening to concerns and quickly getting to work to make the person, the situation or the conditions better.

I chose to retain her official title because she will forever be "my congresswoman." During the time that I spent being represented by Congresswoman Brown, she taught me and I dare say, all of her constituents, the true meaning of servanthood and responsiveness. As a friend, she will rise early and stay late just to make sure that she has exhausted every legitimate way to bring about change and a solution to whatever the concern. She has amassed a broad and far -reaching network of people who are able to assist her in helping others. She is a great mentor for those who want to succeed and even if a person is doubtful of his/her own abilities, she is a strong force of encouragement to ignite a willingness to try.

Judge Corrigan, I sincerely ask that you look at the good that Congresswoman Brown has done for more than a quarter of a century. Further I implore you to look favorably upon all of the information that will be shared with you that goes far beyond the headlines and the previous decisions in her case. She is most deserving of all of this consideration and more as you proceed with subsequent hearings in the case regarding USA v. Corrine Brown.

Dear Judge Corrigan:

I have served with Corrine Brown in the U.S. Congress since I began my tenure in 1998. Through that capacity, I cherished her service to the most vulnerable individuals in her Florida community, especially when her district became the center of national controversies and challenges.

In 2012, following the shooting death of Trayvon Martin in her district, Brown led her colleagues and urged the Department of Justice to investigate Trayvon's death for civil rights violations. The DOJ completed its investigation in 2015, largely because the agency was pressured to do so by advocates like Brown. Brown also hosted the Martin family in Washington, DC, and helped them petition our government for federal recourse. Brown's actions went a long way to help rebuild trust in our justice system and facilitate healing for the Martin family.

In June 2016, Brown's congressional district vaulted into national headlines once again when a mass shooter killed 49 party goers at a local nightclub. The youngest victim was an 18 year-old graduating High School senior. Following that heinous tragedy, Brown led calls in the U.S. Congress to vote on legislation that would have kept guns out of the hands of suspected terrorists.

During the subprime mortgage crisis, which ravaged my congressional district, Brown was on the front lines with me drawing attention to the disproportionate impact the crisis had on homeowners in majority black communities.

Corrine Brown had a deep connection to her constituents and was often outspoken on behalf of individuals who were not able to speak up for themselves. She was especially outspoken during those times of challenge and controversy, which should be the ultimate measure of her character.

As a former prosecutor, I respect the role of our courts in upholding the law and ensuring justice. In that vein, I request that you fully consider Brown's service to her community and our nation during her sentencing proceeding.
