## ENTERED INTO BY AND BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF SOUTH AFRICA, HEREINAFTER REFERRED TO AS THE "GOVERNMENT", DULY REPRESENTED BY THE AMBASSADOR DESIGNATE OF SOUTH AFRICA, JOHANNES HERMANUS ALBERTUS BEUKES, HE BEING DULY AUTHORISED THERETO,

WHEREAS the Government is desirous of engaging the services of a consulting firm in the United States of America on behalf of the Republic of South Africa to provide the Government with general consulting services, including guidance, counselling and representation; and

WHEREAS the Contractor is especially interested in fostering . an improved standard of living for black South Africans: and

WHEREAS the Contractor has agreed to assist the Government in aforementioned capacities;

NOW THEREFORE the parties agree as follow:

- 1. The Contractor is hereby retained and appointed to assist the Embassy of the Republic of South Africa in Washington DC, in carrying out its political, economic and cultural programme in the United States of America subject to the terms and conditions of this Agreement.
- 2. The principle focus of the Contractor's counselling and representation shall be to foster better political, economic and cultural relationships between the Government of South Africa and the United States of America, with the ultimate objective of improving the standard of living for South Africa's Black population, and more particularly:
  - 2.1 to assist in the establishment of exchange programs for black American and black South African educators;
  - 2.2 to assist black South Africans with efforts to enroll in American colleges and universities;

2.3 to organize fact-finding tours of South Africa for interested black Americans;

2.4 to inform black American business organizations of opportunities in South Africa that can be profitable and also effective in improving the economies of black South Africans and their communities;

- 2.5 to work with black American business organizations in the United States and South Africa to facilitate joint ventures;
- 2.6 to monitor legislative activities on Capitol Hill and political activities elsewhere, and alert the government of South Africa of matters which may be important to them;
- 2.7 to contact members of Congress to inform them of the government of South Africa's positions on issues that concern them;
- 2.8 to be available to answer questions that members of Congress have regarding events in South Africa and the government's positions on important issues;
- 2.9 to facilitate meetings between the Ambassador and key members of Congress to discuss progress in South Africa and to answer questions from members of Congress;

- 2.10 to organize meetings between visiting South African dignitaries, especially blacks, and members of Congress;
- 2.11 to encourage and organize fact-finding trips for members of Congress and/or staff to South Africa;
- 2.12 to encourage and organize fact-finding trips to South Africa for key journalists, especially black Americans;
- 2.13 to organize meetings for visiting dignitaries with editors of key black news media; and
- 2.14 to encourage and facilitate speeches by prominent black Americans and prominent black South Africans to important interest groups in the United States.
- 3. The Contractor shall be remunerated for his aforementioned service at the rate of 90 000,00 (ninety thousand dollars) per quarter year, payable in advance to the contractor on the first day of every quarter with effect from August 28, 1985. Following payments will only be made after submission of a report to the Ambassador for the work done during the foregoing term.

3.1 It is expressly agreed that the sum designated above include all costs normally incurred in the conduct of the activities set forth, including fees and salaries of any additional personnel whose services the Contractor may engage in the furtherance of activities.

- 3.2 The Contractor will further be reimbursed for such expenses not within the scope of this contract as may be authorised in advance by the Government and on submission of appropriate receipts. Such disbursements shall not exceed the sum of \$30 000,00 (Thirty thousand dollars) per year.
- 3.3 This agreement shall be effective as from August 28, 1985 until August 27, 1986. With effect from February 27, 1986 either party may terminate the agreement upon two months written notice to the other.
- 4. The Contractor shall indemnify and hold the Government harmless from and against -
  - (a) any and all claims arising from contracts concluded between the Contractor and third parties in order to give affect to the objectives of this Agreement; and  $\frown \bigcirc$

any and all claims, liabilities or damages arising from the preparation or presentation of any programmes covered by this Agreement including costs of litigation and counsel's fees.

- 5. The validity, interpretation and performance of this Agreement shall be governed by the laws of the Republic of South Africa.
- 6. Any controversy or claim arising out of or relating to the Agreement or breach thereof shall be settled by arbitration in the City of Pretoria, Republic of South Africa, in accordance with the laws of the Republic of South Africa
- 7. This document contains the entire Agreement between the parties and it is recorded that no representations were made by either party other than those that are expressly set forth. No agent, employee or other representative of either party is empowered to alter any of the terms and conditions hereof. No variation of any of the terms and conditions of this Agreement shall be valid and binding unless reduced to writing and signed by the parties or their representatives duly authorised to sign such variation on their behalf.
- 8. Should the Contractor fail to comply with any of the conditions of this Agreement, the Government shall be entitled to cancel this Agreement forthwith.
